Arguments heard and record perused. 3. 4. From perusal of the record it was found that no charge sheet or show cause notice has been issued to the appellant much less any departmental inquiry against him. According to the respondent-department since the appellant was in probation, therefore, he could be terminated without any notice. This Tribunal does not subscribe to the said view of the respondent-department as opportunity

in the state

of defense and personal hearing in such like cases when a civil servant is also stigmatized beside loss of service, is an inalienable right being requirement of the natural justice. Since no opportunity of hearing and defense has been provided to the appellant, therefore, we are constrained to set aside the impugned orders. Consequently, the impugned orders are set aside and the case remanded to the respondent-department to proc eed *de-novo* against the appellant. He be given full opportunity of defense and hearing. Needless to mention that for the purpose of *de-novo* proceedings the appellant is reinstated into service. The issue of back benefits be also decide by the department in the light of the *de-novo* proceedings. Parties are left to bear their own cost. File be consign to the record room.





ON FACTS

- 1- Pertains to record, hence no comments.
- 2- In-correct. The appellant was in probation period and he committed serious offence of willful absence. According to the terms and conditions of his offer of appointment is very clear and the competent authority passed order strictly in accordance with the rules. A civil servant can be terminated from service, if his conduct is un-satisfactory during the period of his probation **(Annex-A)**.
- 3- His departmental appeal was considered and rejected by the competent authority vide Inspector General of Prisons letter No.30980 dated, 16/12/2014 copy enclosed as (Annex-B), after affording the opportunity of personal hearing.

- No comments.

GROUNDS: -

- A. The termination orders of the competent authority is strictly in accordance with rules and tenable in the eyes of law and terms & condition of his offer of appointment.
- B. Same remarks as given against Para-A above.
- C. Same remarks as given against Para-2 above.
- D. In-correct, during the course of consideration of his departmental appeal, the opportunity of personal hearing to the accused official / petitioner was provided as evident from **(Annex-C)**.
- E. The Prisons services is very sensitive and the willful absence of Watch & Ward Staff including the petitioner may advantage to the militants to attack on the Jail like, Bannu & D.I.Khan Jails incidents which cannot tolerable at any cost in the interest of state. The appellant committed grave misconduct on his part by willfully absented himself from duty as well as Jail premises in view of security threat to the Jail and showing laxity in responsibility. He deserted and left the security of the Jail on the mercy of Almighty Allah.
- F. The relevant rules as well as terms & condition of his offer of appointment is very clear and the competent authority passed order strictly in accordance with the rules.
- G. In-correct, no malafide intention is involved and the action taken against the appellant is just to maintain discipline amongst the force.
- H. The desertion of the petitioner from the official duty as well as Jail premises, the security of the Jail become at stake and may afford full advantage to any terrorist attack on the Jail. As the appellant


