Respectfully Sheweth:

Briefly the facts of the case are as under:

1. That the appellant has been appointed in Revenue Department and now is serving as Tehsildar. On 26.07.2013 vide Notification No.1355 dated 26.07.2013 the appellant was transferred from District Karak to Inspector of Stamp Kohat. (Copy of Notification dated 26.07.2013 is Annexure "A").
2. That after assuming charge being Inspector of Stamp Kohat, the appellant was again transferred from Inspector of Stamp Kohat to Tehsildar Kohat vide Notification dated 21.11.2013 on political figures. (Copy of Notification dated 21.11.2013 is Annexure "B").
3. That the appellant performing his duties being a Tehsildar Kohat diligently, but again due to political influence and malafidely transferred the appellant from Tehsildar Kohat to Inspector Stamp Kohat vide Notification dated 24.07.2014. (Copy of Notification dated 24.07.2014 is Annexure "C").
4. That in the last continuous one year, the appellant has been transferred from one District to another District and one post to another post i.e. three times and thus is aggrieved of the

impugned transfer order, hence prefers this service appeal, for the following amongst other grounds:

GROUND S:

- A. That the Notification dated 24.07.2014 of respondent No.2 on the basis of political influence and malafidely transferring the appellant from one post to another post, is illegal, unlawful and unconstitutional and against the transfer / posting policy, hence untenable and liable to be set aside.
- B. That initially the appellant was transferred from Tehsildar D.I.Khan Division to Kohat District as Inspector Stamp of Kohat and when he himself adjusted alongwith his children after lapse of three months, the appellant is transferred from Inspector Stamp to Tehsildar Kohat and when the appellant legally performing his duties being Tehsildar Kohat, again transferred on the political influence and malafidely victimized and pressurized the appellant by transferring from Tehsildar to Inspector Stamp of Kohat.
- C. That the appellant after assuming his charge as Tehsildar Kohat, delivered his duties honestly, efficiently and diligently and number of times, the appellant refused to fulfill the illegal

demands of politicals for that reason, the appellant is transferred from Tehsildar Kohat to Inspector Stamp illegally.

- D. That the posting of respondent No.6 is based on political consideration as he has close ties with political figures and his appointment may give undue advantage to the political favourites.
- E. That as per rules of Govt Revenue & Estate Department, the minimum posting period for Tehsildar and Naib Tehsildar is not less than one year and in case the transfer is made before one year period, prior permission of Revenue & Estate Department is required.
- F. That the appellant is being treated unequally against the law and he is being deprived of equal protection of law.
- G. That through the impugned transfer order dated 24.07.2014, the respondents have violated the fundamental rights of the appellant as guaranteed by the Constitution of Pakistan.
- H. That any other grounds may be taken at the time of arguments, with the kind permission of this Honourable Court.

It is, therefore, humbly prayed that on acceptance of this service appeal, the impugned transfer order dated 24.07.2014 of respondent No.2 based on political influence and malafide, the same may kindly be set aside and be declared as illegal, unlawful and unconstitutional and against the transfer/posting policy and be set aside as such.

Any other remedy which deems fit by this Honourable Tribunal may also be granted in favour of appellant.

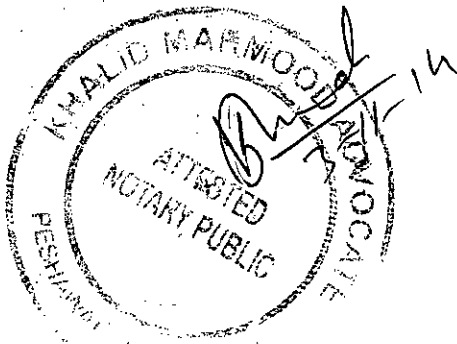

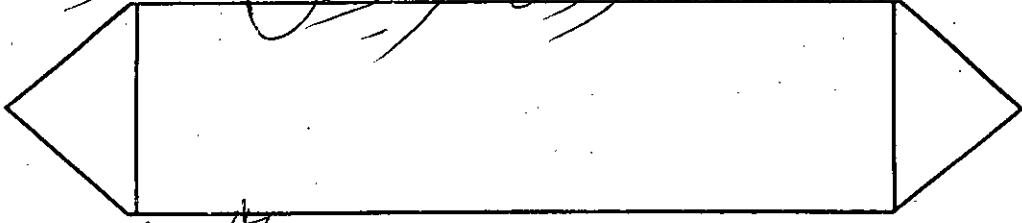
