Appeal under Section 4 of the Khyber Pakhtunkhwa Service Tribunal Act 1974, whereby the not promoting the appellant to the post of GIS Analyst BPS-17 against which the appellant filed his departmental appeal vide dated 14.11.2023 which is not yet respondent even after the lapse of statutory period of 90 days.

Prayer in appeal:

On acceptance of this appeal the appellant may declared fit and eligible for the post GIS Analyst BPS-17, and to consider/promote the appellant to the post of GIS Analyst BPS-17, the inaction of the respondent by not considering/promoting the appellant is this to be declared illegal, unlawful and without lawful authority, with necessary directions the promotion be given effect upon the eligibility for the post in question or any other remedy which is not specifically asked for may also be awarded in favor of the appellant.

Respectfully Submitted:

- 1. That the appellant was initially appointed on the post of Digitizing Operator BPS-12 in the respondent department in the year 2007.
- 2. That since his appointment the appellant is performing his duties with great zeal, devotion and to the entire satisfaction of his superiors without any complaint whatsoever regarding his performance till date.
- 3. That while performing in the said capacity the government of Khyber Pakhtunkhwa issued a notification regarding the upgradation of the post of Digitizing Operator BPS-12 to Digitizing Operator BPS-16 vide dated 11.01.2019. (Copy of the notification dated 11.01.2019 is attached as annexure A)
- 4. That upon the said notification the post of the appellant was also upgraded from BPS-12 to BPS-16 by the respondents vide notification dated 16.01.2019. (Copy of the notification dated 16.01.2019 is attached as annexure B).
- 5. That the next post in the channel of promotion from the Digitizing operator to the post of GIS Analyst BPS-17, whereas the post of GIS BPS -17 was reserved for 50% promotion amongst the Digitizing operator having 5 years' service on the basis of seniority cum fitness.
- 6. That the post of GIS analyst BPs -16 was also upgraded along with all other post to BPS-17, the colleagues/senior who been promoted the post of GIS analyst BPS-16 were also promoted and upgraded to BPS-17, the colleagues who been promoted were only spend 6 days and 1 years and 30 days respectively upgraded to the post of GIS analyst BPS-17.
- 7. That the Public service commission advertised the post of GIS Analyst into BPS-16, upon the appointments in BPS-16 but when joined as the post were upgraded they were also offered the post in Bps-17.

- 8. That the malafide intention of the respondents while not considering appellant upon the upgraded post BPS-17 on the plea that the post was upgraded as a personal upgradation to the incumbent and upon his promotion to GIS Manager BPS-18 will be downgraded to BPS-16 so his case cannot be considered for promotion clearly shows their malafide as on one hand the colleagues who merely spent 6 days were given the benefit of upgradation and also to those who been appointed against the post of GIS Analyst Bps-16 were adjusted in BPS-17 and considered the same as a general upgradation but in case of the appellant the view was turn down to personal upgradation.
- 9. That the anomaly so been created upon the upgradation of the post as the appellant is upgraded to BPS-16 and the next post in the channel of promotion is also in BPS-16 i.e. GIS Analyst so from the appellant the vested rights of promotion is taken away, as the same been given in the rules for promotion to the next higher post i.e. GIS Analyst.
- 10. That being aggrieved from the acts and omission of the respondent, the appellant filed his departmental appeal vide dated 14.11.2023 which is not yet responded even after the laps of statutory period of 90 days (Copy of the departmental appeal is attached as annexure C)
- 11. That the respondent issued circulate the Seniority list of Digitizing Operate BPS-12 vide latter Seniority List dated 03.12.2015, the appellant stood at Serial No 4 of the noted Seniority and respondent No 5 at Serial No 5. (Copy of Seniority List is attached as annexure D)
- 12. That the mentioned Respondent No 5 promoted to the post of GIS Analyst BPS-17 in violation of Rules, Seniority List and also against the person Grade of GIS Analyst.

GROUNDS OF SERVICE APPEAL:

- A. That the appellant has not been treated in accordance with law and hence her rights secured and guaranteed under law and constitution are badly violated.
- B. That appellant having all the requisite eligibility criteria for further promotion to the post of GIS Analyst BPS-17

according to the rules/quota,

- C. That according to the rules for promotion the post of GIS Analyst BPS-17 shall be filled on the basis of Seniority cum fitness with the ratio of 50% amongst the Digitizing Operator and 50 % by initial recruitment, the appellant under the 50% promotion quota.
- D. That the post of GIS analyst BPs -16 was also upgraded along with all other post to BPS-17, the colleagues/senior who been promoted the post of GIS analyst BPS-16 were also promoted and upgraded to BPS-17, the colleagues who been promoted were only spend 6 days and 1 years and 30 days respectively upgraded to the post of GIS analyst BPS-17. \
- E. That the Public service commission advertised the post of GIS Analyst into BPS-16, upon the appointments in BPS-16 but when joined as the post were upgraded they were also offered the post in Bps-17.
- F. That the malafide intention of the respondents while not considering appellant upon the upgraded post BPS-17 on the plea that the post was upgraded as a personal upgradation to the incumbent and upon his retirement the post will be downgraded to BPS-16 so his case cannot be considered for promotion clearly shows their malafide as on one hand the colleagues who merely spent 6 days were given the benefit of upgradation and also to those who been appointed against the post of GIS Analyst Bps-16 were adjusted in BPS-17 and considered the same as a general upgradation but in case of the appellant the view was turn down to personal upgradation.
- G. That the anomaly so been created upon the upgradation of the post as the appellant is upgraded to BPS-16 and the next post in the channel of promotion is also in BPS-16 i.e. GIS Analyst so from the appellant the vested rights of promotion is taken away, as the same been given in the rules for promotion to the next higher post i.e. GIS Analyst.
- H. That any other ground would be taken at the time of arguments with the prior permission of this honourable tribunal.

AN ACT

to provide for the regularization of the services of certain employees appointed on adhoc or contract basis.

WHEREAS it is expedient to provide for the regularization of the services of certain employees appointed on adhoc or contract basis, in the public interest, for the purposes hereinafter appearing;

It is hereby enacted as follows:-

1. <u>Short title and commencement.</u>---(1) This Act may be called the ⁵[Khyber Pakhtunkhwa] Employees (Regularization of Services) Act, 2009.

 - (a) "Commission" means the ⁶[Khyber Pakhtunkhwa] Public Service Commission;
 - (aa) "contract appointment" means appointment of a duly qualified person made otherwise than in accordance with the prescribed method of recruitment;
 - (b) "employee" means an adhoc or a contract employee appointed by Government on adhoc or contract basis or second shift/night shift but does not include the employees for project post or appointed on work charge basis or who are paid out of contingencies;

- (c) "Government" means the Government of the ¹[Khyber Pakhtunkhwa];
- (d) "Government Department" means any department constituted under rule 3 of the ²[Khyber Pakhtunkhwa] Government Rules of Business, 1985, and does not include any section of a Department or an organization which is federally funded;
- (e) "law or rule" means the law or rule for the time being in force governing the selection and appointment of civil servants; and
- (f) "post" means a post under Government or in connection with the affairs of Government to be filled in on the recommendation of the Commission.

(2) The expressions "adhoc or contract appointment" and "civil servant" shall have the same meanings as respectively assigned to them in the ³[Khyber Pakhtunkhwa] Civil Servants Act, 1973 (⁴[Khyber Pakhtunkhwa] Act No. XVIII of 1973).

3. <u>Regularization of services of certain employees.</u>—All employees including recommendees of the High Court appointed on contract or adhoc basis and holding that post on 31st December, 2008 or till the commencement of this Act shall be deemed to have been validly appointed on regular basis having the 'same qualification and experience for a regular post:

Provided that the service promotion quota of all service cadres shall not be affected.

4. <u>Determination of seniority.</u>---(1) The employees whose services are regularized under this Act or in the process of attaining service at the commencement of this Act shall rank junior to all civil servants belonging to the same service or cadre, as the case may be, who are in service on regular basis on the commencement of this Act, and shall also rank junior to such other persons, if any, who, in pursuance of the recommendation of the Commission made before the commencement of this Act, are to be appointed to the respective service or cadre, irrespective of their actual date of appointment.

(2) The seniority interse of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their continuous officiation in such service or cadre:



4A. <u>Overriding effect</u>.---Notwithstanding any thing to the contrary contained in any other law or rule for the time being in force, the Act shall cease to have effect.
