Prayer:-

That on acceptance of the instant service appeal, the impugned order dated 28/11/2023 may kindly be set aside to the extent of private respondent and the respondent be directed to consider the appellant for promotion to the post of ASI with all back and consequential benefits. Any other remedy which this august Tribunal deem fit may also be awarded in favour of the appellant.

R/SHEWETH: ON FACTS:

Brief facts giving rise to the present appeal are as under:

- That the appellant was appointed as Levy Sepoy in the defunct Mohmand Agency now District Mohmand in the levies force and was performing his duties quite efficiently and to the entire satisfaction of superiors.
- That in pursuance to the ibid rules and all other enabling laws the Government of Khyber Pakhtunkhwa Home & Tribal Affairs Department has absorbed Khasadar force through notification dated 11/02/2020 in their respective ranks and accordingly the private respondent No.3 was absorbed as constable, shown at S.No.321 of the ibid notification and similarly private respondent

No.4	has	been	absorbed	viz-a-viz.	Copy	of	notification	dated
11/0	2/202	20 is a	ttached as	annexure				B

- 5) That absorption in the police force of Khyber Pakhtunkhwa, the appellant started performing duty in the police department quite efficiently and to the entire satisfaction of superior and no complaint whatsoever.
- 7) That feeling aggrieved from the impugned order the appellant alongwith their other colleagues filed departmental appeal before the Inspector General of Police but the same has not been responded till date. Copy of departmental appeal is attached as annexure.
- 8) That now the appellant having no other remedy, filed the instant service appeal on the following grounds amongst other:-

GROUNDS:

- 4
- A- That the impugned order dated 28/11/2023, whereby the private respondents have been confirmed against the post of ASI being junior from the appellant, is ultra vires, facts, law, norms of natural justice and materials on record, hence not tenable and liable to be set aside to the extent of private respondents.
- B- That the action and inaction of the respondents by ignoring the appellant and confirming the private respondents against the post of ASI being junior to the appellant is against the law, facts, norms of natural justice and materials on the record hence not tenable and liable to be set aside to the extent of private respondents.
 - C- That appellant has not been treated by the respondent Department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
 - D- That, the treatment meted out to the appellant is clearly based on discrimination and malafide and as such the respondents violated the principle of natural justice.
 - E- That the appellant has been discriminated by the respondents department on the subject noted above and as such the respondents violated the principles of natural justice.
 - F- That the impugned order dated 28/11/2023, whereby the private respondents have been confirmed against the post of ASI being junior from the appellant is also violation of section 9 of the KP Civil Servant Act, 1973.
- G- That according to Article 38 of the Constitution of Islamic Republic of Pakistan, 1973, the state is bound to reduce disparity in the income and earning of individuals including persons in the Service of the Federation. That in light of the mentioned article the appellant is on strong footing.

That appellant seeks permission to advance other grounds and proofs at the time of hearing.

No. SO(Police-ID/HD/SMY/2019:— In exercise of the powers conferred by section 10 of the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act. No. XXXIV of 2019), read with section 5 thereof, the Government of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:

The Khasadar Force (Absorption in the Khyber Pakhtunkhwa Police) Rules, 2019.

- 1. Short title, application and commencement.—(1) These rules may be called the Khasadar Force (Absorption in the Khyber Pakhtunkhwa Police) Rules, 2019.
 - (2) These rules shall apply to all members of the Khasadar Force.
 - (3) These rules shall come into force at once.
- 2. Definitions.--(1) In these rules, unless there is anything repugnant in the subject or context, the following expressions shall have the meanings hereby respectively assigned to them, that is to say,-
 - (a) "absorption" means the process of permanent induction of the members of the Khasadar Force in the Police, in accordance with these rules;
 - (b) "Act" means the Khyber Pakhtunkhwa Khasadar Force Act, 2019 (Khyber Pakhtunkhwa Act. No. XXXIV of 2019);
 - (c) "Provincial Police Officer" means the head of the Provincial Police, who is appointed under section 15

of the Police Act, 2017 (Khyber Pakhtunkhwa Act No. II of 2017); and

- (d) "Schedule" means the Schedule, appended to these rules;
- (2) Words and expressions used, but not defined in these rules shall have the same meanings as are respectively assigned to them in the Act.
- 3. Absorption.—The members of the Khasadar Force shall be permanently absorbed in the Police, against vacancies to be newly created in the Police Department for the purpose, in the following manner:
 - (a) A Scrutiny Committee, hended by the Commandant, and having one member each from District Administration and District Account Officer of the district concern, shall prepare the lists of all the members of the Khasadar Force after personal appearance and scrutiny of record for submission to the Provincial Police Officer;
 - (b) the lists, submitted to the Provincial Police Officer, under sub-rule (1), after proper sifting, shall be forwarded to Home and Tribal Affairs Department of Government with the recommendations for permanent absorption of members of the Khadadar Force in the Police into the respective ranks or cadres as per the Schedule; and
 - the Home and Tribal Affairs Department of Government, after receiving the lists of all the members of Khasadar Force, shall issue notification of absorption of the Khasadar Force in the Police after approval of the Cabinet.

- incentives.—The Khasadar Force absorption in the Police shall be entitled to the same benefits, remuneration and other incentives as are enjoyed by other members of the Police.
- Training.--Special training modules shall be designed by the Training Wing of the Police for imparting requisite police training so that the members of the Khasadar Force are fully sensitized with all Police
- Seniority.--Members of the Khasadar Force, who are absorbed in the Police, in accordance with Government orders and instructions, shall take seniority in the Police from the date of the initial appointment upon recruitment in the Khasadar Force:

Provided that the officer inducted in one batch, upon induction, shall retain their inter se seniority as in the Khasadar Force:

- Repeal and savings.—(1) All rules, orders or instructions, including the Federal Khasadar Force Service Rules, in force in respect of the Khasadar Force, immediately before the commencement of these rules, shall be deemed as repealed in so far those rules, orders or instructions are inconsistent with these rules.
- Notwithstanding the repeal of all rules, orders or instructions, including the Federal Khasadar Force Service Rules, mentioned in sub-rule (!)
 - affecting the seniority and promotion, all promotions done seniority determined and orders made shall be deemed to have been done, determined and made in accordance with law. The repeal, shall not affect any right, privilege, obligation or liability acquired, accrued or incurred under the repealed rules, orders and instructions;

and



(b) shall not affect any investigation or legal proceedings in any Court of Law and shall be continued in the same manner as if the laws and rules have not been repealed.

Removing of difficulties.—(1) If any difficulty arises in giving effect to any provisions of these rules and notifications made thereunder, a Technical Committee, comprising of three members of the Potice Department, to be notified by the Provincial Police Officer, headed by an Officer of Police, who shall not be below the rank of Deputy Inspector General of Police and two other members of Police Department, whose ranks shall not be less than Senior Superintendent of Police, may recommend to Government for giving effects to the provisions of these rules.

(2) Government, after considering such recommendations, submitted by the Technical Committee, under sub-rule (1), may, by notification, make such orders, not inconsistent with the provisions of the Act or these rules, as may appear to it to be necessary for the purpose of removing such difficulty.

Respected Sir,

- That the appellants are the employees of your good-self department and are serving as Head Constables (BPS-09) since their appointments till date, quite efficiently and upto the entire satisfaction of their superiors.
- That the appellants through notification dated 11/02/2020 have been 2absorbed in Police Department from Levies Force Mohmand as Head Constables (BPS-09).
- That similarly above named persons are also absorbed through 3notification dated 11/02/2020 form Khasadar Force Mohmand into Police Department as FC (BPS-07).
- That through impugned notification dated 28/11/2020, the above named persons have been confirmed as Assistant Sub Inspectors, despite the fact that both are juniors to the appellants, but illegally and without adopting proper procedure for their promotion and confirmation, ignored seniors colleagues without any reason and justification.
- 5-That appellants aggrieved from the impugned notification, being illegal and against the Police Rules, preferred the instant Departmental Appeal before your honor inter alia on the following grounds:- (Copies Released Record Attached)

Grounds:

- A) That the impugned order being contrary to law and rules and in utter violation of the law on the subject hence not tenable in the eye of Law.
- B) That appellants have not been treated by the department concerned in accordance with law and rules on the subject noted above and as such action of the respondent department is violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- That the impugned notification is also violative of the Police Rules.



- That the treatment meted out to the appellants is a clear violation. D) of the Fundamental Rights of the appellants as enshrined in the Constitution of Pakistan 1973.
- That while issuing the impugned notification, the appellants being E) seniors from above mentioned persons, ignored and they have been promoted/confirmed.
- F) That neither the above mentioned persons are enlisted in the concerned list of ASI, nor any Departmental Promotion Committee (DPC) conducted before issuing the impugned notification.
- G) That the impugned notification is also violative of APT Rules.
- H) That the impugned notification is also against the Articles 38-E of the Constitution of Islamic Republic of Pakistan, 1973.

It is, therefore, most humbly requested that on of this Departmental Appeal, notification may very kindly be set aside to the extent of Serial No 36 Izaz Ali Shah & Serial No 38 Ajmal Khan, whereby they have been promoted/ confirmed being junior to the appellants and without conducting proper DPC.
