

Appeal under Section 4 of NWFP Service Tribunal Act 1973 against the order Notification No.1500/5. Further order vide letter No. 1506/10 and both dated 09-4-2014 by the respondent No3. Vide which the petitioner was given "Final warning" additional with transfer orders dated 09-04-2014 on disciplinary ground

---

PRAYER: impugned orders of Final warning and transfer on disciplinary ground may be set-aside, the appeal in hand may be accepted. The appellant posting as per notification No.1525/G dated 20-11-2013 may be restored. And Sumaira Naz PHST respondent No.5 may be proceeded against disciplinarily.

---

**FACTS**

1. That the appellant and respondents No.5 including others were promoted to PSHT in (BPS 15) vide notification No.1525/G dated 20-11-2013 by respondent No.3. (Annexure A Promotion Notification)
2. That the appellant and respondent No.5 were placed at Sr.No 248 and Sr. No.371 respectively of the same school i.e. GGPS Iran Abad Mardan.

3. That the appellant through above notification was kept in the same school being Senior to respondent No. 5 and she was promoted and posted at nearby GGPS Aslam Khan Koroona Mardan and than on her request posted at GGPS Gumbat Mardan even then, she remain unsatisfied.
4. That respondent No.5 disobey the above mentioned transfer/posting orders and grabed the school record from appellant, shifted the same to her home and appellant was kicked out of her school (GGPS Iran Abad) forcibly with the collusion of school Chowkidar and others and then lock the school illegally, hence respondent No. 5 is guilty misconduct.
5. That the matter was not only reported to ADEO (F) Mardan, but also to the respondent No.3 DEO(F) Mardan on 08-02-2014. (Annexure B Complaint Application)
6. That DEO (F) visited the spot upon the report of appellant, who instead of punishing the respondent No.5 give final warning and transfer appellant on disciplinary ground malafidely. Annexure C Copy of Notification 1500/5 and Annexure D Transfer Notification 1506/10 dated 09-4-2014)
7. That the respondent No 3 dictate statement for scribing the same in petitioner hand writing and affixing her signature thereon under threat.
8. That the respondent No. 3 & 4 extend her favour for respondent No. 5 (Sumaira Naz PSHT) being wife of Education Clerk namely Shaukat working under the respondent No.3
9. That aggrieved with the impugned orders the appellant preferred appeal to the respondent 1 & 2 vide diary No.3464 & 3465 dated 16-04-2014. The same is than marked by respondent 1 to respondent No.2 which. Annexure E & E/ Departmental Appeals

### GROUNDS

- A. That the impugned orders and notification is void, illegal, unjustified, against the principle of Natural Justice and untenable under the law and arbitrary in nature.
- B. That the appellant was legally promoted and posted , but the respondent No.3 failed to comply with her order, vide Notification No.1525/9 dated 20-11-2013.
- C. That the appellant was condemned unheard as she was not afforded any opportunity before passing the impugned orders.

- D. That the appellant was subjected to discrimination on the basis of unjustified like and dislike.
- E. That the appellant was legally kept on her old place of posting on the basis of seniority as compared to respondent No. 5 which was the legal and procedural requirements and long standing practice of posting and transfer.
- F. That the impugned orders are the result of nepotism, as the husband of respondent No. 5 is Education clerk has good relation with the respondent No. 3 & 4.
- G. That transfer on disciplinary ground is void abinitio because transfer cannot be made as penalty under the relevant law on the subject.
- H. That respondent No. 5 is guilty of misconduct not only on the basis of present occurrence but also her previous service record. Which is evident from impugned order No. 1500/5 dated 09-4-2014 vide para No. 1 & 7.
- I. That no codal formalities was ever conducting before passing the impugned orders.
- J. That the appellant will suffer, irreparable loss by impugned orders and her service record will be blemished forever.
- K. That the appellant seeks leave of this Honourable Service Tribunal to raise further ground also.

It is therefore prayed that impugned orders of Final warning and transfer on disciplinary ground may be set-aside, the appeal in hand may be accepted. The appellant posting as per notification No.1525/G dated 20-11-2013 may be restored. And Sumaira Naz PHST respondent No.5 may be proceeded disciplinary.

Respectfully submitted that:

1. I, Mrs Mazida Begum, am serving in Education Department since 30<sup>th</sup> April 1987 & was posted as PST to GGPS Iran Abad, Distt: Mardan since 2008.
2. On 8-4-2014, I the undersigned complained to DEO (F), Distt Mardan about illegal activities of Miss Sumaira Naz, PST who was earlier Transferred from GGPS Iranabad to GGPS Aslam Khan Korona but did not vacated the post (**Annex-I**).
3. **On my compliant, DEO (F) Mardan, Miss Zuhra Begum called me on 09-04-2014 in her office alongwith the accused Sumaira Naz and handed me a written statement to write it in my own handwriting and sign it and threatened me that by refusing you will be dismissed from your services, and I was bound to write and sign.**
4. DEO (F), Mardan instead of making proper enquiry, has issued illegal Transfer Order on disciplinary grounds alongwith Final Warning to the undersigned (**Annex-II & III**).
5. All the staff members have also submitted a written statement in this regard showing clear picture of whole situation. (**Annex-IV**)
6. Para-1 of Notification dated 9-4-2014 clearly states that "Whereas Mst. Sumaira Naz GGPS Dhaki Gumbat illegally setting at GGPS Iran Abad and interfering in the school matters" and Para-2 states "Sumaira Naz & Mazeeda Begum are quarreling with each other" justifies that who is guilty for disciplinary action (**Annex-III**)
7. An application from the undersigned dated 8-2-2014 about the illegal activities of Miss. Sumaira Naz was also submitted to DEO (F), but in vain. (**Annex-V**).
8. An FIR has also been lodged against the accused for beating one of her staff members as also mentioned in Para-7 of Notification dated 9-4-2014 (**Annex-III**).
9. The Husband of Miss Sumaira Naz is serving as Clerk at Education Department, Distt: Mardan and the same has also been high lighted in press release dated September 17, 2013 (**Annex-VI**)
10. It is worth mentioning that the GGPS, Iranabad Chowkidar Mr. Zahir was also involved with Sumaira Naz in disturbing the school environment by taking his brother inside the school on 8-4-2014 and locking the main gates of School on 09-04-2014 without any permission of undersigned, being School Head Mistress.
11. So many transfer orders of Mst. Sumaira Naz were issued by DEO (F), Mardan (that can be verified from record) but she was still sitting at GGPS Iran Abad (**Para-1 of Notification dated 09-04-2014 Annex-III**).
12. The threat of removal of service by Miss Zuhra Begum, DEO (F), Distt Mardan and Transfer order/ Notification has mentally tortured me.
