JUDGMENT

NIAZ MUIHAMMAD KHAN, CHAIRMAN.- Arguments of the
learned counsel for the parties heard and record perused.

FACTS

2. The appellant was removed from service vide order dated 21.10.2013 against which he filed a department appeal (which is undated). The same was rejected on 12.03.2015 and as per the appellant it was communicated to him on

10.12.2015 and thereafter the present service appeal on 08.01.2016. The charge against the appellant was his unauthorized absence.

ARGUMENTS.

3. The learned counsel for the appellant argued that the appellant did proceed abroad after getting NOC from the department. That he did apply for leave abroad and his application is also available on the file. That he came back from abroad after completing the course and reported for duty, he was informed that he has been removed from service. That the whole proceedings are illegal as the appellant was never associated with the proceedings. That no charge sheet and statement of allegations or show cause notice were ever served on the appellant. That even the notice of appearance was also not served on the appellant. That as per the principles of *audi alterim partim* these proceedings are illegal. He further argued that even otherwise absence from duty in the circumstances does not warrant for removal from service and he should have been imposed the minor penalty. In this regard he relied upon judgments reported in 2006-SCMR-434, 2011-PLC(C.S)117 and 2015-SCMR-117

4. On the other hand, the learned District Attorney argued that the present appeal is hopelessly time barred. That the appellant filed departmental appeal which is undated, however, the letter issued by the District Health Officer on 12.03.2014 clearly suggests that the appellant filed departmental appeal before 02.01.2014. That if the limitation of 90 days is reckoned from 2.01.2014, the present appeal should have been filed before 02.05.2014. He further argued that the appellant proceeded without sanction of leave. That no NOC was issued to the appellant by any departmental authority for proceeding abroad. That the proceedings were initiated and concluded under Rule 9 of the Khyber Pakhtunkhwa Government

Servants (E&D) Rules, 2011 and all the requirements of the said Rules have been fulfilled.

CONCLUSION.

5. As per record the departmental appeal was filed with no date but was rejected on 12.03.2015 and communicated to the appellant on 10.12.2015. The learned DDA is of the view that the departmental representative disowned communication dated 10.12.2015 but the department does not initiated any proceedings against the appellant, therefore, this plea cannot be accepted by verbal assertion and the present appeal has been filed within time after the communication.


6. The appellant was granted leave for 30 days from 20.05.2009 which expired on 20.06.2009. He was also allowed to proceed abroad by the leave sanctioning authority. However, he was again granted 56 days leave on half pay but it is not clear from that sanction that from what date he was granted that leave. Finally, he applied for 730 days from 20.09.2009 which was never sanctioned.

7. Now this Tribunal is to see whether the appellant did proceed without sanction of leave and can take the benefit of principles of *audi alterim partim* as argued by the learned counsel for the appellant. The judgment in this regard reported as 2015-SCMR-117, relates to a situation when that absence period was regularized by the department and on the other hand he was imposed the penalty of removal from service. The said case is not applicable to the present case as there is no regularization of any period of absence of the appellant. The second judgment reported as 2006-SCMR-434 is also not applicable to the present case as in that case the period of absence was converted into leave of the kind due. The third case reported as 2011-PLC(C.S) 387 of the Sindh Service Tribunal is a case in which the civil servant was involved in a criminal case and there was no regular enquiry. This case is also not applicable to the present case.

8. The present proceedings were initiated under Rule 9 of the Khyber Pakhtunkhwa Government Servants (E&D) Rules, 2011 which clearly says that a notice shall be issued by the competent authority through registered acknowledgement on his home address directing him to resume duty within fifteen days of issuance of such notice. The second step is that a notice shall be published in newspaper directed him to resume duty within fifteen days of the publication of that notice and if he does not join the duty within the specified time he is to be removed from service. This rule does not leave any room to the authority to grant a lesser punishment.

9. As a sequel to the above discussion no case is made out which is hereby dismissed. Parties are left to bear their own costs. File be consigned to the record room.







Respectfully Sheweth:

1. That the appellant was appointed as Dental Surgeon in BPS-17 on contract basis in Health Department on dated 12.09.2002. Copy of the appointment letter is attached as Annexure "A"
2. That the appellant has served the health Department with all devotion and skill and no complaint whatsoever has been made against him from any quarter and thus he has tremendous and clean slate in his hand and his contract period was extended from time to time. Copies of contract extension letters are attached as Annexure "B"
3. That in 2009 the Govt. of Khyber Pakhtunkhwa regularized the services of certain employees in which the appellant was regularized under N.W.F.P Employees (Regularization of Services) Act 2009. Copy of the regularization order of appellant is attached as Annexure "C"

4. That the appellant during course of time proceeded abroad with the permission of the concerned department. Copies of NOCs are attached as Annexure "D".
5. That appellant got an MPH (Master in Public Health) Degree from LUNDS University Sweden during his stay abroad. Copy of the Degree is attached as Annexure "E"
6. That on different dates the respondents No.5 issued Notice regarding the absentee from service but the appellant did not receive any of the notice and was not aware of the said notices. Copies of the Notices are attached as Annexure "F"
7. That the respondent No.3 appointed Dr.Abul Wadood as inquiry officer and on 28.04.2010 inquiry officer submitted the Enquiry report. Copy of the Enquiry report is attached as Annexure "G".
8. That on basis of one sided inquiry report respondent No.3 vide order dated 21.10.2013 dismissed the appellant from service. Copy of the order dated 21.10.2013 is attached as Annexure "H".
9. That thereafter the appellant submitted departmental appeal/representation to Respondent No.2 but the same was also turned down vide impugned order dated 12.03.2015. Copy of the departmental appeal/representation and impugned order dated 12.03.2015 is attached as annexure "I" and "J"
10. That the appellant now prefers this service appeal before This Hon'ble Tribunal for the following amongst other grounds;

GROUND:

- A. That the respondents did not issue show cause notice as well as any charge sheet to the appellant which is the mandatory requirement of law .
- B. That the appellant was condemned unheard which is against the norms of natural Justice.
- C. That the respondents conducted one side inquiry and appellant was not asked/called for inquiry proceedings by the inquiry officer which is illegal and unlawful against the rights of the appellant.
- D. That respondent No.5 is/was biased to the appellant on the pretext that despite NOCs were issued from the concerned quarter to the appellant and issued Notices and conducted an illegal inquiry
- E. That the dismissal/ removal from service orders are highly excessive, arbitrary and unjustified.
- F. That the appellant has already served for a long time and has almost earned entitlement to pension, hence, in the circumstances the impugned order is not warranted.
- G. That the appellant has been treated against the law/ rules and regulations and has been deprived of equal protection of law.

- H. That during his service and duty appellant performed his duty/job to the entire satisfaction of his superior. He remained exemplary regular and punctual and no complaint whatsoever was ever made against him from any quarter including the public at large and therefore no justification exists for passing the impugned order.

- I. That any other ground not specifically mentioned here would be advanced, with the permission of this Hon'ble Tribunal, at the time of arguments.

It is, therefore, most humbly prayed that by accepting this appeal, the impugned order of respondent No.2 and 3 dated 12.03.2015 Respectively may please be set a side and consequentially the appellant may please be reinstated in service with all back benefits .

I have a humble request to adjust me on my post and that period should be considered as leave with pay basis. I have spent so much money and due compensation should be given in my case. I want to serve my country in my own field and permission should be granted that I should continue my work for betterment of people of Pakistan.
