

ENDS 1734-44 CLASS IV APPIT 2021, DATED HANGU 28-05-22 PASSED BY **RESPONDENT NO. 3 TO POST /TRANSFER THE APPELLANT** TO GOVT HIGH BALYAMINA INSTEAD OF HANGU DUE TO PERSONAL GRUDGE OF THE RESPONDENT NO.3 WITH THE APPELLANT THE SAME ORDER IS LIABLE TO BE CANCELLED AS THE APPELLANT IS APPOINTED ON MINORITY SEAT, FURTHER DUE SECTARIAN ISSUES THE APPELLANT IS UNABLE TO PERTAIN HIS DUTY IN THE SAID SCHOOL SECONDARY THE RESPONDENT NO.3 ISSUED LEETER NO.936-38 DATED 16-11-2023 FOR REFUNDING OVER PAYMENT SINCE 06-06-2022 TO 05-06-2023 WHICH IS WRONG AND WITHOUT LEGAL AUTHORITY AND THE SAME IS LAIBLE TO BE SET ASIDE. THE RESPONDENT NO.3 IS JUST TO PENALIZE THE APPELLANT INSTEAD OF SOLVING HIS GRIEVANCES. IT IS TO MENTION HERE THAT THE APPELLANT HAS TAKEN CHARGE ON 06-06-2022 LEGALLY AND AS PER OMBUDSMAN SECRETARIAT ISSUE GUIDELINES LETTER DATED 27-03-2023.



#### **Respectfully Sheweth:-**

It is humbly submit as under:

- That the addresses of the parties for the purpose of service by learned court have been correctly given above.
- 2. That the appellant and his family are the law abiding citizen of Pakistan and permanent resident of Hangu.
- 3. That the appellant was appointed / transferred against the post of "Naib Qasid" on 28-05-2002 on minority seat at Government High School Balyamina which is situated at remote area. (Appellant's appointment, transfer orders are placed on file).
- 4. That the appellant has already assumed his charge on 06-06-2022 and his pay was released by the respondent no.3 vide letter no- 936-38 dated 15-11-2023 which is self-explanatory.
- 5. That through this instant appeal the appellant humbly seeks the indulgence of this Hon'ble court for setting aside posting / transfer order dated 28-05-2022 whereby the appellant was posted / transferred at G.H.S Bilyamina because the appellant is unable to perform his duty efficiently, diligently due to serious ethics issues which needs to be resolved by the respondent no.3 without his personal ego.
- 6. That the deduction of salary w.e.f 06-06-2022 to 05-06-2023 is also illegal and without any justification on which needs to be reviewed by the respondent no.3, he has put the appellant in mental agony as well his family. it is pertinent to mention here that the respondent no.3 is negating his own office order no. 1762-63 dated 16/06/2023 addressed to the principal Govt High School Bilyamina Hangu and copy to Distt accountant officer Hangu (copy of the order dated 16-06-2-23 is attached herewith).
- 7. That the order of posting / transfer passed by respondent no.3 against appellant to bilyamina is not is not sustainable in the eyes of law as well violation of the constitution of Islamic Republic of Pakistan, which is suffered from surmises and conjectures Hence liable to be set aside inter alia on the following grounds.

#### **GROUNDS:**

- 1. That the impugned order dated 22-05-2022 passed by respondent no.3 is a sheer violation laid down by Apex court in transfer matters. At the time of transferring a public official, the superior must follow guide lines and principles envisaged in the precedents. Although transfer is prerogative of the employer, however the same is liable to be called for if exercise in arbitrarily.
- 2. That the appellant was posted / transfer to unsafe place i.e G.H.S bilyamina instead of Hangu just to penalize for personal ego of respondent no.3 and put the appellant in fear, and choase and the appellant has not been allowed to perform his duty peacefully.
- 3. That the appellant submitted his representation before respondent no.4 for cancellation / with drawl of his transfer order. The respondent no.4 sought comments from the parties. The hearing was conducted by the respondent no.4 in the presence of respondent no.2, 3 and 7. The respondent no.4 issued his findings that the appellant was appointed against the vacant post of class IV under minority quota at G.H.S Bilyamina but due sectarian issue he could not join his duty and it is the responsibility of DEO (Male) Hangu to adjust the appellant at any other station but no action has been taken by the respondent no.3 up till now. (Copy of the provincial ombudsman judgement finding is placed on file).
- 4. That the appellant also made representation to respondent no.2 to transfer him to Hangu instead of bilyamina the respondent no.2 directed the respondent no.3 to solve the grievances of appellant but in vain (Copy of the application and letter is attached herewith).
- 5. The appellant submitted his application to respondent no.5 for redressal of his transfer case, who accepted the stance of appellant and directed the respondent no.3 to resolve his transfer issue but the respondent no.3 gave a deaf ear to the directives of Deputy Commissioner Hangu (respondent no.5). (Application of the appellant and letter of D.C Hangu is placed on file).
- 6. That the appellant has a clear and unblemished and good service record. His performance has been acknowledge by the principal G.H.S Bilyamina Distt Hangu (Respondent No.7). (Letter of principal No.916-17 dated 13-10-2023 is placed on file).
- 7. That the appellant / head made representation to respondent no.8 but no fruit full result has been achieved till date copy of letter of human rights is attached)
- 8. That if the appeal is not accepted, irreparable loss will be suffered by the appellant.
- 9. That there are two other stations that the applicant should be adjusted as per district education officer letter. (Letter dated 11-12-2023 is attached).
- 10. That the appellant has no other alternative effective and speedy remedy for the redressal of his grievance and can only invoke the jurisdiction of this Honorable court.
- 11. That the appellant humbly seeks permission of this Honorable tribunal to raise additional grounds at the stage of arguments.

#### **PRAYER**

In aforementioned circumstances it is humbly prayed the instant appeal may kindly be accepted and order dated 28-05-2022 passed by responded no.3 / Distt Education Officer Hangu (Male) whereby, the appellant was posted / transferred to Govt high school bilyamina may graciously be set aside, further the respondent no.3 may be restrained from making deduction from the salary w.e.f 06-06-2022 to 05-06-2023 of the appellant. Any other relief which this Honorable court deems fit and appropriate may kindly also be granted.







#### THE COMPLAINT

Mr. Ravi Singh r/o District Hangu instituted the instant compliant stating that he is appointed against the vacant post of Naib Qasid under minority quota in Government High School Bilyamina Hangu vide appointment order No. 1734-44 dated 28/05/2022 However, the principal concerned is not allowing him for taking over charge of the post. Ite stated that he approached the District Education Officer (Male) Hangu and Deputy Commissioner Hangu also for redressal of his grievance but in vain. He requested this Forum for redressal of his grievance.

#### **REPLY OF THE AGENCY**

Notices under Section 10(4) of the Khyber Pakhtunkhwa Provincial Ombudsman Act, 2010 were issued to Director Elementary & Secondary Education Khyber Pakhtunkhwa, District Education Officer (Male) Hangu and Principal Government High School Bilyamina Hangu to meet the allegations contained in the complaint and submit reply including rebuttal, if any. In response District Education Officer (Male) Hangu informed that Mr. Ravi Sing was appointed as Naib Qasid, at Government High School Bilyamina Hangu vide office order No. 1734-44 dated 28/05/2022. But he failed to join the duty.

#### REJOINDER

Reply of the Agency was shared with the complainant for his feedback/ rejoinder. In response, he rejected the stance of the Agency and reiterated his earlier stance.

#### **HEARING**

Due to divergent stance of both the parties, the case was fixed for hearing on 26/01/2023. Mr. Asmatullah Khan Principal GHSS Bilyamina Hangu and Muhammad Nawaz Khan ADO (Litigation), DEO (M) Hangu attended the hearing as representative of the Agency. During hearing Principal of Government High School Bilyamina stated that due to sectarian issues, the complainant was unable to attend the school for joining duty. The Principal requested that the DEO (M) Hangu may be requested to resolve the issue. During hearing, the representative of

#### **FINDINGS**


Perusal of record shows that complainant was appointed against the vacant post of Class-IV under minority quota at GHSS Hangu, but due to sectarian issue, he could not join his duty. It is the responsibility of DEO (M) Hangu to adjust the complainant on any other vacancy subject to his eligibility for the post. Therefore, it is recommended that DEO (M) Hangu may adjust him at any other station, as per rules, but not later than 45 days of the receipt of these Findings.

Note: Defiance/ non-compliance shall warrant disciplinary proceedings against the Principal Officer of the Agency in terms of Section 11 of the Khyber Pakhtunkhwa Provincial Ombudsman Act, 2010, whereby, the Government will take necessary action for ensuring good governance.




