The meeting started with the recitation of the Holy Quran.

Then the Chair welcomed the participants in this meeting and threw light on the importance of the meeting while adding that in order to ensure feasible and conducive teaching learning environment to the children in the schools, the teacher community must be facilitated, satisfied and supported as per policy of the Provincial Government. So, keeping in view the dire need of the schools as well as the persistent demand of the PST cadre for promotion to the Posts of PSHTs BPS -15, the SEDO(M) concerned were directed to work on the seniority lists of SPSTs in order to come up with fair, undisputed and final seniority list, which is the prerequisite for promotion process. He further stated that the SDEOs and ASDEOs Circles were time and again directed to further direct the qualified SPSTs to submit the required documents on emergency basis in order that the promotion process may be finalized in time and at the same time the said directions were notified through electronic media (Facebook page) as well to keep the teachers informed and updated.

The DEO(M) added that a scrutiny committee was constituted in this connection to update the available seniority list and check all the relevant documents (S/Books and synopsis/ACRs/Result statement for 3 years etc) of each and every candidate and finalize the list of SPSTs to be promoted to PSHTs on the basis of their inter-se-seniority as per promotion policy vide Notification No.SO(PE)4-5/SSRC/Meeting/2012/Teaching Cader dated November 13, 2012. The Notification referred above at S.No 18 under column No.5 regarding promotion of SPSTs to PSHTs which is reproduced as below:

"By promotion on the basis of seniority-cum-fitness, from amongst Senior Primary School Teachers with at least ten years service and having qualification prescribed for Initial recruitment of Primary School Teacher".

The DEO(M) further invited the participants to check the due cases of promotion of the concerned teachers as per working papers already prepared by the concerned SDEOs/ASDEOs and Primary Establishment Branch. The detail of the teachers to be promoted in respective cader are as under:






