



Prayer of Service appeal.

I.To declare illegal and set aside the seniority list Superintendents BPS 17 dated 31/12/2021. The appellant is entitled to seek seniority list superintendents BPS 17 dated 31/12/2021 at serial number 20 and It is therefore, most humbly prayed to direct the Respondent No, 1 to include the name of the appellant in final list dated 31/12/2021.

II.To declare illegal and set aside the impugned promotion order dated 27/06/2022 superintendent BPS 17 to Budget and Accounts officer BPS 17 No, SO/PE/ E&SED /2-6/DP C Meeting /Promotion of superintendent / 2022 dated 27/06/2022.

III.it is humbly prayed to declare illegal

and set aside the adjustment order
No, SO/S(M) E & SED /5-17 dated
02/08/2022.

IV. To declare illegal and set aside the working papers for D.P.C. to be held on 23/05/2022, the appellant promotion file process for pro forma promotion to Budget and Accounts officer BPS 17 and issued the pro forma promotion order of the appellant with all consequential benefits.

V. It is most humbly to prayed to implement the Government of K.P. letter/ instructions vide letter No, SO/PSB/ ED-1 - 25/2021 K. C. dated 17/01/2022.

VI. That the Respondents No,1 intentionally and mala fidely not process twenty (20) superintendents completed in all respect files to D.P.C. in prescribed period vide Govt : of K.P. circular No, SO (PSB) ED/1-25/ 2021 K.C Dated 17/01/2022. It is further prayed to direct the Respondent No, 1 to process the appellant promotion file and submit to D.P. C. for pro forma promotion to the post of Budget and Accounts officer B.P.S 17 for next meeting.

Vii .Any other remedy which just appropriate and efficacious may also be awarded in favor of the appellant please.

FACTS OF THE SERVICE APPEAL.

1. That the appellant is the permanent resident of Saidu Sharif Swat.

- 2. That the appellant was initially appointed as junior clerk vide order dated 09/03/1980 in Elementary and secondary Education Swat (Copy of appointment as Annex: A)**
- 3. That the appellant was promoted to the post of senior clerk on 30/09/1990 while again promoted to the post of Assistant BPS 16 on 28/05/2014 as well as promoted as superintendent BPS 17 on 31/05/2019. (Copy of service history as Annex: B)**
- 4. That vide letter No, 2915-87/F. No, A 23 / supdt: to B&AO / Promotion /2021 dated 07/01/2022 A.C.R s of last five years and other relevant papers were requisite from 28 superintendents the appellant submitted all the requirements document through District Education office Female Swat to Director Elementary and secondary Education K.P. Peshawar (Copy letter dated 7/1/2022 as Annex: C)**
- 5. That the L.P.R of the appellant was sanctioned on 14/01/2022, however the appellant got retired on 31/03/2022 (Copy of L.P.R. as Annex: D)**
- 6. That the appellant is senior on the basis of tentative and final seniority list and eligible for promotion to the post of Budget and Accounts officer BPS 17 but the Director Elementary and Secondary Education K.P. Peshawar has not recommended the appellant name for promotion to the post of Budget and Accounts officer BPS 17 to the Departmental selection committee. (Tentative seniority list , meeting approval are Annex: E& F)**
- 7. That per letter No, SO(PSB) ED/1 -25/2021 /KC dated Peshawar the 17/01/2022 where It is crystal clear that send the working papers In first week of March to so that the meeting be arranged. It is pertinent to mention here that in the letter ibid some instructions**

near future were also been given.

The relevant portion is as under.

“ Most Important” working papers of the officers who are at the verge of retirement and falling in the Promotion zone must be forwarded on priority basis.

ii. I am further directed to say that no working papers will be received after the mentioned cutoff date and that the Administrative department will be responsible for any delay in submission of working papers and the resultant deprivation consideration “ (Latter dated 17/01/2022 as Annex: G)

8. That Respondent No, 1 issued a circular dated 04/02/2022 to all District Education officers (Male and Female) in K.P. and the appellant all documents (promotion file) declared complete. (Letter dated 04/02/2022 as Annex: H)

9..That the Respondents No, 1 prepared the Working papers for D.P.C, but the appellant name not recommended nor process the appellant file for promotion, this act of the Respondent No,1 is against the rules and against the fundamental rights. (working papers minutes as Annex: I.)

10. That after the D.P.C committee the Secretary Elementary and Secondary Education K.P. issued the adjustment order of Budget and and Accounts officers BPS 17 dated 02/08/2022. Which is illegal under the law and rules. (Adjustment order as Annex: J)

11.Hence the appellant being aggrieved from the illegal and un lawfully act of Respondents Department.

12. The appellant submitted a departmental service appeal to appellate authority on 11/12/2023 but the appellate authority not decided the departmental service appeal in the prescribed period (90 days) (Departmental service appeal as Annex: K)

13. That the Respondent No, 1 issued the final seniority list of superintendents BPS 17 on 31/12/2012 but the appellant name is not Included intentionally, mala fide in the final seniority list superintendents BPS 17. It is pertained to be noted that date of issuing the final seniority list of the superintendents, the appellant was performed his duty as superintendent in the office of District Education officer Female Swat.(Final seniority list dated 31/12/2021asAnnex: L)

14..That the appellant was filed service a appeal No, 1680/2022 against the seniority . list before this Honorable Tribunal which was senedie on the request of appellant on 08/12/2023.

15.hat up till now the appellant has been deprived from the his legal right. Hence the appellant is going to the instant service appeal on the following grounds.

Grounds.

1.That the impugned orders/ notifications of Respondents departments are against the the law facts material available on record. Hence liable to be set aside.

2.That the appellant is well eligible and full filing the required requirements as well as eligible for criteria for pro forma promotion . It is pertinent to mention here that the appellant has completed his entire period of service

zeal and enthusiasm but erroneously deprived by from his legal right by the Respondents departments which is also against the law and Fundamental rights given by the constitution of Pakistan.

3. That the appellant has not been treated equally and in accordance with the law and rules.

4. *That not promoting the appellant for the Post of Budget and Accounts officer BPS 17 Respondents departments despite of having eligibility and Seniority is against the law, facts, illegal, un lawful un constitution and base on mala fide and norms of natural justice, hence need indulgence of this Honorable Tribunal.*

5. That the appellant has not been treated in accordance with the law and rules on the subject noted above and such Respondents departments violated the law and rules.

6. That the Respondents No, 1 in arbitrary and mala fide manner by not promoting the appellant for the post *ibid*.

7. That the despite of 42 years service of clean and neat service of the appellant, the appellant was ignored from the promotion which is not tenable under the law and the constitution of Pakistan.


8. *That the entire proceeding has been Conducted in derogation of law and rules.*


9. *That the impugned promotion order of Respondents departments are Whimsical, capricious and founded on surmises and conjectures.*

10. That the grounds not specifically raised with be argued with the prior permission of this Honorable Tribunal.

That therefore, very humbly prayed that on acceptance of this service appeal the all impugned orders/ notifications passed by Respondents departments may kindly be set aside and the appellant may kindly be promoted (on the basis of pro forma promotion) to the post of Budget and Accounts officers BPS 17 with all service back benefits .

Any other remedy which just appropriate and efficacious may also be awarded in favor of the appellant pleas.



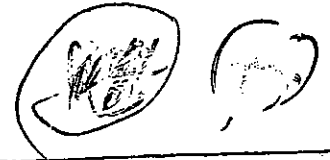


