

SERVICE APPEAL UNDER SECTION 4 OF THE K . P SERVICE TRIBUNAL ACT 1974 , AGAINST THE OFFICE ORDER, IMPUGNED No. SO (P/F)/E&SED/2-1/Transfer/Sarwat Bibi/2023, Dated , Pesh; the, 14TH NOVEMBER, 2023, PASSED BY THE RESPONDENT No.1, PRE MATURE , (with a shortest stay of 07 days) , EVEN DURING BAN, AGAINST THE MERIT & TRANSFER & SPOUSE POLICY, EXIST , FROM GOVT; GIRLS HIGHER SECONDARY SCHOOL JOWAR TO GOVT; GIRLS HIGH SCHOOL KUZA NAWAGAI BUNER, BEING HIS BLUE EYED, HAVING BY PASSED, THE BOTH COMPETENT AUTHORITIES / RESPONDENTS NO. 3 & 4, PURLY AGAINST THE MERIT AND POLICY ON MALA FIDE, BAD SORT OF BUREAUCRACY, POKING NOSE IN THE WAY OF OTHERS AS WELL, DESPITE THE FACT, THE APPELLANT HAS TAKEN OVER HER CHARGE AS STT B 16, ON EVE OF HER POSTING AT GGHS SHADAM AMAZAI, ON PRE ASSURANCE OF THE RESPONDENT No.4 THAT THE APPELLANT, WHO IS SENIOR AND HAVING OTHER MERIT WILL BE ADJUSTED IN GGHS KOZA NAWAGAI AS AND WHEN, THE EXPECTED SANCTION

OF UPGRADATION OF TT POST B 15 TO STT B 16, IS RECEIVED FROM THE GOVERNMENT.

Pray in Appeal

On acceptance of the instant appeal of the appellant, the order impugned dated, 14/11/2023, passed by the respondent No.1, BY GIVING THE NORMAL ROUTINE MATTER , EXTRA ORDINARY IMPORTANCE & EVEN DURING BAN , against the merit and transfer and spouse policies and pre mature , having , by passed, the respondents No. 3 & 4, even No. 4 normally, being competent authority, without any reasonable grounds or cause, just on mala fide intention with the appellant, to post and accommodate the respondent No.5, being his blue eyed, **after 07 days stay**, in her existing station /Govt; Girls Higher Secondary School **Jowar Buner**, may be set aside and be directed the respondent No.4, to transfer and post the appellant, on the same post of STT B-16, newly upgraded, in Govt; Girls High School Koza Nawagai Buner . further relief to which the appellant is otherwise entitle, under the law , though not specifically prayed for, in the instant service appeal, may also be granted.

Respectfully sheweth.

Facts

1. That the appellant is serving in the Education Department and she was appointed as TT B 15 and on 16/05/2014 , subsequently she was promoted as STT B 16 vide notification/order, dated, 28/10/2023. Copies of both, of 1st appointment order and promotion order are annexed for ready reference and perusal as "A & A-1".
2. That the appellant having got score 99.77 and the respondent No.5, had got score 98.32 , so the appellant is Senior and therefore the appellant has been placed at S.No.26 of the seniority list . Copy of the final seniority list of TTs & STTs for the calendar year 2023, is annexed as "B.
3. That before posting of the appellant as STT B 16, she has filed an application on dated 11/10/2023, to the respondent No.4,

vide Diary No.492, to that effect that the post of TT B 15 is lying vacant in GGHS Koza Nawagai, where, up on, the appellant, who is TT B 15 may be transferred and posted against the same post, because the appellant being Senior one and having her spouse as posted, here, at GHSS Jangai, was also, deserving according to spouse policy and other merit too. Consequently the respondent No.4, has assured the appellant for the said posting to be made later on. copy of the said application dated 11/10/2023 and transfer order of her spouse also is annexed as "C" & "C-1".

4. That subsequently after promotion of the appellant as STT B 16 was made, once again it was requested the respondent No.4 that as per in vogue and routine,(like the case of Miss Tawheed STT B 16, who was posted against the post of TT B 15, on anticipation to be upgraded, the said post as STT B 16, in GGHSS Shalbandai Buner) the appellant may be posted against the same vacant post of TT B 15 in GGHS Koza Nawagai, which is under process for sanction, already sought and would be upgraded as STT B 16. But despite the appellant was posted against the spouse policy and other merit, as STT B 16, in GGHSS Shadam with assurance, by the respondent No.4 that the appellant will be adjusted against the said post of STT B 16, after receiving the sanction awaited, being under process and the posting order was thus complied with and the appellant submitted her arrival at GGHSS shadam on dated 29/10/2023.
5. That after receiving the sanction of the up gradation of the GGHS Kuza Nawagai, awaited, Govt; had imposed ban on posting and transfer and the respondent No.4, could not therefore transfer or adjust the appellant and the matter was kept pending till the ban is left.
6. That meanwhile, the respondent No.5, who is junior and is non claimant of spouse policy and, wrongly, has by passing, the respondents No.3 & 4, who were/are competent for the said transfer but the respondent No.5,

could not get the same on her merit and by making undue direct approach to the respondent No.1 and by concealing of the same facts, as a result of suspected illegal give and take, got her pre mature transfer order impugned No. **SO (P/F)/E&SED/2-1/Transfer/Sarwat Bibi/2023, Dated , Pesh; the, 14TH NOVEMBER, 2023, even during ban,** passed by the respondent No.1, by giving the simple normal matter extra ordinary importance. Copy of the said order impugned, arrival and relieving report of private respondent No.5 is annexed as "D" & "D-1".

7. That the transfer order of the respondent No.5 , impugned is a pre mature and having been issued against the merit because she has taken over her charge on 08/11/2023 in GGHSS Jowar Buner and the transfer order impugned, issued by the respondent No.1, made from GGHSS Jowar Buner to GGHS Kuza Nawagai Buner is on dated 14/11/2023, the stay of the respondent NO. 5, makes hardly only 07 days while the stay of the appellant since taking over charge in GGHSS Shadam as on 29/10/2023 up till now is about 5 months . Copies of charge assumption /arrival report according to her posting order dated 28/10/2023 & relieving report are annexed "E" & "E-1".
8. That the appellant , then by noticing the order impugned dated 14/11/2023, has filed a departmental appeal to the respondent No.2 ,on dated 18/11/2023 , through proper channel which the respondent No.4, has forwarded vide her office memo No.4206 /estb; secy; dated,18/11/2023. Copies both of the departmental appeal and forwarding memo are annexed as "F" & "F-1".
9. That the respondent No.2 or any other respondent , has so far not responded, hence the appellant having no alternative adequate efficacious remedy, except, to file the instant Service Appeal on the following grounds amongst other inter alia.

GROUND

- a. That the order impugned No. **SO (P/F)/E&SED/2-1/Transfer/Sarwat Bibi/2023**, Dated , Pesh; the, **14TH NOVEMBER, 2023**, passed by the respondent No.1, is during ban , pre mature, she has taken over her charge on 08/11/2023 in GGHSS Jowar Buner and the transfer order impugned, issued by the respondent No.1, made from GGHSS Jowar Buner to GGHS Kuza Nawagai Buner, is on dated 14/11/2023, the stay of the private respondent NO. 5 makes hardly, only 07 days. Hence the same order impugned dated 14/11/2023 is not sustainable but is liable to set aside in favour of the appellant from the date of its issue.
- b. The matter was of no public importance or no public interest was involved there to be interfered the respondent No.1 being higher or appellate forum in the case of appellant and respondent No.5. so the order impugned is unwarranted and is clear unwarranted interference in the matter in part of respondent No.1 who has violated and violated unheard the legal right of the appellant for no reason or have shown any reasonability or without showing or knowing any fact so as to be moved in hurry in violation of natural law of justice..
- c. The the appellant has taken over her charge in Govt; Girls Higher Secondary School Shadam on dated, 29/10/2023 and the stay of the appellant being about 5 month is more than the private respondent No.5, which is 07 days and she is most deserving to be posted in GGHS Kuza Nawagai, instead of private respondent No.5.
- d. That the appellant, being senior than the private respondent No.5 and also having spouse performing his duty near the GGHS Kuza Nawagai Buner is entitle and most deserving to be posted in the said school while the private respondent No.5 is a single /unmarried and junior to the appellant . hence the transfer order impugned is against the merit in all respect and

is not tenable but is liable to be set aside in favour of the appellant.

- e. That the private respondent No.5 while getting passed her transfer has wrongly purposely bypassed the respondent No.4 or 2, who are competent to the transfer impugned . Hence the transfer order impugned dated 14/11/2023 is a result of concealment of facts from the authority /respondent No.1 or definitely might be a result of illegal give and take because the private respondent No.5 , could lawfully not processed her case for the transfer impugned on merit with a shortest stay of 07 days , without any merit . Hence the order impugned is liable to be set aside in favour of the appellant.
- f. That the order impugned dated 14/11/2023, is totally against transfer policy exist and under the spouse policy and also on merit , the appellant being senior has superior right to either be posted as TT B 15 before promotion of the appellant and upgradation of the post of TT to STT in GGHS Kuza Nawagai by the respondent No.4 or likewise Miss Tawheed STT B 16 GGHSS Shalbondai Buner , the appellant be posted after promotion as STT B 16 against the same post of inspite assuring the appellant . which prove the merit of the appellant otherwise for the said posting.
- g. That the respondent No.1, while passing the order impugned , **has erred by giving extra ordinary status to a normal routine matter instead referring the case to the respondent No.4 or No.3, which tantamount to poking nose in the way of other and is a bed sort of bureaucracy** . which does not favour law and is **also the awkward application of ones discretion** and should be discouraged by setting aside the order impugned, being discriminatory and undue favouritism.
- h. That the instant appeal is within time as the due date/deadline was a weekend/general consecutive holidays, hence being filed on next day.

- i. That further supporting legal and factual points would be raised at the time of arguments.

Therefore it is most humbly prayed that on acceptance of the instant service appeal, the relief sought in the prayer of portion/column of the instant appeal, may be granted in favour of the appellant against the respondent No.5, by setting aside the order impugned dated 14/11/2023, with direction to respondent No. 4 to post the appellant in Govt; Girls High School Kuza Nawagai against the STT B 16. Further relief to which the appellant is otherwise entitled under the law though not specifically prayed for may also be granted in favour of the appellant against the respondents.

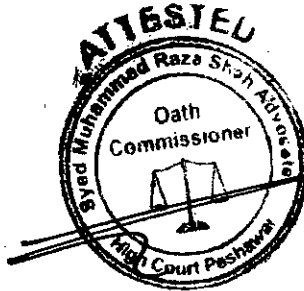

TERMS & CONDITION.

1. NO TA/DA etc is allowed.
2. Charge reports should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary & contract basis initially for one year.
4. They should not be handed over charge if her age exceeds 35 years or below 18 years of age.
5. Appointment is subject to the condition that the certificate/documents must be verified from the concerned authorities by the DEO Any one found producing bogus Certificates/Degrees will be reported to the law enforcing agencies for further action.
6. Her services are liable to termination on one month's notice from either side. In case of resignation without notice her one-month pay/allowances shall be forfeited to the Government.
7. Pay will not be drawn until and unless a certificate to the effect by DEO is issued that her certificates/Degrees are verified.
8. She should join her post within 10 days of the issuance of this notification. In case of failure to join their post within 10 days of the issuance of this notification, her appointment will expire automatically and no subsequent appeal etc shall be entertained.
9. Health and Age Certificate should be produced from the Medical Superintendent concerned before taking over charge.
10. Before handing over charge she will sign an agreement with the department, otherwise this order will not be valid.
11. She will be governed by such rules and regulations as may be issued from time to time by the Govt.
12. Her services shall be terminated at any time, in case her performance is found unsatisfactory during her contract period. In case of misconduct, She will be proceeded under the rules framed from time to time.

Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants, Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer, of teachers, Lectures, and Instructors & Doctors) Regulatory Act, 2011, and such rules & regulation as may be issued from time to time by the Government.

8. The seniority inter-se of the employees, whose services are regularized under this Act within the same service or cadre, shall be determined on the basis of their merit position in such service or cadre.
9. Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one.
