

APPEAL UNDER SECTION 4 OF THE KPK SERVICES TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED ORDER DATED 19/09/2023 ISSUED BY RESPONDENT NO.3, WHEREBY THE NAME OF APPELLANT WAS WITHDRAWN FROM THE AGENDA ITEM NO: 32 WITHOUT ANY LAWFUL JUSTIFICATION AND REASONS AND AGAINST THE OMISSION ON THE PART OF RESPONDENT NO. 1 FOR INDICISION OF THE DEPARTMENTAL APPEAL WHICH IS AGAINST THE LAW AND IN VIOLATION OF SERVICES LAWS AND RULES AND THE APPELLANT WAS CONDEMNED UNHEARD WITH MALAFIDES.

Note: Addresses given above shall suffice the object of service. All necessary and proper parties have been arrayed in the panel of respondents.

respondents but unfortunately the respondents has not granted the benefits to the appellant in the service period, therefore, instant appeal is filed for proforma promotion with all back benefits. Copy of final seniority list dated: 31.07.2023 is enclosed **Annexure-G**.

7. That Feeling aggrieved from the impugned order dated: 19.09.2023, the appellant preferred departmental appeal to respondent No.1 being appellate authority on 24.11.2023.
8. That up-till now no response has been shown from the respondents and ultimately the departmental appeal of the appellant was no decided by the respondent No. 1, hence, instant service appeal.
9. That jurisdiction of this worthy service tribunal is being invoked in attending circumstances against the impugned order dated: 19.09.2023, inter alia on the following grounds amongst others;

GROUNDS

- a. That the impugned order dated: 19.09.2023 and indecision of appellant's departmental appeal is illegal, against services Law and rules, without jurisdiction, in violation of the precedents of Honourable apex courts of the country and is not justifiable for any reason whatsoever.
- b. That appellant was legally entitled to be promoted against the vacant post of Principal / Vice Principal (BPS-18) but official respondents are reluctant to grant promotion to the appellant without any lawful justification. It is pertinent to mention here that the batch mate of the appellant was awarded promotion before his retirement but in the case of appellant special P.S.B was not convened by the official respondents which show their malafide and discriminatory attitude among the employees. Therefore, act of respondent's amounts to injustice with appellant and non awarding promotion to the appellant is against the Law. *file*
- c. That reasons mentioned in impugned order is baseless and P.S.B withdrawal order was issued without adopting any Codal formalities and without any giving personal hearing to the appellant. Hence, the appellant was condemned unheard.
- d. That in this regard at a number of occasions, it has been held by Supreme Court that when there was clear vacancy in BPS-18 available before the retirement of the appellant, the department was

bound to finalize the issue of promotion as expeditiously as possible or at least prior to the retirement to the appellant, where the appellant had served for more than 30 years, and he by all means was entitled to promotion specially the other colleague of the appellant were promoted through circulated promotion.

(2022 SCMR 1546 & 1765)

- e. That the P.S.B withdraw the agenda item No: 32 without any legal justification and without mentioning any cogent reason, depriving the appellant from his legal and fundamental rights. The appellant was entitle for promotion to the post of Principal / Vice Principal BPS-18 from the date of entitlement as one colleague of the appellant was granted the same benefit through circulated promotion, therefore, the identical treatment must be given to appellant.
- f. That appellant being citizen of Pakistan deserves to be dealt in accordance with law and the treatment meted out to him is in violation of Article 4 of our Constitution.

PRAYER


On acceptance of this appeal, the decision of Provincial Selection Board (P.S.B) to the extent to the order dated: 19.09.2023 agenda item No: 32 and withdrawal of the same, for no reasons, may kindly be declared as illegal, Unjustified, without lawful authority, discriminatory & wrongfully depriving the appellant from due promotion. The respondents may kindly be directed to promote the appellant to the post of Principal/Vice Principal BPS-18 being entitled for the proforma promotion from the date of his entitlement with all back benefits.






Respectfully Sheweth:-
