

Respectfully Sheweth:

Brief facts

1. Appellant was appointed as P.T.C un-trained on 11-10-1989 and later on after passing the examination appointed for the post of P.T.C in BPS-9 on 25-5-1995 as regular appointment. Copy of service book is enclosed as **Annexure A.**
2. That the promotion order in respect of P.S.T's was prepared in 2012 and P.S.T's were promoted to BPS-14 & BPS-15 but name of the appellant was not included in the said list on pretext that service book of the appellant was missing from office record of the department. Copy of promotion order is enclosed as **Annexure B.**
3. The appellant earlier submitted various applications for the consideration of his case for promotion but no order was passed. Copies of the applications are enclosed as **Annexure C.**
4. That the misplaced service book of the appellant was traced out from the office record in year 2017 then appellant once again submitted applications for the promotion but no action has been taken by the department. Copy of the applications are enclosed as **Annexure D.**


5. That the appellant submitted departmental representation to the Respondent but Respondent paid no attention. Copy of representation along with courier service receipts are enclosed as **Annexure E and E-1.**
6. That as per legal requirements, the appellant has been left with no other option but to agitate his grievances before this Honorable Tribunal inter alia on the following grounds:

Grounds:


1. Appellant was inducted into service as P.S.T on regular basis in PBS-9 on 25-5-1995 and is entitled for promotion to BPS-15 P.S.H.T under the rules.
2. That other employees having appointments in year 1995 have been promoted to BPS-15 as well as employees appointed much later to the appellant have also been promoted but appellant has been deprived of his lawful rights.
3. That maintaining the office record is the job of department and appellant cannot be deprived of his lawful rights on the pretext that his service book was misplaced in the office.
4. That appellant was avoided PBS-12 on dated 1-12-2007 and on 1-7-2015 appellant was granted on step upgradation to PBS-13 and is still serving in PBS-13 but as per law and rules appellant is entitled for the grant of BPS-15 since 2013. But he has been deprived of his rights illegally and unlawfully.
5. That despite receiving applications department neither allowed nor refuse the said applications and appellant has not been promoted to B.P.S-15.

In view of the above mentioned facts and grounds it is most humbly prayed that the instant appeal may kindly be accepted and Respondent may kindly be directed to include the name of appellant in the promotion order of P.S.T's dated: 4-03-2013 and to grant promotion to BPS 15 as admissible under the rules with all back benefits w.e.f 4-03-2013/ any other remedy deemed appropriate in the given circumstances may also be granted.
