#### Respectfully Sheweth:

- 1) That appellant is the resident of village Hayatai Tehsil
  Utman Khel District Bajaur.
- That appellant was initially appointed as Sipahi in Bajaur levies on 16/08/1979. As two National Identity Cards i.e. one with the Name of Bakht Munir bearing No#21107-1710718-3 and another with the name Alam Khan bearing No#21107-1710761-7 were issued to the appellant from Nadra officials in which CNIC with the name Alam Khan bear true and correct name of the appellant. (Copy of service record is annexure A and Copies of CNIC'S are annexure B and C respectively)

- appointment entered Bakht Munir in the service record of the appellant and after completion of service period, get retired from service on 16/08/1997 and abovementioned name was also entered is the pension book of the appellant which need to be corrected. (Copies of pension Book is attached as Annexure D)
- A) That in the other official record i.e. academic record, Nadra Records, Election commission record the appellant name is entered as Alam Khan that is the actual and correct one as well as in the records of the appellants sons, thus Appellant cancelled the incorrect CNIC with the name Bakht Munir as per Nadra Policy and retained the one with his true and correct name i.e. Alam Khan. (All relevant documents are attached as annexure E)
- That after retirement from service appellant regularly receiving his pension from the concerned office till 10/01/2019 but when appellant retained his correct CNIC as per rules opening of account in Bank stood mandatory for pensioners for receiving their pension. Thus, when appellant contacted the Bank official, they refused to open an account on the name of Alam Khan rather they stressed that account will be opened on the basis of pension book and service record wherein incorrect name of the appellant was entered.
- 6) That the appellant then filed civil suit for correction of his name etc. in the service Book and pension Book,

appellant suit was rejected on the ground of jurisdiction and appellant put on liberty to approach proper forum for redressal of his grievances, thus appellant approaching this office as per law. (copies are attached as Annexure F)

- 7) That as per law and direction of the Additional District Judge ii Bajaur the appellant filed departmental representation in the office of Deputy Inspector General Malakand at Saidu Sharif Swat, which was received by the office vide diary No# District Bajaur No:409 /E Dated:09/01/2024.(Copy is attached as Annexure G)
- 8) That the office of the Regional Police Officer Malakand filed dismissed said departmental appeal/-Representation of the appellant vide of office order No:2579 / E Dated:23/02/2024. (Copy is attached as Annexure H)

#### **GROUNDS:**

- i. That the action, inaction and denial of respondents to pay the pension to the appellant, is illegal, unlawful and against the fundamental rights of appellant.
- ii. That the appellant was a permanent servant of Bajaur levies and retired from there after completion of eighteen years' service and was regularly receiving his pension till 10/01/2019

which was inadvertently stopped due to the above-mentioned reason.

- iii. That it was confirmed by the Nadra Official that Alam Khan and Bakht Munir is the one and same person to whom two CNIC were issued and later on one with the name Bakht Munir was cancelled as per Nadra Policy.
- iv. That other colleagues of the same department who stood appointed with the appellant are also supporting stance of the appellant that he is the same and one person who was appointed in the same department and later on retired from service. Moreover no one else claimed Alam Khan as his name and retired from Bajaur levies.
- v. That the appellant was a retired servant and there is no possibility of availing any other government job and being a retired servant, receiving of pension is the due right of the appellant protected by law.
- vi. That respondents are not authorized to deny pension of the appellant.
- vii. Any other grounds not specifically raised will be argued with prior permission of this August Court.

9) That appellant has filed departmental appeal/representation on 09/01/20224 which stand dismissed on 23/02/2024 while copy received to the appellant on 28/02/2024, hence the instant appeal is filed today, which is well within time.

It is therefore humbly prayed that, on acceptance of this appeal, the respondent be directed to correct the name of the appellant from Bakht Munir to Alam Khan (as his true, actual, and correct name) in the service record i.e. pension book of the appellant and also order may be announced for release of pension from 10/01/2019 till onward.

Any other relief which is otherwise deemed proper, lawful, efficacious may also be granted in favor of appellant.

### JUDGMENT 22.09.2023

This appeal has been preferred against the judgment dated 07.12.2022, of the learned Civil Judge-I *Bajaur*, whereby suit of the appellant was returned due to lack of jurisdiction.

Briefly, stated facts are that, the plaintiff/appellant filed civil suit No 93/1 of 2020 for correction of his name and date of birth. The suit was contested by the defendants. Initially the suit was decreed but this court set aside the decree with direction to the trial court to record

evidence in respect of the claim of defendant No.03.

- The learned trial court then fixed the case for arguments on the point of jurisdiction.
- After hearing arguments of learned counsel for the parties, returned the suit vide his judgment dated 07.12.2022.
  - Feeling aggrieved from the order of the learned. Civil Judge-I, *Bajaur* the appellant has preferred the instant appeal on the ground that the learned trial court has passed the impugned order without considering the available record and without understanding the provision of law and rules.

Mr. Haya Khan Advocate the learned counsel for appellant argued that the learned trial court while passing the impugned judgment has not applied the law properly. He argued that the correction in the name and date of birth is the jurisdiction of civil court and service tribunal has no

powers to correct the same. He further submitted that the appellant has received the pension since 1997 but no objection was raised by the defendant No.03. He further submitted that the appellant is a retired employee and he cannot approach service tribunal. He therefore, requested that on acceptance of this appeal the order of the learned trial court dated. 07.12.2022 be set aside.

District attorney for the respondent argued that the respondent has concealed the material facts from the court and he want to replace Bakht Munir, who was their retired employee. He argued that the appellant want correction in CNIC in the garb of which he want to replace another retired employee. He further submitted that the matter is falling in terms and condition of the service and as such civil court has no jurisdiction to entertain the suit. He therefore, requested that the appeal be dismissed.

From the arguments of the learned counsel of the parties and perusal of record it transpires that the plaintiff has prayed for correction of his name and date of birth in the service record i.e. pension book, wherein according to him his name and date of birth has been mentioned wrongly. Prima facie the case of the plaintiff/ appellant is pertaining to the terms and conditions of service because he seeks correction of name and date of birth in the service record i.e. pension book. The appellant alleges that he is retired employee and as such he was required to have corrected his name and date of birth within a reasonable time after his appointment if he was not able to correct the same within two years from his appointment.



Petitioner submitted as under:

- 1) That petitioner is the resident of village Hayatai Tehsil Utman Khel District Bajaur.
- That petitioner was initially appointed as Sipahi in Bajaur levies on 2) ... 16/08/1979. As two National Identity Cards i.e one with the Name of Bakht Munir bearing No#119-59-156941 and another with the name Alam Khan bearing No#119-58-012649 were issued to the petitioner from Nadra officials in which CNIC with the name Alam Khan bear true and correct name of the petitioner.
  - That the concerned official during the initial appointment entered Bakht Munir in the service record of the petitioner and after completion of service period, get retired from service on 16/08/1997 and above mentioned name was also entered is the pension book of the petitioner which need to be corrected.
