In response, Finance Department created 25 posts and directed this Department via letter No.SO(B&A)/FD/MAS/4-1/SNE/2021 dated 18th, October 2022 (Annex-II) that the basic pay scale of the appellant and one Cameraman are exist in the current side in basic pay scale 11 and 14 respectively, therefore the posts mentioned may be reviewed. The Scrutiny Committee of this Department in its meeting held on 07th December, 2023 (Annex-III), recommended afresh posts of Script Writer (BPS-16) to resolve the salary issue of the appellant.


REPLY ON GROUNDS

A meeting of the Scrutiny Committee to review the regularization issue of the two left-over posts of the project titled 'Establishment of PMU for Operationalization of Five FM Radio Stations in Merged Areas' under the "Khyber Pakhtunkhwa (Regularization of Services of Employees of Erstwhile Federally Administrated Tribal Areas) Act, 2021, was held under the chairmanship of Secretary Information & Public Relations Department on December 07, 2023 at 1300 hours:-

The meeting started with recitation from the Holy Quran.

The Chair welcomed the participants and threw light on the aims and objectives of the meeting. The forum was briefed that 32 employees of various categories had been serving in the afore-mentioned project. However, after the commencement of the ibid Act, the Finance Department, Govt. of Khyber Pakhtunkhwa vide letters No. SO (B&A)/FD/MAS/4-1/SNE/2021 dated 18-10-2022 and No. BO(NMD-III)/FD/MAS/4-1/SNE/2022 dated 09-06-2023 created as many as 25 posts and 5 posts respectively for the project employees on the regular, side leaving the creation of the posts for Cameraman (BPS-16) and Script Writer (BPS-16) with the observation that the said posts already existed on the regular side in basic scale 14 and 11 respectively and may be reviewed by the Scrutiny Committee accordingly.

- The forum was apprised that the post of Script Writer (BPS-16) no where existed on the regular side as misconceived by the Finance Department. Basically the post of Article Writer is in Basic Pay Scale 11, which exists on the regular side and has job description different from the Script Writer (BPS-16). As for the post of Cameraman although the post exists in Basic Pay Scale 14 on the regular side, however, downgrading the incumbent official, who has already been performing his duties for the last one year upto the satisfaction of the high-ups without receiving any stipend, would result in litigation thereby further delaying the process of creation of these posts. The post of Senior Cameraman already existed on the regular side in Basic Pay Scale 16.
- 4. It was further pointed out that the posts for Personal Assistant (BPS-16) and Accountant (BPS-16), which too never existed on the regular side in the DGIPR/subordinate offices, had been newly created by the Finance Department in light of the ibid Act. Therefore, there is no harm in creating the posts of Script Writer and Senior Cameraman in Basic Pay Scales 16 afresh and this is imperative to avoid litigation. After due deliberations, it was concluded that the creation of these posts will neither raise the issue of litigation nor seniority. Furthermore, draft service rules have also been prepared for the Script Writer.
- It was also observed that the Basic Pay Scales of these posts have been adopted from the PC-I as prepared by the Federal Government before the merger of Tribal Districts into Khyber Pakhtunkhwa. As per the "Regularization of services of Employees of ERSTWHILE Federally Administered Tribal Areas (FATA) Act 2021", Section 3, Subsection (1), "Notwithstanding anything contained in any law or rules, the employees, appointed on contract basis, against project posts, in the erstwhile FATA, and holding such project posts till the commencement of this act, shall be deemed to have been validly appointed on regular basis, from the commencement of this act, subject to verification of their qualifications and other credentials by the concerned departments." It was informed that the employees on the posts of Script Writer and Cameraman have the required qualifications to be validly appointed on regular basis.
- The Scrutiny Committee after thorough deliberations recommended that the creations of the two (02) leftover posts is in the continuation of the "Khyber Pakhtunkhwa (Regularization of services of Employees of ERSTWHILE Federally Administered Tribal Areas) Act 2021", and subsequent letter of the Finance Department, No. SO(B&A)/FD/MAS/4-1/SNE/2021 dated 18.1072022. The following proposals are hereby

recommended to resolve the regularization issue of the two (02) left-over employees of the project 'Establishment of PMU for Operationalization of Five FM Radio Stations in Merged Areas' in compliance with the ibid Act:

- i. The post of Script Writer (BS-16) may be created afresh on the analogy of Personal Assistant (BPS-16) and Accountant (BPS-16) as already created by the Finance Department vide letter No. SO (B&A)/FD/MAS/4-1/SNE/2021 dated 18410-2022 on the regular side under the ibid Act.
- ii. Instead of the post of Cameraman (BPS-14), the post of Senior Cameraman (BS-16) may be created on the regular side to address the issue of the incumbent employee.
