

PRAYER:-

On acceptance of this appeal the impugned Order dated 13-03-2024 and Letter dated 27-06-2023 whereby Adverse Remarks/entries in the ACR of the appellant for the period from 01-01-2021 to 31-12-2021 were communicated to the appellant, may kindly

be set aside and the adverse remarks recorded in the ACR of the appellant for the period from 01-01-2021 to 31-12-2021 may kindly be expunged.

Respectfully Submitted:-

1. That the appellant was appointed as ASI on 28-03-2009 and was confirmed as ASI on 17-03-2012. The appellant qualified various courses including Lower School Course, Intermediate Course and Upper College Course and since appointment the appellant has performed his duties with honesty and full devotion and to the entire satisfaction of his high ups. **(Copy of Order dated 28-03-2009, Extract from Service Book & Certificates are enclosed as Annexure A, B & C).**
2. That the appellant was promoted as Officiating Sub Inspector vide Notification dated 30-06-2014 and was confirmed as Sub Inspector vide Letter/Order dated 11-06-2018 and his name was brought on Promotion List "F" on 11-01-2019 and his confirmation as Sub inspector was also revised w.e.f. 02-06-2016 instead of 11-06-2018, as evident from the Seniority List of Sub Inspectors on List "F" for the year 2023. **(Copy of Notification dated 30-06-2014, Letter dated 11-06-2018 & Seniority List of 2023 is enclosed as Annexure D, E & F).**
3. That the appellant is having Excellent ACR,s and is also having excellent performance during his entire

service more particularly during the year 2021 which is evident from his Performance reports.

4. That to the utter surprise and for reasons other than fair and bonafide the appellant was communicated adverse remarks/entries in the ACR for the period from 01-01-2021 to 31-12-2021 vide Letter dated 27-06-2023 **(Copy of Letter dated 27-06-2023 is enclosed as Annexure G).**
5. That the appellant preferred departmental appeal before respondent No 1 which was rejected vide Order dated 13-03-2024. **(Copy of Departmental Appeal & Order dated 13-03-2024 is enclosed as Annexure H & I).**
6. That the impugned Order dated 13-03-2024 & Letter dated 27-06-2023 are against the law, facts and principles of justice on grounds inter alia as follows:-

GROUND S:-

- A. That the impugned Order dated 13-03-2024 & Letter dated 27-06-2023 are illegal, unlawful, without lawful authority and void ab-initio.
- B. That mandatory provisions of law and rules have badly been violated by the respondents and the appellant has not been treated according to law

and rules being his fundamental right as per Article 4 and 25 of the Constitution and law of the land.

- C. That the adverse remarks are vague and not specific hence not tenable in the eyes of law.
- D. That the appellant has been reported as "C" and not honest and that he does not possess the qualities of a good police officer and that he was involved in illegal detention of an innocent citizen and the countersigning officer has also agreed while the fact is that the allegations are without any substance, as no material is there in support of any allegations, thus too the same are liable to be expunged.
- E. That the appellant during the year 2021 was transferred and posted five times and as such even the period of each posting being less, the performance as such cannot be assessed properly.
- F. That the impugned adverse remarks/entries recorded in the ACR of the appellant for the period 01-01-2021 to 31-12-2021 are not tenable as the same have been communicated after more than one and half year in violation of the Instructions and Police Rules on the subject.

- G.** That no Warning, Counseling etc as required under the instructions on PER/ACR were made before the communication of such remarks and the same as such too are liable to be expunged.
- H.** That the appellant was never provided opportunity of defense, improving and hearing in violation of the instructions on the subject and principles of natural justice.
- I.** That the charges were never established nor was any material collected against the appellant warranting adverse entries.
- J.** That the appellant have always earned excellent ACR,s during his entire service career and his performance during the alleged period is outstanding and performed his duties to the best of his abilities and potential.
- K.** That the appellant has about 15 years of service with unblemished service record.
- L.** That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.

Any other relief deemed appropriate and not specifically asked for, may also be granted in favor of the appellant.
