**APPEAL UNDER SECTION 4 OF THE KHYBER
PAKHTUNKHWA SERVICE TRIBUNAL ACT 1974
AGAINST THE LETTER DATED 20-06-2023
WHEREBY ADVERSE REMARKS WERE
COMMUNICATED TO THE APPELLANT IN HIS
ACR FOR THE PERIOD FROM 01-01-2022 TO 19-
07-2022, AND AGAINST WHICH DEPARTMENTAL
APPEAL OF THE APPELLANT HAS NOT BEEN
RESPONDED SO FAR DESPITE THE LAPSE OF
MORE THAN THE STATUTORY PERIOD OF
NINETY DAYS.**

PRAYER:-

On acceptance of this appeal the impugned Letter/Order dated 20-06-2023 whereby Adverse Remarks/entries in the ACR of the appellant for the period from 01-01-2022 to 19-07-2022 were communicated to the appellant, may kindly be set aside and the adverse remarks recorded in the ACR of the appellant for the period from 01-01-2022 to 19-07-2022 may kindly be expunged.

Respectfully Submitted:-

1. That the appellant was initially enlisted as Constable in District Police Kohistan on 24-09-1987 and was then transferred to District Police Mardan in the year 1999. The appellant was promoted as Head Constable where after he was promoted as ASI and was confirmed as ASI on 16-04-2010. The appellant was promoted as Officiating Sub Inspector vide Notification dated 10-07-2015 and since enlistment the appellant has performed his duties with honesty and full devotion and to the entire satisfaction of his high ups. **(Copy of Notification dated 10-07-2015 is enclosed as Annexure A).**
2. That the appellant is having Excellent ACR,s and is also having excellent performance during his entire service more particularly during the year 2021-2022 which is evident from his Performance reports. **(Copies of ACR,s & Performance Reports are enclosed as Annexure B & C).**
3. That to the utter surprise and for reasons other than fair and bonafide the appellant was communicated adverse remarks/entries in the ACR for the period from 18-06-2021 to 31-12-2021 vide Letter dated 08-06-2023 and subsequently was communicated adverse remarks/entries in the ACR for the period from 01-01-2022 to 19-07-2022 vide Letter dated 20-06-2023. **(Copy of Letter dated 08-06-2023 & Letter dated 20-06-2023 are enclosed as Annexure D & E).**

4. That the appellant preferred departmental appeal before respondent No 1 on 28-06-2023 which has not been responded so far despite the lapse of more than the statutory period of ninety days. **(Copy of Departmental Appeal is enclosed as Annexure F).**
5. That the impugned Letter/Order dated 20-06-2023 whereby adverse remarks have been communicated to the appellant for the period from 01-01-2022 to 19-07-2022 is against the law, facts and principles of justice on grounds inter-alia as follows:-

GROUND S:-

- A. That the impugned Letter/Order dated 20-06-2023 whereby adverse remarks have been communicated to the appellant for the period from 01-01-2022 to 19-07-2022 is illegal, unlawful, without lawful authority and void ab-initio.
- B. That mandatory provisions of law and rules have badly been violated by the respondents and the appellant has not been treated according to law and rules being his fundamental right as per Article 4 and 25 of the Constitution and law of the land.
- C. That the adverse remarks are vague and not specific hence not tenable in the eyes of law which is the ditto copy of Letter dated 08-06-2023.
- D. That the appellant has been reported as "C" and not honest and the countersigning officer has also

agreed with remarks that he was warned to mend his ways while the fact is that the allegations are without any substance, as no material is there in support of any allegations, thus too the same are liable to be expunged.

- E.** That the impugned adverse remarks/entries recorded in the ACR of the appellant for the period 01-01-2022 to 19-07-2022 are not tenable as the same have been communicated after almost one year in violation of the Instructions and Police Rules on the subject.
- F.** That no Warning, Counseling etc as required under the instructions on PER/ACR were made before the communication of such remarks and the same as such too are liable to be expunged.
- G.** That the appellant was never provided opportunity of defense, improving and hearing in violation of the instructions on the subject and principles of natural justice.
- H.** That the charges were never established nor was any material collected against the appellant warranting adverse entries.
- I.** That the appellant have always earned excellent ACR,s during his entire service career and his performance during the alleged period is outstanding and performed his duties to the best of his abilities and potential.

- J. That the appellant has about 37 years of service with unblemished service record.
- K. That the appellant seeks the permission of this honorable tribunal for further/additional grounds at the time of arguments.

It is therefore prayed that appeal of the appellant may kindly be accepted as prayed for in the heading of the appeal.

Any other relief deemed appropriate and not specifically asked for, may also be granted in favor of the appellant.
