APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNALS ACT, 1974 AGAINST THE ORDER DATED 15.12.2023, WHEREBY MAJOR PUNISHMENT OF REMOVAL FROM SERVICE WAS IMPOSED UPON THE APPELLANT AND AGAINST THE ORDER DATED 26.03.2024, WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT WAS REJECTED FOR NO GOOD **GROUNDS.**

PRAYER:

THAT ON THE ACCEPTANCE OF THIS APPEAL, THE ORDER DATED 15.12.2023 AND 26.03.2024 MAY KINDLY BE SET ASIDE AND THE APPELLANT MAY BE REINSTATED INTO HIS SERVICE WITH ALL BACK AND CONSEQUENTIAL **BENEFITS.** ANY OTHER REMEDY, WHICH THIS HONORABLE TRIBUNAL DEEMS FIT AND APPROPRIATE THAT, MAY ALSO. BE AWARDED IN **FAVOUR** OF APPELLANT.

RESPECTFULLY SHEWETH:

FACTS:

- 1. That the appellant was working in the respondent department as Constable and has performed his duty with great devotion and honesty, whatsoever assigned to him and no complaint has been filed against him regarding his performing.
- That the appellant while posted at PS East Cantt Peshawar, charge 2. sheet along with statement of allegations were issued to the appellant along with two other officials namely ASI Nazar Gul and Constable Azeem No.5256 in which following allegations were leveled against ASI Nazar Gul and Constable Azeem No.5256 that it has been learnt through reliable source that during the confinement period ASI Nazar Gul and constable Azeem No.5256 contacted the brother of the accused Yasir and demand 01 lac rupees and 02 09 MM pistols of which after mutual bargaining the brother confined accused handed over two 9MM (local made) Pistols to ASI Nazar Gul Khan and Constable Azeem, however, no allegation was leveled against the appellant in the charge sheet and statement of allegations issued to the appellant. The appellant submitted his reply to the charge sheet in which he mentioned that he was on duty in the Police Station East Cantt Peshawar and accused namely Yasir who was re-arrested by the surveillance and confined along with other persons at Police Station East Cantt Peshawar requested the appellant to contact his family to inform them that he is PS East Cantt as they would be worried for him on which the appellant contacted his father namely Shakil, however, the father of Yasir told the appellant that he has knowledge that the Yasir in the Police station Cantt and the appellant clearly mentioned in his reply that he has no ulterior motive for contact and inform the family about Yasir. (Copies of charge sheet along with the statement of allegations and reply are attached as Annexure-A&B)
- 3. That inquiry was conducted against the appellant in which no proper opportunity of defense was provided to the appellant as neither statements were recorded in the presence of the appellant nor gave him opportunity of cross examination, even the inquiry report is not provided to the appellant and as the inquiry report was not provided to the appellant therefore, he filed an application for provision of inquiry report, however, inquiry report was not provided to him

which may be requisite from the department. (Copy of application is attached as Annexure-C)

- 4. That without any allegation, the appellant was removed from service vide order dated 15.12.2023 without issuing show cause notice to the appellant. The appellant filed departmental on 22.12.2023 against dismissal order dated 15.12.2023, which was rejected on 26.03.2024 for no good grounds. (Copies of removal order dated 15.12.2023, departmental appeal and order dated 26.03.2024 are attached as Annexure-D,E&F)
- 5. That the appellant wants to file the instant appeal in this Honorable Tribunal for redressal of his grievance on the following grounds amongst others.

GROUNDS:

- A) That the impugned orders dated 15.12.2023 and 26.03.2024 are against the law, facts, norms of justice and material on record, therefore, not tenable and liable to be set aside.
- B) That no allegation was leveled against the appellant in the charge sheet and statement of allegations, but despite that the appellant was removed from service vide order dated 15.12.2023, which is against the norms of justice and fair play
- C) That although no allegation was leveled against the appellant but despite that inquiry was conducted against the appellant in which no opportunity of defense was provided to the appellant as neither statements were recorded in the presence of the appellant nor gave him opportunity of cross examination, which is violation of law and rules and such the impugned orders are liable to be set aside.
- D) That allegations were leveled against the ASI Nazar Gul and constable Azeem No.5256 in the statement of allegations that during the confinement period ASI Nazar Gul and constable Azeem No.5256 contacted the brother of the accused Yasir and demand 01 lac Rupees and 02 09 MM pistols of which after mutual bargaining the brother confined accused handed over two 9MM (local made) Pistols to ASI Nazar Gul Khan and Constable Azeem without mentioning the name of the appellant in that statement of allegations,

but he was also removed from service along with ASI Nazar Gul and Constable Azeem in the order dated 15.12.2023 without specification of charges, which is against the norms of justice and fair play and as such the impugned orders are liable to be set aside on this ground alone.

- E) That when no allegation was leveled against the appellant then on which ground the appellant was departmentally proceeded by the inquiry officer?
- F) That when no allegation was leveled against the appellant then on which ground the appellant and was removed from service by the respondent department?
- G) That the appellant mentioned in his reply to charge sheet that Yasir who was re-arrested by the surveillance and confined along with other persons at Police Station East Cantt Peshawar requested the appellant to contact his family to inform them that he is PS East Cantt as they were worried for him on which the appellant contacted his father namely Shakil, however, the father of Yasir told the appellant that he has knowledge that the Yasir in the Police station Cantt and the appellant clearly mentioned in his reply that he has no ulterior motive for contact and inform the family about Yasir, but without observing his reply to charge sheet, the appellant was removed from service, which is against the norms of justice and fair play.
- H) That in statement of allegations it was mentioned that during the confinement period ASI Nazar Gul and constable Azeem No.5256 contacted the brother of the accused Yasir and demand 01 lac Rupees and 02 09 MM pistols of which after mutual bargaining the brother confined accused handed over two 9MM (local made) Pistols to ASI Nazar Gul Khan and Constable Azeem, but in impugned removal order dated 15.12.2023 and rejection order dated 26.03.2024, the name of the appellant was inserted along with the ASI Nazar Gul and Constable Azeem without knowing the realty by the authorities that the charges were not leveled against the appellant in the statement of allegations and if the allegations were not leveled against the appellant and proved through proper and regular inquiry then on which ground his name was inserted in the impugned order dated 15.12.2023 and 26.03.2024 and was punished, which means that the appellant has been punished for no fault on his part.

- I) That show cause notice was not issued to the appellant before passing the impugned removal order which is against the natural justice and fair play.
- J) That the appellant has not been treated in accordance with law and has been punished in violation of law and rules.
- K) That the appellant seeks permission of this Honorable Tribunal to advance others grounds and proofs at the time of hearing.

It is, therefore most humbly prayed that on the acceptance of this appeal, the order dated 15.12.2023 and 26.03.2024 may kindly be set aside and the appellant may be reinstated into his service with all back and consequential benefits. Any other remedy, which this honorable tribunal deems fit and appropriate that, may also, be awarded in favour of appellant.

Under Police Rules 1975 (amended 2014) proper charge st eet alongwith summary of allegation were issued against them and ASP Havatabad was appointed as Enquiry Officer, who submitted his finding, wherein he concluded that the allegations against delinquent officials have been proved and they stand guilty of the charges and agree with the preliminary enquiry. The E.O further recommended them for major punishment.

3. Having gone through the enquiry file and other relevant record, the undersigned is fully satisfied that the delinquent officials have committed a gross misconduct, which is proved beyond any shadow of doubt. Thus, they brought bad name to the police department. <u>ORDER.</u>

This order will dispose of the departmental appeal preferred by Ex-Constable Noor-ul-Basar No. 6070, who was awarded the major punishment of "dismissal from service" under KP PR-1975 (amended 2014) by SSP/Operations, Peshawar vide order No. 2106-11/PA, dated 15.12.2023.

2- Brief facts leading to the instant appeal are that the defaulter Constable was proceeded against departmentally on the charges that in light of the directions, the accused namely Yasir Khan s/o Shakeel r/o Masho Khel Badaber, Peshawar was arrested by the surveillance team and was confined at PS East Cantt: till further orders. During the confinement period, the defaulter Constable contacted brother of the accused namely Yasir and demanded 01 Lac Rupees and two 09-MM (Local made) Pistols. After mutual bargaining, brother of the accused i.e. Yasir, handed over two 09-MM (Local made) Pistols to ASI Nazar Gul and Constable Azeem.

3- He was issued Charge Sheet and Summary of Allegations by SSP/Operations, Peshawar ASP/Hayatabad, Peshawar was appointed as Enquiry Officer to scrutinize the conduct of the accused official. The Enquiry Officer after conducting departmental enquiry submitted his findings in which he was recommended for major punishment. The competent authority in light of the findings of the Enquiry Officer awarded him the major punishment of dismissal from service.

4- He was heard in person in Orderly Room. During personal hearing, he was given an opportunity to prove his innocence. However, he failed to submit any plausible explanation in his defense. Therefore, his appeal for setting aside the punishment awarded to him by SSP/Operations, Peshawar vide order No. 2106-11/PA, dated 15.12/2023, is hereby rejected/filed.
