SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974, AGAINST THE IMPUGNED NOTIFICATION DATED 23/02/2024, WHEREBY THE APPELLANT HAS BEEN DEMOTED/REVERTED TO THE POST OF ARABIC TEACHER AND AGAINST THE APPELLATE ORDER DATED 01/04/2024, WHEREBY THE DEPARTMENTAL APPEAL OF THE APPELLANT HAS BEEN REGRETTEED.

Prayer:-

On acceptance of this Service Appeal, the impugned notification dated 23/02/2024 and appellate order dated 01/04/2024 may kindly be set aside and the appellant may kindly be restored on the post of SST Biochemistry (BPS-16) with all back benefits. Any other remedy which this august Service Tribunal deems fit that may also be awarded in favor of the appellant.

R/SHEWETH:

ON FACTS:

Brief facts giving rise to the present appeal are as under:-

- 1) That appellant was initially appointed as Arabic Teacher (BPS-15) on Adhoc basis, pursuance to advertisement and proper selection process vide office order dated 22/05/2014. Copy of appointment order is attached as annexure.....**A**

- 2) That in pursuance of regularization act, 2017 the service of the appellant were regularized by the respondent department through notification dated 21/03/2018. That where after final seniority list was issued for the cadre of AT (BPS-15) wherein the appellant was enlisted at Serial No 83. Copies of Regularization notification and seniority list are attached as annexure.....**B & C**
- 3) That it is pertinent to mention here that the appellant was assigned the ibid seniority position as per merit assigned by the Departmental Selection Committee and in light of Rule 17 (i)(a) of the APT Rules, 1989.
- 4) That one of the colleague of the appellant namely Mr. Jan Baz Khan impugned the seniority list before this august Service Tribunal in Service Appeal No 887/2020 on the ground that as per Regularization enactment 2017 the seniority list be corrected as assigned seniority on the basis of age/date of birth instead of merit position. That the ibid Service Appeal was allowed vide judgment dated 31/05/2023 in favour of Mr. Jan Baz Khan with the directions to the respondent department:-

9. In view of the above discussion, the impugned seniority list dated 26/10/2019 stands set-aside to the extent of those Arabic Teachers, who were appointed on contract basis on 22/05/2014 and whose services were regularized vide Notification bearing Endorsement No 1833-61/AE-1/Estab: dated 21/03/2018 and it is directed that their inter-se seniority shall be determined age-wise on the basis of ibid notification dated 21/03/2018 as well as Sub Section 2 of Section 4 of Khyber Pakhtunkhwa Employees of the Elementary & Secondary Education Department (Appointment and Regularization of Services) Act, 2017 by placing the name of the appellant at correct position in the seniority list of her concerned Arabic Teachers with all consequential benefits. The appeal in hand stands allowed in the said terms. Needless to mention that this judgment shall have no bearing upon those Arabic Teachers, whose appointments have been made through any order/judgment of court or Tribunal. Parties are left to bear their own costs. Copy of judgment dated 31/05/2023 is attached as annexure.....D****
- 5) That in the meanwhile prior to the issuance of the ibid judgment of this august Tribunal, the appellant was promoted

to the post of SST Biochemistry (BPS-16) vide notification dated 07/02/2020 and upon promotion he was posted at GHS Ghoriwala Bannu vide office order dated 13/02/2020. That in compliance of the ibid notification the appellant submitted his charge report on 17/02/2020 and started performing his duty as SST (BPS-16) quite efficiently and upto the entire satisfaction of this superior. Copies of promotion notification, posting order and charge report are attached as annexure.....E

- 6) That the respondent while implementing the judgment of august Service Tribunal, issued the impugned notification dated 23/02/2024, whereby the appellant was reverted/demoted to the post of Arabic Teacher (BPS-15), by retrospectively implementing the judgment of this august Tribunal dated 31/05/2023. Copy of the impugned notification dated 23/02/2024 is attached as annexure.....F
- 7) That feeling aggrieved, the appellant preferred departmental appeal before the appellate authority vide Diary No 962 dated 05/03/2024, but the same was regretted vide impugned appellate order dated 01/04/2024 on no good grounds. Copies of departmental appeal and regret order are attached as annexure.....G
- 8) That the appellant has no other legal remedy and approached to this Honorable Tribunal with the following grounds.

GROUND:

- A- That the impugned notification dated 23/02/2024, whereby the appellant has been demoted/reverted to the post of Arabic Teacher is against the law, facts, norms of natural justice and in utter violation of ATP Rules, hence liable to be set aside.
- B- That the appellant has not been treated by the respondent department in accordance with law and rules on the subject noted above and as such the respondents violated Article 4 and 25 of the constitution of Islamic Republic of Pakistan 1973.
- C- That, the treatment meted out to the Petitioner is a clear violation of the Fundamental Rights of the Petitioner.

- D-** That the respondents acted in arbitrary and malafide manner by issuing the impugned notification dated 23/02/2024 against the appellant.
- E-** That, the appellant has been discriminated by the respondents on the subject noted above and as such the respondents violated the Principle of natural justice.
- F-** That neither the impugned notification dated 23/02/2024 has been issued by the respondents in violation of the principle of locus Poenitentiae.
- G-** That no show cause notice has been issued to appellant before issuing the impugned notification dated 23/02/2024 and appellate order dated 1.4.2024.
- H-** That no chance of personal hearing/defense has been provided to the appellant and as such the appellant has been condemned unheard.
- I-** That the respondent department also floated the judgment of this august Tribunal dated 31/05/2023 by giving retrospective effect to the ibid judgment.
- J-** That the concerned authority acted in arbitrary and malafide manner while issuing the impugned notification dated 23/02/2024.
- K-** That instead of correcting/modifying seniority in the cadre of SST (BPS-16) as per judgment of the august Tribunal, unfortunately the authority without any reason & rhyme and without following codal formalities straight away issued the impugned notification dated 23/02/2024 whereby the appellant has been demoted/reverted to the post of Arabic Teacher.
- L-** That appellant seeks permission and advance other grounds and proofs at the time of hearing.

It is therefore most humbly prayed that the appeal of the appellant may kindly be accepted as prayed for.



TERMS & CONDITIONS.

1. NO TA/DA etc is allowed.
2. Charge reports should be submitted to all concerned in duplicate.
3. Appointment is purely on temporary & contract basis initially for one year W.e.f 22TH May, 2014 to 21th May, 2015.
4. He should not be handed over charge if he exceeds 35 years or below 18 years of age. Age relaxation case may be submitted to competent authority.
5. Appointment is subject to the condition that certificate/documents must be verified from the concerned institutions by the DEO Male (concerned), anyone found producing bogus/fake Certificate/degree will be reported to the law enforcing agencies for further action and his appointment will be withdrawn from the selection list. Charges of the verification will be borne by the appointee himself.
6. His services are liable to termination on one month's prior notice from either side. In case of resignation without notice his one-month pay/allowances shall be forfeited to the Government.
7. Pay will not be drawn until and unless a certificate to the effect by DEO Male (concerned) is issued that his certificates are verified
8. He should join his post within 10 days of the issuance of this notification. In case of failure, his appointment will expire automatically and no subsequent appeal etc shall be entertained.
9. Health and Age Certificate should be produced from the Medical

- Superintendent concerned before taking over charge.
10. He will be governed by such rules and regulations as may be issued from time to time by the Govt.
 11. His services shall be terminated at any time, in case his performance is found unsatisfactory during his contract period. In case of misconduct, he shall be processed under the rules framed from time to time.
 12. His appointment is made on School base, He will have to serve at the place of posting, and his service is not transferable to any other station.
 13. Before handing over charge once again their document may be checked if they have not the required relevant qualifications as per rules, they may not be handed over charge of the post.
 14. In case of any error, deceit on behalf of the appointee found at any time, the appointment order of the candidate will be with drawn

TERMS AND CONDITIONS

Their services shall be governed by the Khyber Pakhtunkhwa Civil Servants Act, 1973, the Khyber Pakhtunkhwa (Appointment, Deputation, Posting & Transfer of Teachers, Lecturers, Instructors & Doctors) Regulatory Act, 2011, and such rules and regulations as may be issued from time to time by the government.

Their services shall be considered regular and they shall be eligible for pension/deduction of GP fund in terms of the Khyber Pakhtunkhwa Civil Servants Act, 1973 as amended in 2013.

Their services are liable to termination on one month prior notice from either side. In case of resignation without notice, their one month pay/allowances shall be forfeited to the Government treasure.

They shall possess the same qualification and experience required for a regular post.

They shall have not resigned from their services or terminated from services on account of misconduct, inefficiency or any other ground before commencement of this Act. The DDO concerned should ensure this condition before the drawal of their pay as regular servants.

Their regularization shall not affect the promotion quota of existing holders of posts in respective service cadres.

They shall rank junior to all other employees belonging to the same cadre who are in service on regular basis on the commencement of this Act and shall also rank junior to such other persons if any, who, in pursuance of the recommendation of the Khyber Pakhtunkhwa Public Service Commission made before the commencement of this Act are to be appointed to the cadre, irrespective of their actual date of appointment.

Their seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service in the case of two or more employees is the same, the employees older in age shall rank senior to the younger one.

Errors and omissions will be acceptable within the specified period.

JUDGMENT:

SALAH-UD-DIN, MEMBER:- Precise facts as alleged by the appellant in his appeal are that he was appointed as Arabic Teacher (BPS-15) on contract basis on 22.05.2014 through National Testing Service (NTS) and was later on regularized vide Notification bearing Endorsement No. 1833-61/AE-1/Estab dated 21.03.2018; that initially a seniority list dated 15.10.2019 in respect of Middle School Arabic Teachers was circulated, wherein the name of the appellant was mentioned at serial No. 84, while the names of private respondents No. 3 & 4 were at serial No. 120 & 124 respectively; that the

afore-mentioned seniority list dated 15.10.2019 was prepared age-wise but subsequently another seniority list dated 26.10.2019 in respect of Middle School Arabic Teachers was circulated, wherein the appellant was shown junior to private respondents No. 3 & 4, constraining the appellant to file objection petition before the District Education Officer (Male) Bannu, however the same was not responded; that the appellant then filed departmental appeal before the Director Elementary & Secondary Education Khyber Pakhtunkhwa Peshawar but the same was also not responded; that the appellant then submitted another application to the District Education Officer (Male) Bannu for disposal of objection petition earlier filed by him; that the District Education Officer (Male) Bannu passed hand written order on the application that the applicant being low in his merit position than the competing candidates, was not entitled for promotion and that he shall be promoted on his own turn subject to availability of the posts; that the impugned seniority list dated 26.10.2019 of Middle School Arabic Teachers has been prepared in violation of Clause-8 of terms and conditions prescribed in regularization Notification bearing endorsement No. No. 1833-61/AE-1/Estab dated 21.03.2018 as well as sub-section-2 of Section-4 of Khyber Pakhtunkhwa Employees of Elementary & Secondary Education Department (Appointment and Regularization of Services) Act, 2017, therefore, the same is liable to be corrected.

2. On admission of the appeal for regular hearing, notices were issued to the respondents. Official respondents No. 1 & 2 as well as private respondents No. 3 & 4 contested the appeal by way of filing of


replies, wherein they refuted the assertion raised by the appellant in his appeal. Rest of private respondents were proceeded ex-parte vide order dated 12.01.2023.

3. Learned counsel for the appellant has addressed his arguments supporting the grounds agitated by the appellant in his service appeal. On the other hand, learned Deputy District Attorney for official respondents No. 1 & 2 as well as learned counsel for private respondents No. 3 & 4 have controverted the arguments of learned counsel for the appellant and have supported the comments submitted by them.

4. Arguments have already been heard and record perused.

5. A perusal of the record would show that the appellant as well as private respondents were appointed as Arabic Teachers (BPS-15) on contract basis vide appointment order bearing endorsement No.5390-6440/AE-II-Male/AT/Adhoc/Apptt dated 22.05.2014. During the course of their service, Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department-(Appointment and Regularization of Services) Act, 2017 was enacted and vide Notification bearing Endorsement No. 1833-61/AE-1/Estab: dated 21.03.2018 their services were regularized with effect from the date of their initial appointment. Clause-8 of Terms and Conditions as mentioned in regularization Notification dated 21.03.2018 is regarding determination of seniority, which is reproduced as below:-

"Their Seniority shall be determined on the basis of their continuous service in cadre, provided that if the date of continuous service

in the case of two or more employees is the same, the employees older in age shall rank senior to the younger one."(Emphasis provided)

6. Moreover, the criteria for determination of seniority inter-se of the employees regularized under Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017 has been provided in Sub-Section 2 of Section-4 of the said Act, which is reproduced as below:-

"4. Determination of seniority.---

(1).....

(2) The seniority inter-se of those employees, whose services are regularized under this Act within the Cadre, shall be determined on the basis of their continuous service in Cadre:

Provided that if the date of continuous service in the case of two or more employees is the same, the employee older in age shall rank senior to the younger one." (Emphasis supplied.)

7. Furthermore, according to Section-5 of the Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017, the provisions of the said act shall have an overriding effect and the provisions of any such law or rules/to the extent of inconsistency with the said Act shall cease to have effect.

8. The appellant as well as private respondents were appointed on contract basis on the same date i.e 22.05.2014 and were regularized



through same Notification dated 21.03.2018, therefore, in view of Clause-8 of Notification bearing Endorsement No. 1833-61/AE-1/Estab: dated 21.03.2018 as well as proviso to Sub-Section-2 of Section-4 of Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017, their seniority inter-se was to be determined age-wise. While going through the impugned seniority list dated 26.10.2019, it is evident that inter-se seniority of the appellant and private respondents has been determined on the basis of score obtained by them in written test conducted through NTS, which was not a correct criteria for determination of their inter-se seniority. The NTS score was relevant for their appointment and not for determining their seniority inter-se. The impugned seniority list dated 26.10.2019 to extent of appellant as well as private respondents was prepared wrongly and requires to be corrected in accordance with Clause-8 of terms and condition of Notification bearing Endorsement No. 1833-61/AE-1/Estab: dated 21.03.2018 as well as Sub-Section 2 of Section-4 of Khyber Pakhtunkhwa Employees of the Elementary and Secondary Education Department (Appointment and Regularization of Services) Act, 2017.


9. In view of the above discussion, the impugned seniority list dated 26.10.2019 stands set-aside to the extent of those Arabic Teachers, who were appointed on contract basis on 22.05.2014 and whose services were regularized vide Notification bearing Endorsement No. 1833-61/AE-1/Estab: dated 21.03.2018 and it is directed that their inter-se seniority shall be determined age-wise on the basis of ibid Notification



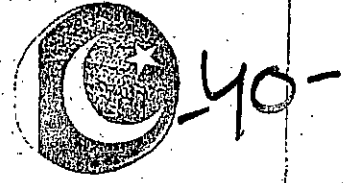



3. And whereas, the case of the appellant was decided vide judgment dated 31-05-2023 by the Honorable Tribunal in favor of the appellant with the direction to the Department, reproduced in verbatim as under:-

AB *Jan Baz Khan*

"inter-se-seniority of the appellant shall be determined age-wise on the basis of Notification dated 21-03-2018 as well as Sub-Section-2 of Section-4 of KP E&SE Department (Appointment & Regularization of Services) Act, 2017 by placing the name of the appellant at correct position in the seniority list of the concerned Arabic Teacher with all consequential benefits"

4. And whereas, the case was declared as UNFIT for filing CPLA before the apex Court by the law Department, whereafter, the DEO (M) Bannu implemented the judgment ibid to the extent of seniority (age-wise) and submitted working papers to this Directorate for promotion of the appellant to the post of SST (BPS-16) in compliance of the judgment supra, whereafter, the case was referred to the meeting of Departmental promotion committee held on 13-12-2023 and the committee has recommended that, the promotion Notification No. 8565-70 dated 07-02-2020 be withdrawn to the extent of Mr. Safdar Ali Shah SST (B/C) (BPS-16) only and Mr. Janbaz Khan - AT (BPS-15) be promoted to the post of SST (BPS-16) with immediate effect.




