

Prayer of appeal:

On the acceptance of this service appeal the impugned notification/ order No.8013-19 Rationalization SST dated 08/12/2023 may kindly be set aside/ cancelled.

Respectfully Shewith:

Precisely starting the facts of the case, out of which the present appeal/ Petition arises are as under

1. That the appellant as serving as (SST) General Teacher (BPS-16) at Buner education Department.
2. That the appellant has been transferred from GCMHS Dagger No.1 to GHSS Naway Kalay wide Notification order No.8013-19/ Rationalization/ SST dated 08/12/2023 on the basis of rationalization policy which is illegal and ineffective upon the right of appellant.
(Copy of the Notification order is attached as Annexure "A").

3. According to the policy base for 9th and 10th base classes, there would be two SST's General, One SST for Mathematics/ Physics and one for Biology/ Chemistry and afterwards 1.5 Teachers per section (i.e. 9th B and 10th B). so base on this criteria, for the base two section (9th A and 10th A) the teacher have in the school according to policy mention but for the remaining sections there is one surplus Teacher and the junior-most should be transferred.
(Copy of Policy is attached as annexure "B").

4. That it is important to mention here that according to seniority list there is another teacher who has appointed in 2015 and is Junior to the appellant. Because the appellant was appointed in 2014.
(Copy of seniority List is attached as Annexure "C").

5. That it is also pertinent to mention that if it has been determined by the date of appointment, then the appellant is Senior from the two other Teachers, based on the dated of appointment, because the ongoing Seniority case is also pending in Khyber Pakhtunkhwa Service Tribunal.

6. That the appeal Committee has been formed consisting/ comprised of BPS-19 and BPS-20 officers after undue transfer order just to sort-out the matter of appellant and other aggrieved teachers. And the appellant has submitted an appeal and dated 11/12/2023 but the result of appeal is none. And the appellant have got the information from the unknown source that the committee has accepted his appeal, but the respondent No.2 being Personalize with appellant and political approach for other teachers, rejected the appeal of appellant which is ineffective upon the right of appellant and also against the due course of law.

(copy of appeal to appeal committee is Annexure C2)

7. That the ill and malafide intention of respondent No. 2 and being personalized with appellant is that the respondent No.2 constitutes an appeal committee after undue transfer order based on rationalization policy. The appeal committee accepted the appeal of appellant but the respondent No. 2 rejected the decision of appeal committee, and some of teachers subsequently returned to their old stations and other transfer to the near stations. Further the appeal committee held its meeting on 18 December while all order of transfer issued on 14/03/2023. Which showed that the order have already been decided even before Committee meeting.

8. That it is very important to mentioned here that the respondents No.2 issued the Rationalized order on Sunday 10/12/2023, while the date written on order is 18/12/2023 with the direction to take charge within three days just to expedite the implementation of the order, which is against the law of the land. And ineffective upon the right of the appellant.

9. That the appellant moved a departmental appeal bearing diary No. 959 dated 03/01/2024 before respondent No. 1, which is still pending, Moreso, the appellant moved an application for disposal of departmental appeal for immediate disposal, but without any result, till date. And this order was issued in such a crucial time where as the students and teachers were in revision process and will waste the precious time of the students.

10. That the appellant is aggrieved from the impugned transfer notification No. 8013-19/ Rationalization/ SST dated 8/12/2023 having no other alternate and efficacious remedy, approaches this Honorable Tribunal and filling the instant appeal on the following Grounds:

Grounds:

- a. That the impugned transfer notification dated 08/12/2023 of respondent No. 2, is manifestly, illegal, Unlawful, and without any lawful justification, void-ab-initio and ineffective upon the right of the appellant, hence untenable in the eye of law and liable to be cancelled.
- b. That the appellant has not been treated in accordance with law, hence right of the appellant has secured and guaranteed under the law, are badly violated.
- c. That the impugned order notification is illegal, under lawful and facts of political motivated, mode being personalized with appellant and nothing else.
- d. That the appellant has been transferred to the school i-e GHS nawakaly whereas the SST general sanctioned post is not existed. And the appellant apprehends that his salary may cease either today or tomorrow, resulting in serve mental retardation and hardship to the appellant.

- e. That the appellant have been transferred based on rationalization policy from GCMHS Dagger No.1 to GHSS nawaklay is illegal, unlawful and against the law and ineffective upon the right of the appellant.
- f. That the appellant is being treated unequally against the law and he is being deprived of equal protection of law.
- g. That through the impugned order/ notification dated 8/12/2023 the respondents have violated the fundamental rights of the appellant as guaranteed by the constitution of Pakistan.
- h. That the appellant seeks leave of the Honorable tribunal to raise additional points, during the course of arguments with the kind permission of this Honorable Tribunal.

Prayer:

For the aforesaid reason, it is therefore most humbly prayed that on the acceptance of this petition the impugned notification No. 8013-19/ Rationalization/ SST dated 8/12/2023 may kindly be declare as unlawful, illegal, without any lawful justification, void-ab-initio as well as against the rationalization Policy and also in ineffective upon the right of the appellant.

Any other relief which this Honorable tribunal deems proper in the circumstance of the appeal may also be granted in favour of appellant.

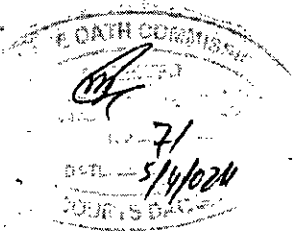



I am further directed to further clarify that:

1. On rationalization surplus teachers in Primary Schools ,PST B-12 , Senior PST B-14 , may be posted in the nearest school if possible then in the same UCs and then in the same circle and then in the same Sub Division and then in the same District Subject to the provisions of need,
2. Over all ratio of SPST/PST will remain according the sanction posts.
3. Senior most PSHT B-15, SPST B-14 & PST B-12 (According to the Seniority list) may be retained in the same school of their present posting and junior most may be transferred to other needy schools.
4. No teacher of CT B-16, PET B-16, AT B-16, DM B-16, TT-16, will be posted in Middle Schools.
5. Senior most Senior CT and SST (According to the Seniority list) may be retained in the schools of their present posting and junior most may be transferred to other schools.
6. Disable teacher may be retained in the schools of their present posting; another teacher may be shifted instead of disable.



Subject: Appeal Against Unjust Transfer and Violation of Policy

Respected Madam,

Meekly stated that I am working as an SST in E&S education department, a dedicated teacher, writing to express my deep concerns regarding my recent transfer to another school based on the rationalization policy vide DEO(M) Buner order No. 8013-19/Rationalization /SST. Dated 08/12/2023. While I acknowledge the importance of policy adherence, I believe there are discrepancies in my case that need attention.

According to the policy for 9th and 10th base classes, there would be two SSTs general and one SST (Math/Phy) and one SST (Bio/Chem), and afterwards 1.5 teachers per section. Based on this criterion, for the base two sections we have teachers according to policy mentioned but for the remaining sections there is one surplus teacher and the junior-most should be transferred. However according to policy point No.5, it has not been specified whether SST General or SST Science should be transferred. It clearly says that the junior-most SST should be transferred, based on seniority list.

So According to seniority list there is another teacher appointed in 2015 who is junior to me (2014). On this criteria, I am not the junior-most.

Alternatively, if it has been determined by the date of appointment, then I am senior to two other teachers based on the date of appointment. Highlighting the ongoing seniority case against these teachers in Khyber Pakhtunkhwa Service Tribunal, questioning the decision-making process when a case determining seniority is under judicial review (Case Name is attached).

So, whether it has been done by the date of appointment or by seniority list, in both cases, I am not the junior-most.

Additionally, an SST (G) is working as an SST Math/Phy for the last 10 years, so he is not teaching a general subject but only physics, so I should be kept in his place. Furthermore SST to SS promotions are expected shortly. In our school, there are 4 SSTs expected to be promoted while one other SST G is going to retire in June 2024.

Committee Acceptance and Officer Rejection: Expressing concern about the

composition of an appeal committee, consisted of BPS 19 and BPS 20 officers and some others, after the transfer order. Noting that the committee accepted my appeal, but the officer concerned rejected the decision and ordered my transfer.

Post-Appeal Order: Highlighting the subsequent order where some teachers were returned to their old stations and others transferred to nearer stations.

Order Nos DEO(M) Buner: Corrigendum orders: SSTs: 8153-58 , PET,DM,TT: 8141-46 and CT: 8147-52 Dated: 14-12-2023.

Date Manipulation and Expedited Implementation: Additionally, I would like to bring to your attention that the officer concerned issued the rationalization order on Sunday, 10th December 2023, however he wrote the date as 8th December 2023 in an attempt to expedite the implementation of the order, which is against the law. This expedited implementation has led to inadequate planning and execution.

Our School, GCMHS DAGGAR being in the headquarter, is the hub for curricular and co-curricular activities where functions, meetings, and other extra work are ongoing all the time.. We are in need of more staff.

In my defense, I would say that my first priority is to be focused on my teaching actively rather than sitting idle. My students, my staff members, and my principal are witnesses of my efficiency.

Even an SST(G), I reopened our science laboratory after years for the students of 9th and 10th and even for middle classes, which was before just a ghost house. I have been incharge of various literary competitions.

keeping these points in mind if you kindly retain me in my previous station so I can focus on my teaching and skill development. I would be grateful to you for the rest of my life.

I affirm my commitment to contributing positively to the educational system. A just resolution is crucial for personal well-being and the integrity of the educational institution. I appreciate your prompt attention and anticipate a fair resolution

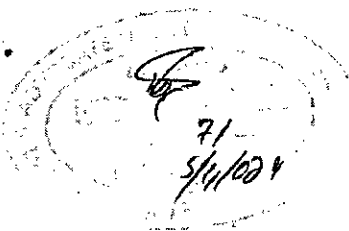

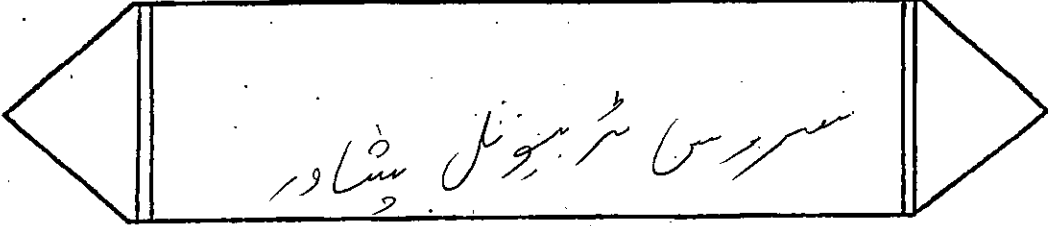
