

Brief but relevant facts of the case are as follows:

- 1. That the appellant has qualified M. Sc (Economics), Master of Education (M. Ed) and Bachelor of Education (B. Ed). Consequent upon the recommendation of the KP Public Service Commission, the appellant was appointed as Subject Specialist (Economics) by the competent authority vide Notification dated 01-01-2008. (Copy of the Certificates and appointment order is filed herewith and annexed as **Annex-B**)
- 2. That the appellant received the impugned order dated 29-11-2023 issued by respondent No 4 wherein the appellant was directed to deposit an amount of Rs 1777998/- in PTC account of GHSS, Ziarat Masoom within two weeks. (Copy of Order is filed herewith and annexed as Annex-C)
- 3. That feeling aggrieved of the aforesaid Order, the appellant filed Departmental Appeal but in vain. (Copy of Departmental Appeal is filed herewith and annexed as **Annex-D**)
 - Hence, the title Service Appeal on the following amongst other grounds:

Grounds:

a. That, the impugned order is against the law, illegal, unlawful, without lawful authority, void and ineffective upon the rights of the Appellant, thus calling interference of this Honorable Tribunal.

- a. That impugned Order is passed without holding any inquiry, without giving any show cause Notice, without giving any chance of hearing to the Appellant, without giving any final show cause Notice to the Appellant, without recording any evidence in utter disregard of the mandatory provisions of Khyber Pakhtunkhwa Government Servants (Efficiency and Discipline) Rules, 2011.
- b. That the impugned Order is against the principles of natural justice as the Appellant is condemned unheard and it is a well settled principle of law that any order which violate the principle of audi alteram partem is nullity in the eve of law.
- c. That the impugned Order is against the principles of administrative law, based on colorful exercise of powers and against the dictums of the August Supreme Court of Pakistan.
- d. That the appellant remained Principal and Drawing Dispersing Officer of the school during the period of September 2020 to September 2022 and has neither misused a single penny of the school funds nor committed any illegality while using the school funds.
- e. That the impugned order is Coram Non Judice and is a non speaking order.
- f. That the treatment met to the appellant is against the principles of administrative law, based on colorful exercise of powers and against the dictums of the August Supreme Court of Pakistan.
- g. That the Appellant craves permission of this Honorable Tribunal to rely on other grounds at the time of arguments and produce any additional document if required in support of his Service Appeal.

It is, therefore, prayed that on acceptance of the instant service appeal, the impugned order dated 29-11-2023 be declared as unlawful, illegal, without lawful authority, void ab-initio and ineffective upon the rights of the appellant and the respondents may kindly be directed not to make any deductions from the salary of the appellant in pursuance of the impugned order and reimburse the appellant.





Departmental Appeal against the letter: Recovery of amount illegally drawn by Mr. Faisal Abbasi SS/ Ex in charge principal GHSS Ziarat Masoom, Endst. No:256, Dated 29/11/2023, by Principal GHSS Ziarat Masoom.

Dear Sir,

With due respect, it is stated that the appellant received a letter from Principal GHSS Ziarat Masoom, vide letter no. 256, Dated 29/11/2023, wherein it is shown that it was issued vide letter no.10349, dated 22/11/2023, issued by the office of DEO (male), Abbottabad, that directed to deposit amount of Rs. 1777998/- in PTC Account of GHSS Ziarat Masoom within 2 weeks. Now I am appealing against the same.

Dear Sir, I remained in charge principal of this school from September 2020 to September 2022. During my tenure, I was the Drawing Dispersing Officer of the school. I make all efforts to enhance the school curriculum and co-curriculum activities for the betterment of students and the community as a whole. Besides this, the devastating condition of the school appealed to me the most and it was very difficult to continue the classes in this situation of the school, where, classrooms are in black and torn doors and windows and glasses of the windows. Torn plasters on the walls and lack of furniture and classroom accessories. Very devastative condition of paints and many other building related things. Being in charge Principal it was my duty to provide education education-friendly environment to the students and staff to boost the curriculum activities.

That time was ceased by the covid-19 pandemic and many steps have to be taken for SOP to safeguard the students, staff, and their belongings. Emergency expenditures were needed there. In 2021, the roof of 3 rooms was also blown in a heavy wind storm.

Nothing was in the school for security purposes, when I took charge of the school. I have installed 14 security cameras in the whole school, including classrooms and outside areas. The boundary wall is fenced with razor wire and concrete work is done behind the boundary wall of 250*3 feet and at the main door and parking areas of about 700 sqr. feet as well. Purchase of 80 Tablet chairs, Repair of more than 100 chairs aiready broken, and Principal office furniture is also done in my tenure.

The washroom for the students was maintained and 2 new washrooms were constructed due to the urgent need of the school, 1 for the principal office and the other for the upper portion of higher secondary classes. Besides, the garden is lo maintained and many flowers and gamlas were purchased for the school renovation. The whole building is painted for a fresh look including the rooftop after the maintenance of doors, windows, cupboards, laboratories, library, kitchen, torn plasters of walls, and all other required work for the maintenance of the building.

Exams, sports, student workbooks, and ceremonies and functions are also done from this fund.

All work is done with the consent of the PTC Committee and the chairman of PTC. Resolutions of PTC are also presented to the inquiry committee. Even more than Rs. 75000/-is paid from my pocket.

High-ups of the department are notified many times to utilize the funds for the betterment of school buildings, students, and classrooms. Do not keep them idle as they are the purpose of school. I utilized the whole funds very carefully and loyally for the betterment of the school and community and all the purchases were done by the purchase committee and chairman PTC with his team also aware and cooperating in the whole process.

Bank profit is also utilized as I was unaware of the fact that this amount should be submitted to the government treasury account, even though no one knows in principals and DEOs before June 2022, when the department notified to deposit this amount to govt. treasury account.

I was new to this court, inexperienced, and unaware of many facts, that might create some loopholes in the maintenance of fund records, otherwise, nothing was misused during my tenure.

It is very regretful that an Inquiry is initiated merely on the demand of some opponents and a person junior to me is nominated as inquiry officer, who blames various areas and persons without any proof. These activities torture me a lot and damage my reputation. Then on my application, the inquiry was given to another person but soon his inquiry was canceled without any solid reasons, just for the pleasure of opponents, and another inquiry team was sent which was not a team but a man show. I show them all these things and demand to physically verify every expenditure.

After all, I didn't receive a single detail of the inquiry report for what I have to deposit money back into the PTC account. Even once DEO (M) Abbottabad called me for a personal hearing. I went there but DEO was not available and Dy. DEO just told me about withdrawals verbally. No detail is provided.

It seems fiction and injustice to victimize me just because I was in charge principal and not in line with the insane demands of some people, especially one of the staff members who remained on duty for the whole session and tried to convince the public against me just on my demand to remain present in the school for the sake of students.

Therefore you are humbly requested to reconsider the matter and consider my appeal with your kind consideration. I swear, I haven't used a single penny out of school. I am very much shocked and suffering with these tactics. I am a bonafide and dutiful teacher of the department and many of the Principals are evident in my duties. Be kind to me to consider the matter with sympathy and my services should be taken into view.

I will be thankful to you with a core of my heart.
