- 1- That the appellant is accredited Engineer in civil technology from recognized university and was initially appointed as Assistant Engineer BPS-17 in Irrigation Department on the proper recommendation of the Khyber Pakhtunkhwa Public Service Commission vide notification dated 21/07/2007. Copies of the recommendation and appointment order are attached as annexure.....**A&B**
- 2- That during service, respondent department i.e. Communication & Works Department advertised the post of Assistant Engineer (BPS-17) in which the appellant got NOC from the Irrigation Department and applied for the ibid post, participated in the selection process and was recommended by the Khyber Pakhtunkhwa Public Service Commission for the post of Assistant Engineer (BPS-17). Copy of the NOC is attached as annexure .....**C**
- 3- That after recommendation of the Public Service Commission the respondents department issued notification dated 04/01/2011 regarding appointment of the appellant and his other colleagues against the post of Assistant Engineer (BPS-17).Copy of the application and notification are attached as annexure.....**D&E**
- 4- That upon appointment in the respondent department, the Irrigation Department submitted a summary to the Chief Secretary for reliving of the appellant and accordingly the same was approved vide summary dated 15/01/2011. Copy of the summary is attached as annexure.....**F**
- 5- That in light of the ibid summary, the appellant was relieved by the Irrigation Department to the Communication & Works Department vide notification dated 21/01/2011. Copies of the approved summary and notification are attached as annexure.....**G&H**
- 6- That upon arrival, the appellant started performing duties with zeal and zest and efficiently and upto the entire satisfaction of the superiors.
- 7- That vide letter dated 01/01/2014 the respondents department issued seniority lists for the cadre of Assistant Engineer/SDO (BPS-17) wherein astonishingly the name of the appellant was enlisted at Serial No 70 instead of Serial No 26 above the name of Amir Jan. Copy of the seniority list is attached as annexure.....**I**
- 8- That feeling aggrieved, the appellant submitted Departmental Appeal before the respondent No 2 for correction in the seniority list to the extent of enlistment of the appellant at Serial No 26 of the seniority list circulated for the cadre of Assistant Engineer /SDO (BPS-17) w.e.f. the date of initial appointment in Irrigation Department i.e. 21/07/2007 instead of 04/01/2011. Copy of the

- 1. Departmental Appeal and (*seniority list is already attached as annexure I*) is attached as annexure.....J
- 2. That in similar nature case the respondent department granted seniority to the one of the employee namely Syed Daud Jan, whose appeal was allowed by this august Tribunal vide judgment dated 10/05/2004 passed in appeal No 1201/2002 .Copy of the judgment is attached as annexure.....K
- 3. That later-on the respondent department implemented the judgment of this Tribunal by enlisting the name of Syed Daud Jan at the right place of the seniority list. Copies of the seniority lists are attached as annexure.....L
- 4. That so much so the senior colleague of the appellant namely Muhammad Asif was initially appointed in the Local Government Department as Assistant Engineer and then appointed in the Communication & Works Department was allowed seniority from the date of initial appointment in the Local Government Department vide letter dated 19/09/2011. Copies of letters are attached as annexure.....M
- 5. That light of the above scenario the appellant is also similarly placed in the respondent department and is entitle for similar relief as meted out to his other senior colleagues. That no response has been received so far of the Departmental Appeal submitted by the appellant. Hence the instant service appeal on the following grounds amongst others:-

#### **GROUND:**

- A- That the inaction of respondents by not granting lien/seniority to the appellant at the right place of the seniority for the year, 2019 is against the law, facts, norms of natural justice and materials on record.
- B- That appellant has not been treated in accordance with law and rules by the respondent Department on the subject noted above and as such the respondents violated Article 4 and 25 of the Constitution of Islamic Republic of Pakistan 1973.
- C- That the respondents acted in arbitrary and mala fide manner by not granting lien/seniority to the appellant from due date and as such the inaction of the respondents is violative of law and rules.
- D- That the inaction of the respondents is discriminatory and against the norms of natural justice, therefore not tenable in the eyes of law.

- E- That as per the judgment rendered by this Honourable Tribunal in the case of Syed Daud Jan as per notification of the respondents in the case of Muhammad Asif the appellant is also similarly placed employee of the respondent department, is entitled for the relief meted out to his other senior colleagues in the light of judgments of Apex Court reported in 1995 SCMR 1185, 2009 SCMR 01 & 2023 SCMR 08.
- F- That not granting seniority to the appellant w.e.f. first regular appointment in the Irrigation Department i.e. 21/07/2007 instead of 04/01/2011, the respondent violated section B of the Civil Servant Act, 1973 read with Rule-17 of the Appointment, Promotion & Transfer Rules, 1989.
- G- That as per Fundamental Rule-12-A, the appellant is fully entitled for the grant of lien/seniority from the date of initial appointment as Assistant Engineer in the Irrigation Department i.e. w.e.f. 21/07/2007 instead of 04/01/2011.
- H- That appellant seeks permission to advance other grounds and proofs at the time of hearing.

It is therefore, most humbly prayed that the instant appeal of the appellant may kindly be accepted as prayed for.
