SERVICE APPEAL UNDER SECTION 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT, 1974 AGAINST THE OFFICE NOTIFICATION DATED 19.04.2023 OF R. NO.1, WHEREBY APPELLANT WAS DROPPED FROM PROMOTION TO THE RANK OF OFFICIATING INSPECTOR B-16 FOR NO LEGAL REASON.

#### <u>JUDGMENT</u>

KALIM ARSHAD KHAN CHAIRMAN: According to the memorandum and grounds of appeal, appellant was initially appointed as Constable on 21.02.1982 and through step wise promotions, lastly, was promoted to the post of Sub Inspector. That for further promotion to the rank of Officiating Inspector, letter for submission of ACRs of the Sub Inspectors of List "F", were written to the Heads of Police Department. That subsequently, seniority list of Sub-Inspectors on list "F" of the Khyber Pakhtunkhwa Police was issued, wherein, name of appellant was reflected at Serial No.16. That the appellant submitted his ACRs for the period concerned. That vide impugned order dated 10.05.2023 other colleagues of the appellant were

promoted to Officiating Inspectors and the appellant was deferred on the basis of missing of his ACRs. Feeling aggrieved, he filed departmental appeal which was also rejected. Hence, the instant service appeal.

- 02. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 03. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
- O4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).
- O5. Perusal of record reveals that the appellant was serving as Sub-Inspector and was found eligible for promotion to the post of Officiating Inspector (BPS-16), however, he was deferred and admittedly, his juniors were promoted as Officiating Inspector vide Notification dated 19<sup>th</sup> April, 2023. In the said Notification of promotion, the name of the appellant was not included on the ground that his PERs up-to the year 2021 were missing. In this regard, correspondence had also been made in the shape of letter dated 23.06.2023 addressed to the Provincial Police Officer, Khyber Pakhtunkhwa,

Regional Police Officer, Bannu Region, Bannu, the contents of the letter are reproduced below:

"It is intimated for favour of kind information that according to the contents of application, the police officer concerned has been deferred from officiating promotion as Inspector due to nonavailability of ACTs for the years 2020 and 2021 which had been requisitioned by CPO Peshawar from all the Unit Heads of Police Department Khyber Pakhtunkhwa Peshawar, CCPO Peshawar and all the RPOs in Khyber Pakhtunkhwa vide CPO Peshawar letter No.113-37/23 dated 17.01.2023, letter No.S/472-96/23 dated 21.02.2023 and letter No.S/891 900/23 dated 10.04.2023 in connection with DPC meeting for promotion as officiating inspectors at CPO level but the said ACRs were not submitted in time to CPO Peshawar and departmental proceedings against the defaulter ones are being initiated by the undersigned under relevant rules in the subject case and subsequently, the said police officer was deferred due to the reason from promotion as Officiating Inspector in the DPC meeting held on 19.04.2023 as CPO,, Peshawar.

It is, therefore, requested that the said police officer SI Muhammad Zaman No.B 51 is entitled for promotion as Officiating Inspector from the retrospective date i.e. 19.04.2023 being one at the verge of retirement with no fault at his credit please."

In the above letter, the respondents have admitted missing of PERs, which was made a reason for deferment of the appellant for promotion. Admittedly, it is a case of deferment and deferment is not a punishment while the reason for deferment is stated by the department to be non-production of PERs/ACRs of some period which was not the fault on the part of the appellant, rather the department ought to have procured the same at the proper point of time.

06. Be that as it may as the appellant has retired during the pendency of this appeal, therefore, it is deemed appropriate to remit the matter to the department for consideration of the appellant for his promotion in accordance with law and



#### Respectfully Sheweth;

Bannu Region Bannu . . . .

- 1. That appellant was initially appointed as Constable on 21-02-1982 and on satisfactory performances of his official duties he was promoted to the rank of Head Constable. The said process of promotion was in-vouge when he was further promoted to the rank of ASI in the year 2006, followed by subsequent promotion to the rank of Sub-Inspector in the year 2014.
- 2. That further promotion to the rank of Officiating Inspector was required in the department and then on 07-01-2023, R. No. 01 wrote letter to all Heads of the Police Department, CCPO and Regional Police Officers in KP to remit ACRs up to the year 2021 to Secret Branch CPO within 10 days of those Sub-Inspectors who are on List "F". Matter be considered on top priority followed by subsequent letter dated 21-02-2023 and 10-04-2023 of the same nature. (Copies as annex "A")

- That on 18-04-2023, seniority list of Sub-Inspectors on list "F" of KP Police was issued wherein name of appellant was figured at S. No. 16 by showing his name on list "F" with effect from 03-12-2020. (Copy as annex "B")
- 4. That appellant had submitted ACRs for the period concerned with the Record Keeper of R. No. 02 for remission of the same to R. No. 01 for the purpose well within time.
- 5. That DPC held Meeting for the purpose and almost all 154 incumbents were promoted to the rank of Officiating Inspectors B-16 vide Notification dated 19-04-2023 by R. No. 01. (Copy as annex "C")
- 6. That on 07-06-2023, appellant submitted after receipt of the impugned Notification on 10-05-2023, appellant submitted representation before R. No. 01 for promotion to the rank of Officiating Inspector which was processed in the office concerned for necessary action. (Copy as annex "D")
- 7. That appellant submitted application to the authority on 07-06-2023 for explaining the position of the case by dropping his name from promotion and met with R. No. 02 who fully explained the position of none remitting of his documents to the quarter concerned. (Copy as annex "E")
- 8. That on 23-06-2023, R. No. 02 wrote letter to R. No. 01 that appellant has submitted the required documents well before the Record Keeper of R. No. 02 but he was not remitted the same to the concerned quarter, so enquiry was initiated against the defaulter with further request that appellant is entitled for promotion as Officiating Inspector with effect from 19-04-2023 being at the verge of retirement for his no fault. (Copy as annex "F")
- 9. That on 04-07-2023, his request for promotion to the rank of Officiating Inspector was not honored. (Copy as annex "G")

Hence this appeals, inter alia, on the following grounds:

#### GROUNDS:

a. That admittedly appellant was in the range of promotion and was fully fit and suitable for the purpose, having neat and clean service record at his credit.

b. That appellant had submitted the documents well before the Clerk concerned but it was not known as to why he remitted documents of others to the office of R. No. 01, leaving aside the documents of appellant.

c. That in letter dated 23-06-2023, R. No. 02 has clarified the position of appellant before R. No. 01 that his ACRs were not remitted to the quarter concerned by the Record Keeper and departmental proceedings were initiated against him as appellant was left from promotion due to fault of clerk concerned, otherwise appellant was entitled for promotion to the said post since 19-04-2023, being one at the verge of retirement.

- d. That order of rejection is not based on legal footing as it was incumbent upon the authority to direct the concerned quarter to issue order of promotion of appellant to the said post.
- e. That the impugned order as per available record is not per the mandate of law rather based on malafide.

It is, therefore, most humbly prayed that on acceptance of the appeal order dated 04-07-2023 of R. No. 01 be set aside and appellant be promoted to the rank of Officiating Inspector B-16 since 19-04-2023 with all consequential relief as he will be retired at the end of the year.

- E. Incorrect, the order is as per mandate of law and not based on malafide intentions.

The respondents department seeks permission of this Honorable Tribunal for further/additional grounds at the time of arguments.


