BY ACCEPTING THE INSTANT APPEAL, THE IMPUGNED ORDER DATED 13.10.2023 MAY BE DECLARED ILLEGAL AND MAY BE STRUCK DOWN. IT IS FURTHER REQUESTED THAT THE

MANAGER SEWERF

APPELLANT MAY KINDLY BE ADJUSTED/ TRANSFERRED TO GGMS MANSEHRA IN THE BEST INTEREST OF PUBLIC INTEREST.

ANY OTHER RELIEF, WHICH THIS HONORABLE COURT DEEMS FIT AND APPROPRIATE, MAY ALSO BE GRANTED TO THE APPELLANT FOR THE ENDS OF JUSTICE.

#### RESPECTFULLY SHEWETH:

Brief facts of the matter which lead to the present Appeal are as under!

#### **FACTS**

- 1. That Appellant belongs to respectable family of the locality and was initially appointed as Drawing Master in the year 2007 and was posted at GGMS Matta District Battgram (Copy of Appointment order is Annexed as A).
- 2. That Later on Appellant was transferred to GGHS Shamlai Battgram in the year 2010. After that period Appellant was promoted to SDM in the year 2016 and she was transferred to GGHS Battgram. It is important to note once again she was transferred to GGCMS Gujar KhanBatagram on 02/02/2017 and finally she was promoted and was transferred to GGMS Sikandra as SST (Gen) on on 02/02/2018 and till date is serving on the same post at District Mansehra. {Copies of Transfer AND PROMOTION ORDERS ARE ANNEXED AS B}.
- 3. That Appellant had come to know that one Mst Hameeda Khatoon SST (Gen) is going to be retired from services on 31/12/2023 and the post will remain vacant after her retirement, Hence the appellant filed an application to Respondent No.2 for transfer to the said School

(GGMS Mansehra). {Copies of Application Submitted to DEO Female (RESPONDENT No. 2 is annexed as C).

- 4. That Respondent No. 2 while favoring their blue eyed, and bulldozing the policy ignored the application of the appellant and while adjusting Respondent No. 3 being junior to the appellant on the said vacant post at GGMS Mansehra. {Copy of IMPUGNED OFFICE ORDER DATED 13 (2023 IS ANNEXED AS D).
- 5. That being aggrieved from the Impugned order 13/10/2023 appellant preferred departmental appeal within time to Respondent No.1 which was not been responded within statutory period. (COPY OF DEPARTMENTAL APPEAL IS ANNEXED AS E).
- 6. That feeling aggrieved from the inaction and omission of Respondent No. 1 & 2 by not considering the Departmental appeal of the appellant within statutory period. Appellant have no other adequate remedy available except to approach this Hon'ble Tribunal by filing appeal on the following grounds.

#### GROUNDS

- A. That the Impugned Notifications/Office Orders dated 13/16/2023 of Respondents No.2, is wrong, illegal, unfounded, unconstitutional, based on nepotism and favoritism, hence, are liable to be set aside.
- B. That the appellant is mother of 4 children and is the only bread winner for his family and all are school going children who is admitted at main City. Furthermore appellant has served on the same post at hard area for more than 5 years, apart from this appellant had served out district at Batagram which is evident from transfer orders. In this

state of matter Appellant was entitled to be adjusted at GGMS Mansehra against the vacant post of SST (Gen). But Respondent No. 2 ignored this aspect while ignoring article 4 of the constitution of Islamic Republic of Pakistan. Hence, the very impugned order dated: 13/10/203 is untenable in the eye of law.

- C. That the impugned Notifications/ office orders issued by Respondents are in sheer violation of the Fundamental Rights guaranteed to the Appellant as envisaged under the Constitution of Islamic Republic of Pakistan 1973.
- D. That the whole proceedings took place on malafide, ill will intentions and just to harass the appellant, which is violation of fundamental rights guaranteed by Constitution of Islamic Republic of Pakistan 1973.
- E. That any other ground will be taken at the time of arguments with the kind permission of this Honorable Court.

In wake of above submissions, it is therefore, most humbly prayed that the instant appeal may kindly be accepted as prayed for.
