*" It is therefore, humbly prayed that by
accepting the instant service appeal the
impugned order No, 8862-67 dated
22/03/2024 (cancellation of mutual transfer
order) may kindly be set aside, issued by the
Respondent No,2 (District Education Officer
Male Swat) being against the law, rules,
transfer policy and against the natural justice .*

*ii. It is further respectfully prayed to direct the
Respondents No, 2 to released the pay/Salary
of the appellant with effect from 01/03/2024
the act of the stoppage of pay the act Respondent
No,2 and 3 against the service rules, against the
fundamental rights and natural justice.*

iii. It is also prayed to direct the Respondent No,2,

to restore the mutual transfer order No, 8107-12 dated 19/03/2024 and released the pay of the appellant.

iv. Any other reliefs not specifically prayed for, but this August court deem proper may also be granted.

Respectfully Sheweth.

Facts of the service appeal.

1. That the applicant is residence of village Lanagr Tehsil Khawazakhela Swat.

2. That the appellant is performing his duty in Elementary and secondary Education Swat under the supervision of Respondent No, 2 from last 29 years.

3. That the appellant was promoted from PST to CT BPS 15 and adjusted at Government Middle school Baboo Khawaza khela Swat.

4. That the Respondent No, 2 issued the promotion order No, 4830-36 dated 27/06/2023 as SCT BPS 16 and the appellant adjusted at Government Higher Secondary school Drush khela Matta Swat vide No, 4830-36 date 27/06/2023. (Promotion order & pay slip GHSS Drush Khela are Annex: A & B)

5. That the Respondent No, 2 issued the mutual transfer order No, 8107-12 dated 19/03/2024 on the written application of both High up's of the schools and the both teachers and Respondent No, 2 issued the mutual transfer order vide dated 19/03/2024.

(Mutual transfer application and transfer order are Annex: C & D)

6.. That after few days the Respondent No, 2 issued the

cancellation order of the mutual transfer order of the appellant due to the local political influence, the appellant fulfilling his duty by the complying with the order of Honorable Respondents Departments (Cancellation order as Annex: E)

7. That in November 2023 consultation with the Finance Department K.P. Peshawar by Respondent No,2 the post the C.T. BPS 15 of the Respondent No, 3 school (GHS Janoo Swat) was up graded to SCT BPS 16 . It is pertinent to be noted that the appellant was submitted an application for transfer on 28/02/2024 on against the SCT BPS 16 vacant post to Respondent No,2 (GHS Janoo) but the Respondent No, 2 remained salient on the appellant transfer application and the appellant pay/ salary was transferred to GHS janno on the consultation of Finance Department and the Respondent No,2 on 11/2023 in the yearly financial meeting at finance Department Peshawar and the appellant was drawn his pay from GHS janno vide DDO Code SW 6101 but before the transfer of appellant in 11/2023 meeting in Finance Department on 11/2023 after consultation with Finance Department K.P. Peshawar and Respondent No,2 was up graded CT post 15 to SCT BPS 16 post of GHS Janoo (Up gradation of pay slip as Annex: F)

8. That after 3 days of mutual transfer from GHSS Drush khelaMatta Swat to GHSS Chamatali Khawaza Khela Swat, The same order was recalled/cancelled by the Respondent No,2. The appellant pay/ salary was drawn on RespondentNo, 3 school (GHS janno Khawaza Khela Swat) from last three months which was stopped vide source form by the Respondent No,3 by the verbal order of the Respondent No,2. The salary was transferred to GHS Janoo school due to the mutual consultation of Respondent No, 2 and Finance Department K.P. Peshawar has transferred the appellant pay from GHSS Drushkhela Matta Swat to Respondent No, 3 school (GHS janno Khawaza khela Swat.

9. That the Respondent No, 3 (Headmaster GHS Janoo Khawaza khela Swat) stopped the pay of the appellant with out any reason, the appellant is still performing his

duties honestly and according to the satisfaction of his High ups. (source of stopped of pay as Annex: G)

10. The appellant submitted an application to Respondent No, 2 for cancellation of the mutual transfer order vide diary No, 4691 dated 25/03/2024 and another application submitted to Respondent No, 2 for the released the pay of the appellant vide diary No, 9147 dated 01/04/2024 but in vain. (application for Cancellation of transfer order and application for release of the of pay are annex: H & I)

11. That the word " non availability of SCT BPS 16 post at GHSS Drush Khela Matta Swat " is totally wrong. The appellant was drawn his pay on SCT BPS 16 in the mentioned institution for last three months.

12. That Mr. Shafaat Khan SCT BPS 16 G.H.S.S Chamtali is retired on 31/3/2024 not the post of SCT BPS 16 Clear vacant in the aforesaid school. (Retirement Certificate as Annex: J)

12. That the Respondent No, 2 submitted the reply vide Dated 25/02/2024 . The respondent No,2 has deny from the stopping of pay of the appellant. (Reply as Annex: K)

12.. That the appellant submitted a departmental service appeal to Respondent No, 1 on 26/03/2024 but rejected vide Respondent No, 5325 dated 16/05/2024. (Departmental service appeal and Rejection letter are Annex: L & M)

GROUNDS.

1, That the impugned order cancellation of mutual transfer is illegal, un lawful and against the principal natural justice.

2. That the appellant has not committed any Violation of the rules and regulations, against which the appellant should be punished and to be cancelled/ recalled the mutual transfer order.

3. That the appellant is innocent.

4. That the appellant has never act in a manner , which comes under the meaning of disciplinary ground. (5)

5. That the appellant is serving the education Department since the date of his appointment and renders a long service; but the whole service of appellant has totally ignored and overlooked.

6. That discrimination not has been committed the appellant.


7. That further grounds would be agitated during the course of arguments with prior permission of the Honorable Tribunal.

It is therefore, humbly requested that on acceptance of instant service appeal of the appellant.
