



ABBOTTABAD. THE IMPUGNED NOTICE ISSUED
BY RESPONDENTS' DEPARTMENT IS ILLEGAL
AND IS LIABLE TO BE SUSPENDED.

PRAYER: ON ACCEPTANT OF THE INSTANT
SERVICE APPEAL, THE IMPUGNED NOTICE NO.
767-70 DATED 07/04/2016 REGARDING RECOVERY
OF RS.1,809,927/- MAY BE SET-ASIDE AND DE-
SEALING OF ACCOUNT NO. 4072685704 IBAN
PK02NBPA0927004072685704 OF THE APPELLANT
MAY BE ORDERED. ANY OTHER RELIEF WHICH
THIS HONOURABLE TRIBUNAL DEEM FIT AND
APPROPRIATE MAY ALSO BE GRANTED TO THE
APPELLANT.

Respectfully Sheweth;:-

Brief Facts of the case are as under:-

1. That the appellant is resident of Bandi Berote Tehsil & District Abbottabad and is performing duties as Head Teacher in Govt. Primary School Bandi Berote Abbottabad.
2. That there was no outer wall of the Govt. Girls Primary School Bandi Berote and due of this

reason a sum of Rs. 2,939,927/- was allocated by the respondents' department for the construction of outer wall, of 02 rooms, 09 toilets to meet the needs of the girls school.

3. That for the above mentioned construction works, no formal tender was issued by the respondents but (PTC) Parents Teacher Council was constituted and respondent No. 4 was also included as member of the said PTC. Copies of agenda meeting and resolutions of PTC members are attached as Annexure "A".
4. That at the spot supervision of the construction work was carried out by the said PTC (Parent teacher) Council and during the pendency of construction work the officers also paid visits at the spot to check the progress of construction work. No objection certificate was issued by the respondents' department which reflects their satisfaction about the construction work done.
5. That the construction work was carried out and expenses were spent through joint account run by the appellant, PTC and respondents' department.

6. That a sum of Rs. 24,97,000/-, have been spent and remaining amount of Rs. 5,58,785/- was available in the account of the bank while plaster of walls of rooms, flour and installation of doors are pending while outerwall, latrine water pipe line fitting have been completed. Electrification cost Rs. 8,380/- has been spent and remaining amount Rs. 1,20,000/- deposited in Bank account which is laying for installation of credials for children/students. Copy of statements of account is attached as Annexure "B".
7. That entire work carried out with good faith on the basis of approval by PTC. Inspection of site can be verified by C&W Department to assess the cost of work done. Copy of inspection report is attached as Annexure "C".
8. That a notice No. 767-70 dated 09/04/2016 was issued regarding recovery of amount of Rs.1,809,927/- by respondents' is nothing only, but black mailing tactics which is illegal, non-operative on the part of the appellant. Copy of notice No. 767-70 dated 09/04/2016 is attached as Annexure "D". Hence, the appellant filed departmental appeal on 3/4/24 but of no avail.

Besides, respondents have not acted upon the impugned notice so far. Therefore, the instant service appeal is being filed inter-alia, on the following grounds:-

GROUND:

- a) That the appellant being the chairman of PTC (Parent Teacher council) utilized the funds amount to Rs. 2,497,000/- after getting proper permission from the PTC through resolution. Besides, all the IN and OUT of expenditures occurred on the building of said school are available in record duly endorsed by PTC. Hence, the recovery against the appellant is illegal.
- b) That the appellant is not a Govt. Contractor but is a teacher. There is no law which authorizes the respondents' department to direct the petitioner to construct buildings etc in the school. As per law, the respondents' department was supposed to issue tenders to the Govt. registered contractor for the purposes of construction in the said school.

- c) That the construction work carried out by the petitioner through PTC is more than the work done if it was done by Govt. Contractor. It is further submitted that department as well as this Honourable Tribunal may refer the case of construction to C&W department to assessment whether the fund allocated by the department for construction work at Govt. Primary School Bandi Berote has been utilized or otherwise by the appellant.
- d) That the main controversy arose, when respondents' department through different tactics tried their best to get percentage amount out of the govt funds but appellant being honest teacher refused to succumb to their illegal demands gratification which resulted into illegal recovery of Rs. 1,809,927/- which is malafide against the law and rules on the subject.
- e) That the expenditure receipts from the concerned quarters were to be verified prior to the imposition of recovery of an amount to Rs. 1,809,927/- against the appellant. But

respondents' department has miserably failed to get the procurement receipt verified from the quarter concerned and imposed the recovery on their whims and wishes. Hence, the impugned recovery as per law is not maintainable and same may not be recovered from monthly salary as well as from pensionary benefits at the time of the appellant.

It is, therefore, humbly prayed that, on acceptant of the instant service appeal, the impugned notice no. 767-70 dated 07/04/2016 regarding recovery of Rs.1,809,927/- may be set-aside and de-sealing of account no. 4072685704 Iban pk02nbpa0927004072685704 of the appellant may be ordered. Any other relief which this Honourable Tribunal deem fit and appropriate may also be granted to the appellant.


