- of this Honourable Tribunal, the respondents' department restored the period of reduction in lower stage in time scale for 05 years of the appellant vide order dated 10/03/2023 subject the final outcome of CPLA pending decision before August Supreme Court of Pakistan. Copy of order dated 10/03/2023 is attached as Annexure "E".
- 6. That after setting aside the reduction in time scale for 05 years, the respondents' department did not fix seniority of the appellant. Therefore, the appellant filed departmental appeal on 26/12/2023 but of no avail. Copy of departmental appeal dated 26/12/2023 is annexed as Annexure "F".
- 7. That the respondents' department sought advice from Home Department KP vide letter dated 04/04/2023. Copy of letter dated 04/04/2023 is attached as Annexure "G". Resultantly Government of KP Establishment and And Admin Department (Regulation Wing) letter dated 13/07/2023 wherein it was clarified that as per Para-IV (i) of promotion policy is quite clear which stipulates that subjudice seniority would

not debar the competent forum to make recommendation, however such promotion will be conditional and subject to out come of court decision but even then the respondents' department is not restoring the seniority of the appellant. Copy of order dated 13/07/2023 is attached as Annexure "H".

8. That in the meantime respondents' department did not restore seniority of the appellant for promotion. In this regard the appellant preferred departmental appeal on 26/12/2023. Copy of departmental appeal dated 26/12/2023 is attached as Annexure "I". Therefore the instant service appeal is being filed on the following grounds;

#### **GROUNDS: -**

a) That the conduct of respondents' department towards the appellant is discriminatory and not insertion of name of the appellant after restoring his seniority in the seniority list is illegal and against inalienable right of the appellant.

- b) That respondents' department is willfully not restoring seniority of the appellant just to damage his service carrier as well as to make monitory loss to him. It is further submitted that when law allow a thing to an employee that must be given to him in letter and spirit at the earliest.
- c) That the appellant is eligible to be promoted after restoring his seniority in the revised seniority list. Because the penalty of reduction to lower stage in time scale for a period of 05 years was set-aside by this Honourable Tribunal vide judgment dated 16/11/2022.
- d) That the appellant is entitled for promotion once, his 05 years seniority is restored with all service back benefits.
- e) That the instant service appeal is well within the period of limitation this Honourable Tribunal has jurisdiction to entertain the lis under Article 212 of the constitution of Islamic Republic of Pakistan.

- f) That the valuable rights of the appellant are involved.
- g) That other points shall be urged at the time of arguments.

It is therefore, most humbly prayed that on the acceptance of instant service appeal the respondents may graciously be directed to fix seniority of the appellant and issue revised seniority list and thereafter the appellant may be promoted to next higher grade. Any other relief which this Honourable tribunal deems appropriate in the circumstances of the case may also be granted to the appellant.

#### **JUDGMENT**

KALIM ARSHAD KHAN CHAIRMAN.: The appellant is aggrieved of order dated 04.11.2015, whereby major penalty of reduction to a lower stage in a time scale for a period of five years was imposed upon him and the period of his absence from 01.02 2015 to 15.03.2015 (43 days) had been treated as leave without pay.

- 2. According to the appeal, the appellant was serving as Junior Clerk in the Prison Department and was in Sub-Jail Dassu, Kohistan; that because of his involvement in a criminal case, he remained absent from duty for 43 days, because of which he was awarded major penalty of reduction to a lower stage in a time scale for a period of five years and his absence period was treated as leave without pay vide impugned order dated 04.11.2015; that the appellant was acquitted from the charge by the learned Additional & Sessions Judge, Lahore on 19.02.2019 and he filed departmental appeal which was not responded within the statutory period, hence this appeal.
- 3. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who, on putting appearance, contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.

- 4. We have heard learned counsel for the appellant and learned Additional Advocate General for the respondents.
- 5. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Additional Advocate General controverted the same by supporting the impugned order.
- 6. The first moot point for determination before us was question of limitation but that had already been settled vide the admitting note dated 13.07.2021 in the following manner:-

"However, in the impugned order, the competent authority deviated from his own tentative decision and imposed major penalty of reduction to a lower stage in a time scale for a period of five years. Apart from the said major penalty, the period of absence of 43 days was also treated as leave without pay. The impugned order on its face, for the reasons of absence of formal charge sheet at the time of commencement of enquiry proceedings, and on account of deviation of the competent authority from its tentative decision of <u>imposition of minor penalty indicated in the show</u> <u>cause notice, is likely to suffer from voidness, if</u> rebutted by sufficient material justification by the respondents. Thus, there is uncertainty as to whether the question of limitation will have any bearing or not".

7. The only question remained before this Tribunal for determination is whether the impugned order of reduction to a lower stage in a time scale for a period of five years. It is in this respect observed that the very and only charge against the appellant in the statement of allegation was that he remained absent from duty w.e.f

#### **APPLICATION/ADVICE**

I am directed to refer to the subject and state that Mr. Zeeshan Ahmad, Senior Clerk (BPS-14) presently posted at District Jail Mansehra was awarded major penalty of reduction to a lower stage in a time scale for a period of five years in a departmental proceedings vide this office order dated 04-11-2015 (F/A). Against the said major penalty, he preferred a departmental appeal before the Appellate Authority through proper channel but the same was rejected vide Home Department letter (F/B). Thereafter, he preferred service appeal No. 864/2019 before Khyber Pakhtunkhwa Service Tribunal Peshawar which has been disposed off vide judgment dated 16-11-2022 (F/C) and the impugned penalty was set-eside. Against the learned Khyber Pakhtunkhwa Service Tribunal Judgment dated 16-11-2022, the department filed CPLA in the August Supreme Court of Pakistan, which is still pending. On the other hand, the appellant filed execution petition No. 27/2023 before the Learned Service Tribunal for implementation of Judgment dated 16-11-2022, Resultantly, the Chairman Khyber Pakhtunkhwa Service Tribunal issued order sheet dated 22-02-2023 (FID). Accordingly, the judgment dated 16-11-2022 referred to above, was implemented conditionally, subject to final outcome of CPLA from the August Supreme Court of Pakistan vide this office order dated 10-03-2023 (F/E),

Now vide (F/F), the appellant has submitted an application, wherein he requested for due seniority / promotion and back benefits with effect from 04-11-2015, as during subsistence period of penalty, some junior colleagues were promoted and the applicant was superseded for the above major penalty in his service record.

In view of the above, it is requested that the case of the above named official may kindly be referred to Establishment Department for necessary advice on the following points:

a. Whether the request for granting due senionity/promotion & back benefits of the above named appellant can be considered while CPLA is pending in the August Supreme Court of Pakistan against the judgment ibid dated 16-11-2022 or otherwise? And

b. If the August Supreme Court of Pakistan decided the case in favor of the appellant, then he will be granted promotion / senionty from the due date, when his junior colleagues were promoted during subsistence period of penalty or
