## REJOINDER ON BEHALF OF APPELLANT IN RESPONSE TO REPLY FILED BY RESPONDENT NO: 1, 2 and 3

Respectfully Sheweth,

### Preliminary Objections:

- 1. Preliminary objections raised by answering respondent are erroneous and frivolous.
- 2. The appellant has strong cause of action and for that matter locus standi to file the service appeal.
- 3. The appeal is very much maintainable in its present form.
- 4. The appellant has approached the Hon'ble Tribunal with clean hands and nothing has been concealed from the Hon'ble Tribunal.
- 5. All the essential facts have been incorporated in the service appeal and all the necessary parties have been arrayed.
- 6. The present appeal is based upon bonafide intention. The appeal is well within time.

  The Hon'ble Tribunal has exclusive jurisdiction to entertain the instant appeal.
- 7. That no estoppel operates against the appellant in the circumstances.
- 8. The appellant has timely raised the issue at appropriate forum.
- 9. The judgment in Service Appeal No: 567/ 2018 and 339/2017 dictate that the Appellants in Service Appeal No: 1831/2009 who have already been availed an upgradation from BS-16 (Statistical Investigator) to BS-17 from 01.5.1977 vide Notification dated: 17.02.2010 are not Statistical Officers and their Seniority shall be maintained separately (Annex:-D in main appeal).

#### Facts:

- 1. Correct.
- Correct as the Respondent has verified the claim of the Appellant.
- 3. Reply under Para-2 above is re-iterated.



- Correct as the Respondent has verified the claim of the Appellant. However, the Department is hesitant to reply objectively as they have no plausible justification for denial of the fact.
- Incorrect. The Appellant had challenged the re-designation of the post of Statistical Investigator BS-16 as Statistical Officer after its upgradation to BS-17 and resultantly the re-construction/amalgamation of the seniority wherein the Statistical Officers Supervisory (BS-17 + Rs; 150/= P.M) were placed junior to their subordinates (erstwhile Statistical Investigator BS-16) in the Department through Service Appeal No: 339/ 2017 & 567/2018. The Hon'ble Tribunal accepted both the appeals. Para-16 of the judgment placed at annexure-D in the main appeal reads;

16- ......The appellant along with his other batchmates stands senior to their erstwhile juniors and shall be considered first for promotion to the next grade,......

- ii) The Appellant was promoted to BS-18 vide notification dated 29.01.2021 whereas the colleagues of the Appellant who benefitted from the Up-gradation to **BS-18** (Personal) w.e.f 27.7.2010 were promoted to **BS-18** in 2018 & 2019, BS-19 in 2019 and **BS-20** in 2021 (Annex:-I).
- The judgment dated 26.7.2010 in Service Appeals No. 1831 to 1843/2009 and 1856 to 1862/2009 (Annex:-B in main appeal) is not specifically in favor of the Appellants therein but in general with respect to the Statistical Officers in the Department. The operative Para-10 of the judgment reads,

10- ............ The Department may submit a summary for re-designation/ restructuring of the post of Statistical Officer at par with District Soil Conservation Officer, Crops Reporting Services, which has been upgraded by the Government of Punjab.

Therefore, deprivation of the Appellant from the benefits of up-gradation to BS-18 (Personal) w.e.f 27.7.2010 is against the wording and spirit of the judgment dated 26.7.2010.

6. Incorrect, hence denied. The Respondent Department on one hand admits in Para-5 of their reply that "the colleagues of the appellant were granted personal up-gradation to BS-18 on the basis of having no chance of promotion, whereas the appellant has recently become entitled for promotion to BS-18......" But in contrary to the said statement, the Respondents take another plea in Para-13 of the "Facts" and Para-A & F of the "Grounds" that the officer is not "Similarly placed Person". This is blowing hot and cold in one breath on part of the Department. If the Appellant is not similarly placed person then how they placed his seniority with them (Statistical Officers). The same point has also been elaborated in Para-5 above that some of these colleagues were promoted to BS-20 whereas the Appellant being recruited in BS-17 who remained their senior and was allowed a single promotion to BS-18 in April 2021, just before his retirement on 23.10.2021.

- 7. Incorrect hence denied. Facts quoted in Para 5 & 6 above are vehemently reiterated.
- 8. Incorrect. Mere denial without any grounds or reasons is no denial.
- 9. Facts already admitted hence no comments.
- 10. Reply in Para-5 (iii) above is re-iterated.
- 11. Reply in Para-6 above is re-iterated.
- 12. No comments as the facts have been admitted by the Department.
- 13. Reply in Para-6 above is re-iterated.
- 14. No comments as the facts have been admitted in clear terms by the Department.

#### Grounds

- A. Incorrect. The Respondent Department has already admitted in Para-1 & 5 of their reply that the Appellant is a Statistical Officer serving in the Department since 03.5.1987. Furthermore, the Seniority list issued from time to time since induction of the Appellant in the Department also verifies and confirms the fact that the Appellant is a similarly placed person.
- B. Incorrect, the judgment of Supreme Court cannot be over ruled by the statement that the Appellant is not similarly placed person without any justifications.
- C. Incorrect as the Appellant has been evidently and unambiguously discriminated as some of his similarly placed officers have been promoted even to BS-20 on regular basis. The Department cannot deny their own documents placed at annexure-II above.
- D. The reply of the Department is irrelevant to the claim of the Appellant. Hence denied.
- E. Incorrect. Reply in Para-D above is re-iterated.
- F. Incorrect. Reply in Para-C above is re-iterated.
- G. No comments.

It is therefore, humbly prayed that the reply of Respondent No. 1, 2 & 3 may graciously be rejected and the appeal as prayed for may graciously be accepted with cost




