

### OFFICE ORDER.

**WHEREAS** it was brought into the notice of the Director General, Agriculture Extension, Khyber Pakhtunkhwa that certain illegal/bogus orders have been issued by Mr. Tariq Mehmood, the then District Director Agriculture Extension, Nowshera with the help of Mr. Liaqat Ali, Junior Clerk, O/O District Director Agriculture Extension, Nowshera.

**AND WHEREAS** a fact-finding inquiry was conducted, wherein the appointments/posting-transfer orders were found to be bogus /fake.

**AND WHEREAS**, a Formal Inquiry Committee was constituted by the Competent Authority to conduct full dressed inquiry into the matter as per E&D rules 2011.

**AND WHEREAS**, the Inquiry Committee submitted its report wherein, the charges levelled against the accused officer/official have been proved.

**AND WHEREAS**, the Inquiry Committee has recommended that the District Director Agriculture, Nowshera, should immediately issue termination orders of all the staff appointed through bogus/fake orders.

**NOW THEREFORE**, the Competent Authority in light of the recommendations of the Inquiry Committee communicated by the Directorate General, Agriculture Extension, Khyber Pakhtunkhwa vide letter No.DFO. 4/914/DGA(E) dated 29/02/2024, is hereby terminated the bogus services of the following persons w.e.f date of their illegal entry into Government Payroll System: -

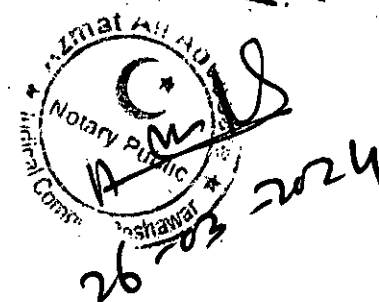
