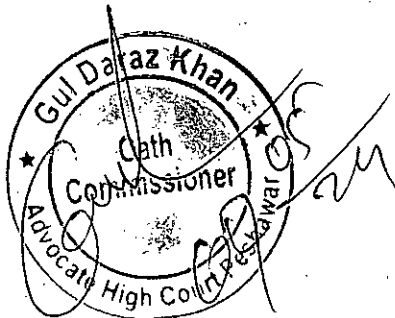



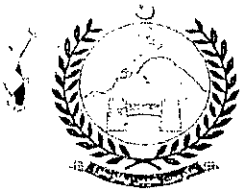
Terms and conditions:-

1. They will get minimum pay of BPS-03 plus usual allowances as admissible under the rules and will be entitled to annual increment as per existing policy.
2. Their services will be considered governed under the Khyber Pakhtunkhwa, Civil Servant Act, 1973 & other rules made there-under for his class of government servants.
3. They will, for all intents and purposes, be civil servant, in the prescribed manner as per existing policy.
4. They would be on probation for a period of one year extendable for another one year as the competent authority desires.
5. Their services are liable to termination on one month's notice from either side. In case of resignation without notice his one-month pay/allowance shall be forfeited to the Government.
6. Their services shall be terminated at any time if any discrepancy is found during the process of verification of documents and certificates et al.
7. They will produce Medical Fitness/age certificates from Medical Superintendent Services Hospital Peshawar.
8. They will submit their arrival to the undersigned within 15 days of receipt of this order, otherwise order will be deemed cancelled.




