<u>RESPECTFULLY SHEWETH:</u>

PRELIMINARY OBJECTIONS.

- 1. That the appellant has got no cause of action and or locus standi to file the instant appeal because no departmental appeal has been filed against the final order i.e. issuance of final joint seniority list while they have challenged the regrettable order passed on the objections filed against the tentative joint seniority list thus the appeal is liable to be dismissed on this score alone.
- 2 That the instant appeal is baseless, frivolous, vexatious and has been filed to harass the answering respondents. Although the appellant cadre was transferred\adjusted in the tentative joint seniority list to the cadre of the answering respondents but through SSRC rules were not amended for inclusion of the appellant cadre for promotion to the post of Tehsildar although meeting was held so the appeal is liable to dismissed summarily.
- 3. That the present appeal is not maintainable in its present form hence liable to be dismissed because the appellant has concealed the factum of dismissal of application of the appellant moved for adjustment of his name in the joint seniority list of the Assistants and senior scale stenographer of the offices of commissioners and deputy commissioner by the SMBR vide order dated 13.05.2022. Allegedly the name of the appellant was adjusted in the joint tentative seniority list on acceptance of his review petition but in fact there is no order or even note sheet of the SMBR on the basis of which notification dated 01.07.2022 was issued by Asst. Secretary (Estt) Board of Revenue. So the same notification is illegal and void.
- 4. That the appellant has not come to this Honourable Tribunal with clean hands and has supressed material facts from this Honourable tribunal. The appellant was inducted into service as computer assistant in BPS 11. In the year 2010 Govt. of KPK through notification dated 12.07.2010 has upgraded all the existing post of key punch operator (BPS-8)/ data entry operator (BPS-9)/ computer assistant

existing post of key punch operator (BPS-8)/ data entry operator (BPS-9)/ computer assistant (BPS-11) and computer operators (BPS-10) of different pay scales to BPS-12 with the nomenclature of post of computer operator. Later on through notification dated 29.07.2016 (Annex-C) Government of KPK has upgraded and re-designated all existing posts of computer operator and data processing supervisor as computer operator BPS-16. The finance dept. merged all these posts because all these posts fall in the category of technical posts. The appellant cadre i.e. district ministerial cadre service rules (Annex-D) give 40% quota to computer operator for promotion to the post of senior scale stenographer. Once they get promoted to the post of senior scale stenographer then they will get further promotion to the post of Private Secretary as well as Tehsildar. So the appellant cadre is having their own hierarchy of promotion that's why in SSRC meeting held on 30.05.2023 (Annex-E) although Tehsildari and Naib Tehsildari Service Rules, 2008 were further amended but no hierarchy of promotion was given to the cadre of appellant because they are already having two pronged promotion hierarchy.

There are round about 300 Computer Operator working in the offices of D.Cs AND Commissioners but only 13 Computer Operators have been included in the Seniority List of Assistants and SSS (Senior Scale Stenographer). As stated above CO (Computer Operator) will first be promoted to SSS, as such his name will be included in the Seniority List of Assistants and SSS thus he will get promotion to the post of Tehsildar. It is further submitted if senior employee in computer operator (BPS-16) cadre whose name is not included in the List ibid (Seniority List of Assistants and SSS) is promoted to the post of senior scale stenographer (BPS-16) at this stage or later on then his name will be placed in the joint Seniority List of Assistants and SSS below the Computer Operator (Appellant herein).

The answering respondents are in the promotion zone of Tehsildari and Naib Tehsildari Service Rules, 1962 (which were later on amended from time to time) from the beginning i.e. 1962 and still intact. On 26.12.2008 through notification no.32\02\Adm:I\135\SSRC previous rules were superseded by Tehsildari and Naib Tehsildari Service Rules, 2008, in which the answering respondents were also in the promotion zone. Once again on 23.01.2015 through notification previous rules were superseded by Tehsildari and Naib Tehsildari Service Rules, 2015, in which the answering respondents are also in the promotion zone. (Annex-F).

- 5. That the appellant has filed the instant appeal malafidely and to waste precious time of this Honourable Court.
- 6. That appeal of the appellant is premature because through the instant appeal the appellant has challenged the order passed on the objections filed over tentative seniority list which is a step towards final proceeding i.e. issuance of final seniority list which was later on issued and notified by the department but was not challenged by the appellant. Tentative seniority list is issued only for ascertaining the position and considering objections, if any raised by the persons being affected so that a final list, which has element of reliability, be prepared and circulated. Tentative seniority list, except inviting attention for seeking correction, does not create any legitimate basis for conferring right or **basis for cause of action** thus the appeal being premature is not maintainable.

ON FACTS.

1. In reply to Para.1 it is submitted that the appellant was upgraded to BPS-16 on 29.07.2016 having their own two pronged promotion hierarchy while the

answering respondents are in the promotion zone of Tehsildari and Naib Tehsildari Service Rules, 1962 from the beginning i.e. 1962 and still intact in the rules of the year 2008 and 2015.

- 2. Para.2 needs no reply.
- 3. In reply to para.3 it is submitted that the tentative joint seniority list of Assistant/Senior Scale Stenographer of- the offices of the Commissioners and Deputy Commissioners as stood on 31.12.2023 was issued after incorporating the name of the appellant in the joint tentative seniority list in light of Notification dated 01.07.2022 which was issued illegally.
- 4. Para. 4 of the appeal is wrong and incorrect. Further submitted that the appellant raised objections over inclusion of his name in tentative joint seniority which is issued only for ascertaining the position and considering objections, if any raised by the persons being affected so that a final list, which has element of reliability, be prepared and circulated. The name of the appellant is included in the tentative joint seniority list of Assistant/Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners as per Notification dated 01.07.22 which was issued illegally but is still intact. The cadre of the appellant is different cadre so he has no right for insertion in the tentative joint seniority list from the date of his initial appointment because there is neither merger nor restructuring of the department.
- 5. Para.5 of the appeal is wrong and incorrect hence denied. It is further submitted that objections of the appellant were rightly regretted by the Competent Authority being merit less and against the law/rules. The appellant has not challenged joint final seniority list so he is precluded from challenging the intermediate proceeding.
- 6. Para.6 of the appeal is also wrong, incorrect and is against the material facts. The cadre of the appellant is different and he was adjusted in the tentative joint seniority list of Assistant / Senior Scale Stenographer offices of the Commissioners and Deputy Commissioners from different cadre so section-8 of the Khyber Pakhtunkhwa Civil, Servants-Act. 1973. read with Rule-17 of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules, 1989 is not applicable to the case of the appellant thus he has no legal right to disturb the seniority list of the answering respondents. Further section-8 of the Khyber Pakhtunkhwa Civil, Servants-Act. 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil, Servants-Act. 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil, Servants-Act. 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules, 1989 is not applicable to the case of appellant because the department has although committed illegality by inserting/adjusting the name of the appellant in the joint tentative seniority list of the answering respondents cadre but has correctly placed the appellant in the bottom because the appellant cadre has neither been merged with answering respondents cadre nor the department has been restructured.
- 7. In reply to para.7 of the appeal it is submitted that appeal of the appellant is premature. The appellant has not challenged final joint seniority list so has waived his rights if any.

<u>GROUNDS</u>

- A. Ground-A of the appeal is wrong and incorrect. The appellant belong to different cadre and his name was included in the joint tentative seniority list of Assistant/Senior Scale Stenographer of the offices of the Commissioners and Deputy Commissioners on his own request from 01.07.2022 although issued illegally (From the date of Notification) because he has no right to disturb the seniority of the others employees in whose list he was inserted\adjusted. Further there is no merger nor restructuring of the department
- B. Grounds-B of the appeal is wrong, incorrect and is against the material facts. The department has although committed illegality by inserting\adjusting the name of the appellant in the joint seniority list of the answering respondents cadre but has correctly placed the appellant in the bottom because the appellant cadre has neither been merged with answering respondents cadre nor the department has been restructured so the law on the subject has strictly been followed and the objections of the appellant were rightly regretted however detail reply has been in reply to para-6 above.
- C. Ground-C of the appeal is also wrong and incorrect. It is further that the seniority of the appellant was determined in the light of the law on the subject. The appellant cadre being different cadre was inserted in the cadre of answering respondents on their own choice so he cannot claim seniority over answering respondents. Seniority amongst the same cadre is to be determined from the date of regular appointment. So section-8 of the Khyber Pakhtunkhwa Civil, Servants-Act. 1973 read with Rule-17 of the Khyber Pakhtunkhwa Civil Servant (Appointment, Promotion & Transfer) Rules, 1989 is not applicable to the case of appellant because the department has although committed illegality by inserting\adjusting the name of the appellant in the joint seniority list of the answering respondents cadre but has correctly placed the appellant in the bottom because the appellant cadre has neither been merged with answering respondents cadre nor the department has been restructured. Further the Notification dated 01.07.2022 although issued illegally is still intact through which the name of the appellant was incorporated in the joint tentative/final seniority list of Assistant/ Senior Scale Stenographer of the offices of the Commissioners and Deputy Commissioners. Very recently SSRC meeting was held on 08.08.2023 (Annex-G) for deliberations over proposed amendments for inclusion of the HVC which is a different cadre for promotion to the post of Tehsildar wherein after threadbare discussion it was unanimously concluded to include HVC for promotion to the post of Tehsildar but would be placed at the bottom of seniority list.
- D. Ground-D of the appeal is wrong and incorrect. The appellant has not divulged complete facts. Under Tehsildari and Naib Tehsildari Service Rules, 1962 answering respondents are in promotion zone from the beginning and even in the rules of the year 2008 and 2015 the answering respondents are in promotion zone while in the case of the appellant although the appellant cadre was transferred\inserted\adjusted in the tentative joint seniority list to the cadre of the answering respondents but through SSRC rules were not amended although meeting was held so there is no case of discrimination of the appellant.

- E. Ground-E of the appeal is incorrect. The appellant has been treated in accordance with law/rules on the subject.
- F. Ground-F of the appeal is wrong and incorrect. No rights of the appellant have been infringed.
- G. In reply to Ground-G it is submitted that the answering respondents may kindly be allowed to rebut any oral assertions if raised at the time of arguments.
- H. Ground-H of the appeal is wrong and incorrect. The appeal being premature is liable to be dismissed.

Keeping in view the above, the appeal of the appellant having no merits may very graciously be dismissed with costs.

ORDER.

1. Facts of the case are that the Peshawar High Court has disposed off Writ Petition No. 3087-P/2019 with I.R with CM No. 277-P/2020 with Chief Minister No. 532-P/2021 with CM No. 2331-P/2021 with the direction to look into the Petitioner's application and decide the same in accordance with law and rules on the subject within a period of two months positively.

2. In compliance with the order of hon; ble Peshawar High Court the petitioners Azhar Iqbal Mughal etc. Computer Operator s were called for personal hearing on 18.04.2022 before the Senior Member, Board of Revenue.

The applicants contended that they were appointed as Computer Assistants and 3. lateron were merged together with the post of Key Punch Operator (BPS-08), Date Entry Operator (BPS-09) and Computer Operators (BPS-10) vide Finance Department Notification dated 12.07.2010. That all these different categories were illegally merged and were given the nomenclature of Computer Operator and were upgraded with a unified BPS-12. Further contended that again the post of Computer Operator (BS-12) were merged with the post of Data Processing Supervisor (BPS-14) and were upgraded to (BPS-16) with the nomenclature of Computer Operator vide Finance Department Notification dated 29.07.2016. That the applicants were initially appointed as Computer Assistants and the nature of job was the same as that of office Assistants. That by having illegal and imprudently been merged with the distinctly line cadres in a unified scale and similar nomenclature, the petitioners have been envisaged with formidable consequences as having no further prospects of any further promotion as against Office Assistants who got tremendously bright future as having service structure of getting further promotion as Superintendents/Tehsildars under 15% quota in Tehsildari Rules, 2015. As the nature of job of the applicants is same as that of Assistants therefore, the applicants may be merged with the seniority of Assistants in the office of concerned Deputy Commissioners to get benefits of legal promotions.

4. Applicants heard and record of the case perused which revealed that the applicants initially were appointed against the post of Computer Assistants. Lateron they were merged together with the post of Key Punch Operator (BPS-08), Date Entry Operator (BPS-09) and Computer Operators (BPS-10) vide the Finance Department Notification dated 12.07.2010. The post of Computer Operators (BS-12) were again inerged with the nomenclature of Computer Operator vide Finance Department (BPS-16) with the nomenclature of Computer Operator vide Finance Department Notification dated 29.07.2016. The Finance Department merged the posts as these were fall in the category of technical posts. The District Cadre Ministerial Service Rules revealed that the Computer Operators have 40% quota for promotion to the post of Senior Scale Stenographer. Once they promoted to the post of Senior Scale Stenographer BS-16, they will get further promotion to the post of Private Secretary as well as Tehsildar.

5. Furthermore, the merger Notifications were issued by Finance Department which were not challenged by the petitioners till 2018. Likewise, inclusion of Computer Assistant in the seniority of the Assistants of the District is not the mandate of Board of Revenue as all these technical posts were merged by the Finance Department. The applicants have no locus standi to agitate the merger notification issued by the Finance Department before this Department, therefore the applications of the applicants having no merit are rejected/filed.

The Chair welcomed participants and formally spelled out the purpose of the meeting. Thereafter, agenda items of the following departments were discussed in detail and the representatives of the departments were asked to brief the forum on their respective agenda items as under.

Board of Revenue, Revenue & Estate Department.

The representative of Board of Revenue, Revenue & Estate Department apprised the forum that as per existing Service Rules of Tehsildar (BPS-16), fifty five percent (55%) share of promotion on the basis of seniority-cum-fitness goes to Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar with at least three (03) years' service as such. However, there is only one (01) post viz. Head Vernacular Clerk (HVC) (BPS-15), in Commissioner Office Hazara having no service structure. It is therefore, imperative that avenue of promotion may be provided to Head Vernacular Clerk (HVC) on account of having the same scale as that of Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar; thus the same may be included in the fifty five percent (55%) share for the purpose of promotion of the incumbent to the post of Tehsildar (BPS-16). In the wake of promotion of the incumbent, the post of Head Vernacular Clerk (HVC) shall be

abolished as HVC is the only post in the whole Revenue & Estate Department.

One of the members raised a query that in case the post of Head Vernacular Clerk (HVC) is included in the joint seniority list of Naib Tehsildar, District Revenue Accountant, District Kanungo and Sub-Registrar what would be the position of seniority of the incumbent Head Vernacular Clerk (HVC). In reply to which majority of the members opined that in that scenario the incumbent Head Vernacular Clerk (HVC) would be placed at the bottom of the joint seniority list.

After threadbare discussion, the forum unanimously agreed to the proposed amendments in the existing Service Rules of Tehsildar (BPS-16) as (Appendix-I)

After threadbare discussion, the forum unanimously agreed to the proposed amendments in the existing Service Rules as per (Appendix-II)



That when the case was fixed for hearing before your goodself office in the light of the directions of the Honorable Peshawar High Court Peshawar, instated of giving a benigene consideration, the same have simply been turned down by your goodself order dated 1305.2022 (copy annexed as Annexure "C".
- 5. That feeling aggrieved and being occupying the parental Chair, your goodself is once again being approached by the petitioners for reviewing the order dated 13.05.2022 (Annexure "C) upon the following grounds.
- a. That the Local Government System was introduced in the Year 2001 with the inception of the Local Government System, District Coordination

Officers came into being. In the DCO's Establishment, posts of Computer Assistants (BPS-11) were created under the title of Computer Assistant, which were equivalent to Office Assistant BPS-11 of that time.

- b. That the appointment criteria, qualification and other eligibilities for both posts ie Computer Assistant and Office Assistant. Subsequently the posts of Computer Assistants and Assistant were simultaneously upgraded.
- that initially, the title of the post under which the petitioners were appointed c. was Computer Assistant, but later on by virtue of Notification bearing No. KC/FD/SO(FR)/7-3/2001 dated 12.07.2010 issued by Government of Khyber Pakhtunkhwa Finance Department Peshawar, the nomenclature of the post was changed as Computer Operator, whereby the Computer Assistant who were initially appointed effected due to this introduction of new title as the merger of the post under new title as Computer Operator instated of Computer Assistant effected the promotion prospect of the Computer Assistant, who were primarily appointed as Computer Assistant with the intent to equate them vis-à-vis Assistant, As no structure was framed meaning by they shall be treated under the prevalent appointment promotion and transfer rules-1989 by providing them equal opportunities for promotion parallel to Assistant of Board of Revenue working either in Provincial Offices, Divisional Offices or District Offices of worthy SMBR, Commissioners and Deputy Commissioners respectively.
- d. That it is pertinent to mention here that the Computer Assistant BPS-11, KPOs, DEOs, Cos (BPS-8,9,10) were merged and titled as Computer Operator (BPS-12) vide Notification bearing No. KC/FD/SO(FR)/7-3/2001 dated 12.07.2010 issued by Government of Khyber Pakhtunkhwa Finance Department, which is amounting to injustice by thwarting the promotion prospect of the petitioners.
- e. That the irony of fate is that initially when the posts of Computer Assistant were crated it was meant as step brother of Office Assistant and for the same purpose not only the nomenclature was assigned the same, but rather was given and placed in the same BPS-11. This brotherhood was devastated when up-gradation of the KPO, DEO and Computer Operator were upgraded. Now when this cadre of KPO, DEO and CO were upgraded, the cadre of the petitioners was separated from Office Assistant and was brought and clubbed together with these newly upgraded positions in a gleamingly illegal and void manner.
- f. That the nature of job for which the Computer Assistant had been recreated remains the same in-spite of being clubbed together with distinctly lying cadre under the common title of Computer Operator as that of Office Assistant for all intents and purposes including but not limited to Office



Assistant training, Office Assistant Jobs description and Office Assistant Job responsibilities whether it be not noty or any other responsibility assigned to Office Assistant.

g. That inspite of all these facts and circumstances the case of the petitioners was turned down for no good reason.

h. That your goodself office is the only competent forum of the instant issue and as per law only the concurrence of Finance and Establishment Department are required otherwise the proposal for subject matter, its justification, requirements and essentialities as well as approval all within the competency of your goodself office whose examples are lying in the office of your very goodself office whether it is the creation / reservation of the 20% quota for the Post of Tehsildar for Office Assistant or its further bifurcation between Office Assistant of Board of Revenue and Commissioner / Deputy Commissioner Offices or whether its the creation / reservation of 5% quota of the Post of Tehsildar for Office Assistant working in the office of Senior Member Board of Revenue. In all these cases this is your goodself office which is competent forum in principle.

In the light of submission mentioned above, your goodslef is pleased to gracious enough to review and revisit order dated 13.05.2022 and got it setaside and by doing so the petitioners be bring at par with Office Assistant by separating them from Computer Operator and bring them in the joint seniority list of Office Assistant and Senior Scale Stenographer in the office of Commissioners / Deputy Commissioners with further prayers of paving ways for further promotion to the post of Superintendent / Tehsildar with same ways as that of Office Assistant with all back benefit since from the date of initial appointment.


