order dated 24.08.2023, he was dismissed from service; that feeling aggrieved, he filed departmental appeal on 28.08.2023, which was converted into that of removal from service vide impugned appellate order dated 14.11.2023, hence, the instant service appeal.

- 2. On receipt of the appeal and its admission to full hearing, the respondents were summoned, who put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.
- 3. We have heard learned counsel for the appellant and learned Deputy District Attorney for the respondents.
- 4. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order(s).
- 5. Perusal of record reveals that the appellant while serving as Primary School Teacher, was issued show cause notice on the basis of charges, which are as under:
 - "1. You have submitted fake degree of M.Ed as verified by the University of Peshawar vide No.7355/M/Secrecy dated 13.06.2023.
 - 2. You have concealed material fact from the high ps.
 - 3. You were inefficient.
 - 4. You were guilty of misconduct."

On the basis of the above mentioned charges, he was dismissed from service vide impugned order dated 24.08.2023. However, the appellant filed departmental appeal to the appellate authority, who converted the penalty of dismissal from service into that of removal from service vide
