12. Unauthorized payment of Ph.D allowance without verification, worth Rs. .. (0.930 million.

According to finance department PhD allowance is admissible to officials/officers having the requisite qualification.

During audit of the accounts record of the Directorate of Archives & Libraries, Khyber Pakhtunkhwa, Peshawar, for the FY 2022-23, it was observed that the Directorate of Archives and Libraries extended approval of Ph.D allowance to Mr. Muhammad Ashfaq, the Librarian, BPS-18. Audit has the following observations.

1- Approval granted without getting verification of the Doctorate Degree from the university concerned.

2- The officer concerned joined this Directorate on 18-04-1994 and has got the said degree during his service period on 16.3.2016, therefore, he is required to submit his attendance sheet along with his degree. The officer has drawn Rs. 0.930 million as PhD allowance wef 16.3.2016 to December 2023 (10000 x 93)

The lapse occurred due to weak internal control and mismanagement.

When pointed in December 2023, the Management replied that detailed reply will be furnished after scrutiny of record

Audit recommends that verified degree may be produced from the competent forum otherwise the Ph.D. allowance be discontinued and recovery of Rs. 0.930 million may be made.

During audit of the accounts record of the Directorate of Archives & Libraries, Khyber Pakhtunkhwa, Peshawar, for the FY 2022-23, it was observed that Books for Rs. 37.711 million have been purchased from the various firms. Following points needs justification: -

- Purchase was not made through the committee constituted by the Secretary Higher education.
- 2 Physical verification of books was not carried out by the committee constituted by the Director Archives and libraries vide no. 133/2/24/DA & L/dated 22.01.2021.
- No requisition or demand of books from institution, colleges, students' visitors, scholars are available on record.
- 4 There was certificate of physical inspection committee on the bills.

The lapse was occurred due to non-adopting proper procedure for the purchase of books.

When pointed in December 2023, the Management replied that detailed reply will be furnished after scrutiny of record

Audit recommends detailed investigation and fixing the responsibility on the person(s) concerned and taking action against them as required.
