JUDGMENT

RASHIDA BANO, MEMBER (J): The instant service appeal has been instituted under section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as below:

“It is, therefore, humbly prayed that on acceptance of this service appeal,

- a. **Set aside the impugned office dated 26.07.2023 and be declared ass illegal, unlawful, without lawful authority and thus is of no legal effect and hence liable to be reversed.**
- b. **An appropriate direction be issued to respondents to withdraw/recall the impugned office order No. SO(111)/HED/1-3/2023 DATED 26.07.2023.**
- c. **The respondents be directed to restore-back the appellant at her previous posted station i.e GGDC**

Bacha Khan or GGDC Gulshan Rehman Peshawar station along with all back benefits accrued to the appellant. Any other relief, not specifically prayed for in the circumstance of the case may be passed in favour of the appellant.”

2. Brief facts of the case, as given in the memorandum of appeal are that appellant was appointed as Lecturer BPS-17 upon the recommendation of Khyber Pakhtunkhwa Public Service Commission vide order dated 17.08.2018 and was performing her duty upto the entire satisfaction of his superior; that appellant was transferred from GGDC No.1 Charsadda to GGDC Zaryab Peshawar vide order dated 26.09.2019; that she was transferred from GGDC Zaryab Peshawar to GGDC Timergara vide order dated 30.11.2020; that she was again transfer from GGDC Timergara to GGDC Tangi vide order dated 20.01.2021; that she was again transferred GGDC Tangi to GHEC Pirpai Nowshera on 31.07.2021; that after spending s9ix months she was transfer to GGDC Bacha Khan Peshawar; and that once again for sixth time she was transferred from GGDC Bacha Khan Peshawar to GGDC Khan Kohi Nowshera on 26.07.2023. Feeling aggrieved, she filed departmental appeal on 03.08.2023 which was not responded to, hence the instant service appeal.

3. Respondents were put on notice who submitted written replies/comments on the appeal. We have heard the learned counsel for the appellant as well as the learned District Attorney and perused the case file with connected documents in detail.

4. Learned counsel for the appellant argued that that the impugned office order dated 26.07.2023 is illegal, wrong, based on malafide, without cogent reason and against the fundamental rights of the appellant, hence liable to be set aside. He further argued that impugned transfer order was not in public interest as required under the posting/transfer policy, therefore, the same is not tenable and is liable to be set aside. He contended that impugned notification

has neither been issued in the public interest nor in the exigencies of public service rather issued on the basis of political interference, hence liable to be set aside.

5. Conversely, learned District Attorney contended that appellant had been treated in accordance with law and rules. He further argued that appellant was transferred from GGDC Bacha Khan to GGDC Khan Kohi Nowshera vide notification dated 26.07.2023 in the best public interest. He further contended that the posting/transfer at one's own choice is not the vested right of Civil Servant under Section 10 of Civil Servant Act, 1973, the civil servants is liable to serve anywhere where competent transferred/posted her/him.


6. Perusal of record reveals that appellant was appointed on 17.08.2018 and was posted at GDDC No.1 Charsadda, whereafter she was transferred to GGDC Zaryab Colony Peshawar vide order 26.09.2019. She was again transferred from GGDC Zaryab Colony Peshawar to GGDC Timergera vide order dated 30.11.2020, then the Tangi Charsadda vide order dated 20.01.2021, on 20.04.2021 from Pirpia Nowshera to GGDC Bacha Khan Peshawar. Now again vide impugned order dated 26.07.2023 appellant transferred to GGDC Khan Kohi, Nowshera. It is pointed out that one Ms. Busry was posted three months later from appellant when post of lecturer in Law was filled and occupied by the appellant. Ms. Busry used to teach Urdu to students and not Law which fact is confirmed by representative of respondents. So in our humble view, premature transfer of the appellant is not in the interest of students to whom the appellant was teaching. Here in this case public interest lies to allow appellant to continue teaching Law subject to the students. Ms. Busry will have to be adjusted at some other post in the said college or in some other college of Peshawar in her own subject of Law.




7. For what has been discussed above, we are unison to set aside impugned transfer order to the extent of appellant with direction to permit her to complete her normal tenure with further direction to adjust Ms. Busry at Peshawar. Costs shall follow the event. Consign.







Respectfully Sheweth:

1. That the Appellant very implore for permission to plead her grievances at the hands of respondents and seeks solace thereto, as follows:
2. That since the date of appointment i.e 17/08/2018 of appellant is service, as performing her official duties to the best of her ability and to the entire satisfaction of her superior. (Copy of appointment is attached as annexure "A").
3. That the appellant was initially transferred after 13 months vide office order dated 26/09/2019 from GGDC No.1 Charsada to GGDC Zaryab Peshawar. (Copy of Office Order dated 26/09/2019 is attached as Annexure "B").
4. That after 14 months the appellant was transferred for second time vide office order dated 30/11/2020 from GGDC Zaryab Peshawar to out of zone GGDC timargara. (Copy of office order dated 30/11/2020 is attached as annexure "C")

5. That the appellant hardly served at Timargara station just after 1 month and 20 days, on 20.01.2021 she was again transferred from the GGDC Timargara to GGDC Tangi Charsada. **(Copy Office order dated 20/01/2021 is attached as annexure "D")**.
6. That after six months the appellant again transferred in the same year from GGDC tangi Charsada to GHEC Pirpia Nowshra on dated 31/7/2021. **(Copy of office order dated 31/07/2021 as annexure "E")**.
7. That after spending six months in the said station the appellant transferred for fifth time vide office order dated 20/04/2022 on sanction post from GHEC Pabbi Nowshra to GGDC Bacha Khan Peshawar. **(Copy of office order dated 20/04/2022 is attached as annexure "F")**
8. That the appellant once again for six time on dated 26/07/2023 transferred from GGDC Bacha Khan to GGDC Khan KOHI Nowshera. **(Copy of impugned office order dated 26/07/2023 is annexure "G")**
9. That feeling aggrieved from the act of the respondent No.2, the appellant on dated 03/08/2023 after obtained the copy of said office order dated 26/07/2023 submitted a representation to Respondent No.1 but no positive step has been taken by respondents till date. **(Copy of Departmental representation is attached as Annexure "H")**
10. That thereafter the appealant file a writ petition for implementation of notifications regarding bane on transfer and posting but hounerable Peshawar high court Peshawar on 6/09/2023 dismissed the same due to lack of jurisdiction. **(Copy of writ petition and order/judgment dated 06/09/2023 as Annexure " I")**
11. That feeling aggrieved from the act of the respondents now the appellant has no other adequate remedy except to file the instant Service Appeal on the following grounds amongst others:

GROUND S:

- A. That the impugned Office Order dated 26/07/2023 of Respondent No.2 is illegal, wrong, based on malafide, without cogent reasons based on political high handedness and against the fundamental rights of the Appellant, hence liable to be struck down and reversed.
- B. That neither the Appellant has committed any wrong nor has completed her tenure therefore, on ther score alone the impugned transfer order needs to be reversed as it was purely made on malafide and intervention of the local politicians whereas it is high time that the trend of seeking interference and intervention of such like political figures be discouraged in line with the dictum so laid down by the superior judiciary.

- C. That the transfer and posting policy approved by the competent authority says that all postings/ transfers shall be strictly in public interest for three years and shall not be abused and misused to victimize the government servant however, most unfortunately, the government servants are always been made scapegoat so as to please the ruling party figures. It is important to mention the that the Appellant had hardly completed not more than 13 months tenure on the same station whilst transferred on the behest of the political leaders.
- D. That there are placement committees in different departments who recommend different officers to be posted and transferred against different posts but most unfortunately in case of the Appellant none has been contacted and consulted about and all of a sudden in hasty and hefty manner impugned transfer order was issued. And the appealant in her short tenure of 5 years and 02 months time and again transferred for six time which is against the fundamental rights and as well as transferred policy of civil servants.
- E. That the impugned notification has resulted into visible injustice to the Appellant, as the impugned office order for transfer dated 26/07/2023 has been passed without any legal or plausible justification, hence liable to be reserved and set aside on the aforementioned grounds.
- F. That the August Supreme Court of Pakistan has held in the case of Syed Mamood Akhtar Naqvi etc Vs Federation of Pakistan and others, reported as PLD 2013 Supreme Court 195 that matter of posting and transfer of civil servants cannot be allowed to be dealt with in an arbitrary manner.
- G. That the said respondents have got no authority whatsoever to issue such an illegal transfer order.
- H. That the appellat was transferred against vacant/sanction post lecture in law on dated 20/04/2022 from GHEC pirpia Nowshera to GGDC bacha khan kohat road and after about three months one of another lecture in law transferred GGDC bacha khan Peshawar on surplus post/ wrong post she belong to zone 1. In such like situation if the government need to transfer civil servants/ employees will transfer surplus candidate but due to political approach the surplus candidate save herself from transferred and spent whole of her tenure in district Peshawar and the appealant again for sixth time transferred to nowshra.
- I. That the respondents are travelling way beyond the scope and approach adopted for others thus the approach adopted for the Appellant is in violation of the Article-10-A and 25 of the Constitution of Islamic republic of Pakistan, 1973.
- J. That the impugned order is without jurisdiction and is clearly a colorful exercise of authority.

- K. That even, otherwise, this Hon'ble Tribunal being the constitutional court of the province is vested with the authority and jurisdiction to provide efficacious and appropriate remedy to the Appellant.
- L. That any other grounds will be raised at the time of arguments with the prior permission of the Hon'ble Tribunal.


It is, therefore humbly prayed that on acceptance of the Service Appeal.



Change report should be submitted to all concerned. The Director, Higher Education, Khyber Pakhtunkhwa, Peshawar should furnish a certificate to the effect that the appointees have joined their posts or otherwise, after one month of the issue of this Notification.
- iv. In case of disciplinary matters Khyber Pakhtunkhwa, Civil Servants Act.1973 and Khyber Pakhtunkhwa, Civil Servants (Efficiency & Disciplinary) Rules, 2011 shall be applicable.
- v. They will be on probation for a period of 01 year extendable for another one year.
- vi. They will undergo mandatory training for the purpose of promotion, as the case may be.
- vii. They will get pay i.e. initial pay of BPS-17 including usual allowances as admissible under the rules. They will be entitled to annual increment like other Civil Servants.

1. That the petitioner is the citizen of Pakistan and presently serving as lecturer in Law (BPS-17) GGPS Bacha Khan, Peshawar.
2. That the Election Commission of Pakistan has issued a notification dated 22.01.2023, wherein a complete ban was imposed on transfer & posting of officers in all

departments. (Copy of Notification dated 22.01.2023 is Annex "A")

3. That the Provincial Govt. also issued Notification dated 29.05.2023 imposing complete ban on posting/ transfer in the departments. (Copy of Notification dated 29.05.2023 is Annex "B")
4. That the petitioner was transferred to Peshawar on dated 20.04.2022 and hardly served at Peshawar for 13 month, whereafter vide impugned order dated 26.07.2023, she was again transferred prematurely to another District (Nowshera). It is also to be mention here that petitioner has been made a rolling stone and was transferred five times during last 05 years, which shows malafide on the part of respondents. (Copy of impugned transfer order dated 26.07.2023 is Annex "C")
5. That petitioner approached the respondents against the void illegal and unlawful transfer order, but of no avail. (Copy of representation appeal is Annex "D")
6. That feeling aggrieved and having no other adequate alternate remedy the petitioner now prefers the instant writ petition on the following grounds inter-alia.

GROUNDS

- F. That vested right of petitioner as guaranteed by the Constitution of Pakistan have been violated.
- G. That any other ground, which has not been taken in the instant petition would be taken at the time of arguments with the permission of this Hon'ble Court.

It is, therefore, humbly prayed that on acceptance of this writ petition, the respondents may graciously be directed to:-

- i. Implement the notifications issued by Election Commission of Pakistan as well as Provincial Govt. whereby complete ban was imposed upon transfer/ posting in all departments.
- ii. Withdraw the impugned transfer order dated 26.07.2023 being void, premature, issued during ban period and allow the petitioner to serve on the post at Peshawar.
- iii. Any other remedy deemed appropriate in the circumstances and not specifically asked for
