## JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: Brief facts of the case as alleged in the memo and grounds of appeal are that appellant was appointed as Theology Teacher and posted at GHS Pattan District Kohistan vide order dated 07.10.1996; that the appellant was transferred

from District Kohistan to District Swabi and posted at GHS Kadar Swabi vide order dated 31.07.2006 where he took over charge of the post on 02.08.2006; that the appellant had land dispute with his relatives who threatened him; that the appellant submitted application for three years leave without pay which was duly forwarded by the Headmaster concerned; that appellant after resolving his land dispute, came to the school for joining his duty but he was not adjusted.

02. Feeling aggrieved, he filed departmental appeal on 10.10.2019 which was not responded, hence, he filed the instant service appeal.

03. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defense setup was a total denial of the claim of the appellant.

04. We have heard learned counsel for the appellants and learned District Attorney for the respondents.

05. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned District Attorney controverted the same by supporting the impugned order(s).

06. The appellant contends that he was employee of the respondent department and was appointed as Theology Teacher (TT) on 07.10.1996 and that he was transferred from Kohistan to Swabi vide order dated

31.07.2006. That there arose a land dispute between the appellant and his relatives, due to which, he filed application for three years leave without pay, but there is no order on the file which could show that such leave was ever granted to him. There is an appeal of the appellant made to the Director, Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar on 10.10.2019, wherein, the appellant has admitted his prolonged absence from duty. In the reply of respondents No.1 to 3, it was pointed out that appellant belonged to District Swabi but claimed to have been appointed in District Kohistan. It was then, the DEO (Male) Kohistan was made as party. The DEO (Male) Kohistan submitted reply, whereby, the very appointment order of the appellant was declared as fake & bogus.

07. The above being the position of this case, we see no merits in it and dismiss it with costs. Consign.
