JUDGMENT

KALIM ARSHAD KHAN, CHAIRMAN: According to the appeal, the appellant was appointed as Primary School Teacher (BPS-07) vide Notification dated 16.10.2004 and vide order dated 05.06.2006, the post of Primary School Teacher was up-graded from BPS-07 to BPS-09 with effect from 26.10.2004 and later further up-graded from BPS-09 to BPS-12 with effect from 02.12.2012. The appellant was promoted to the

post of PSHT (BPS-14) vide Notification dated 22.10.2013, however, Sub-Divisional Education Officer (Female) Town-III, Peshawar recorded entry at page No. 19 of the service book of the appellant by placing her seniority at the bottom of seniority list of PSTs (BPS-12). Feeling aggrieved, the appellant filed departmental appeal on 29.01.2020, which was not responded, hence the appellant filed the instant service appeal on 11.06.2020 for redressal of her grievance on the ground that the impugned entry recorded at page No. 19 of her service book was illegal, illogical and arbitrary in nature as well as the impugned entry was made without any reason or government notification.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned but they failed to file written reply/comments despite being given them several opportunities, hence placed ex-parte vide order dated 23.05.2023.

3. The learned counsel for the appellant reiterated the facts and grounds detailed in the memo and grounds of the appeal while the learned Deputy District Attorney controverted the same by supporting the impugned order (s).

4. We have heard the arguments of learned counsel for the appellants as well as learned Deputy District Attorney for the respondents and have perused the record.

5. A perusal of the record would reveal that vide order dated 16.10.2004, the appellant was appointed as Primary School Teacher (BPS-07) in District Mardan. The appellant was promoted from the post of PST (BPS-12) to the post of PSHT (BPS-14) vide Notification dated

22.10.2013. The appellant was transferred from District Mardan to District Peshawar vide order dated 26.12.2013. The appellant has impugned the entry recorded in her service book at page No. 19, whereby she was placed at the bottom of seniority list of PSTs, however, neither order of any authority of any date has been challenged by the appellant through this appeal nor the same has been placed on file by either side. Moreover, there is no denying the fact that as per Inter District Posting/Transfer Policy of the Provincial Government, a person so transferred shall be placed at the bottom of the cadre strength which he joins for the purpose of determining his seniority vis-à-vis other members borne on the cadre, therefore, on transfer of the appellant from District Mardan to District Peshawar, she was rightly placed at the bottom of the seniority list.

6. Consequently, the appeal in hand stands dismissed. Costs shall follow the event. Consign.

2. That vide order dated 05.06.2006 the post of PST has been upgraded from BPS-07 to BPS-09 w.e.f dated 26.10.2004 and later on upgraded from BPS-09 to BPS-12 w.e.f dated 02.12.2012. **(Copy of Notification is attached as Annexure "B")**.
3. That the appellant has been promoted to Senior PST (BPS-14) vide notification dated 22.10.2013. **(Copy of the promotion order is attached as Annexure "C")**.
4. That the respondent No.3 SDEO Town-II (Female) made adverse entry at Page-19 in Service book of the appellant and deviated her from BPS-14 to

BPS-12. (Copy of the Notification is attached as Annexure "D").

5. That the appellant preferred Departmental Appeal/Representation before the competent Authority but no avail, hence in the instant appeal on the following grounds inter alia: **(Copy of the Departmental Appeal is attached as Annexure "E").**

GROUND S:

- A. That the impugned entry in Service Book of the appellant is illegal, illogical and arbitrary in nature, hence needs to be struck down.
- B. That it is beyond comprehension that now the appellant has been devoted from BPS-14 to BPS-12, without any valid reason or Government Notification.
- C. That act of the respondents is misuse of authority and void-ab-initio in the circumstances.
- D. That the impugned entry is based on presumption and there is no legal justification with the respondents.
- E. That any other ground will be raised at the time of arguments with the prior permission of this Hon'ble Tribunal.

Therefore, it is humbly submitted that entry at Page-19 in Service Book of the appellant may please be struck down being illegal and respondents may please be directed to correct the same.

- (6) That the appellant was transferred as senior PST (BPS-14) from GGPS Arif Khan Kali district Mardan to GGPS Malakand Dher District Peshawar vide Director E & S E Peshawar office Endst no. 4419-24/F.No.100 (F)/G Transfer dated 26-12-13, as per spouse policy after marriage of the appellant on her won pay & BPS in the interest of public service and then transferred from GGPS Malakand Dher to GGPS police colony vide S.D.E.O.(F) Peshawar office order Endst no.2090-92 dated 08-09-2014 on own pay and BPS in interest of public service.

In the light of above factual position, it is humbly requested to fix the seniority of the appellant at the bottom of senior PST (BPS-14) rather than PST (bps-12) in the light of above office order of Director E & SE Peshawar at para No-6 as the as the appellant was already promoted from PST (BPS-12) to S-PST (BPS-14) before transfer from district Mardan to district Peshawar.

5. That para-5 it is submitted that when any Govt. teacher (Below-16) is transferred from other district by their own request automatically the seniority of that teacher goes to the bottom of seniority list, furthermore the act of the respondent is according to Law rules and policy.

Grounds:


- A. **Ground-A** is incorrect, misleading and against the facts the respondents are bound to act upon the existing law & rules.



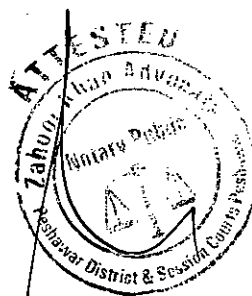


