JUDGMENT

KALIM ARSHAD KHAN CHAIRMAN: Brief facts gathered from the

memo and grounds of appeals are that the appellants was appointed as Senior

Vernacular Teacher (BPS-09) on 30.09.1989; that nomenclature of the post of the appellant was later on changed as Certified Teacher and also upgraded to BPS-14; that due to domestic issues, the appellant was requested for leave which was accordingly granted two years leave with effect from 01.04.2008 to 31.03.2010; that the appellant was belongs to Charbagh District Swat which was the hub of the terrorists those days, and the government servants were particularly at their target; that during those days so many government servants were killed by the terrorists and others including the appellant were threatened that if they perform duties with the government, they will be targeted; that in the circumstances, the appellant was forced to leave the area and shifted at safe place; that in the meanwhile, the appellant alongwith two others teachers while posted to Government High School Shawar Swat, was removed from service vide impugned notification dated 10.08.2011 from the date of absence; that against the impugned order, the appellant preferred departmental appeal on 17.12.2018 which was not responded within statutory period of ninety days, hence, the instant service appeals.

2. On receipt of the appeal and its admission to full hearing, the respondents were summoned. Respondents put appearance and contested the appeal by filing written reply raising therein numerous legal and factual objections. The defence setup was a total denial of the claim of the appellant.

3. We have heard learned counsel for the appellant and learned District Attorney for the respondents.

The appellant was removed from service on 10.08.2011 and he filed departmental appeal on 17.12.2018 and this appeal filed on 17.04.2019, as such not only the departmental appeal but instant appeal before this Tribunal both are barred by time. No plausible explanation is given in the application for condonation of delay on this account, therefore, this appeal is dismissed being barred by time. Costs shall follow the event. Consign.
