

ANY OTHER RELIEF WHICH THIS HONOURABLE COURT DEEM APPROPRIATE MAY ALSO BE GRANTED TO THE APPELLANT.

Respectfully Sheweth:-

Brief facts leading to the instant appeal are arrayed as under;-

1. That appellant was appointed against the vacant post of PST BPS-9 vide order bearing endorsement No.13386-13434 dated 29/08/2009 and is performing as such till date. Copy of appointment order dated 29/08/2009 of the appellant is attached as annexure "A".
2. That appellant earlier took one year (365 days) Extra Ordinary Leave from 01/09/2012 to

31/08/2013 vide letter No.2743-46 dated 04/07/2013. Copy of order dated 04/07/2013 is attached as Annexure "B".

3. That on expiry of said E.O.L the appellant reported for duty vides his duty report dated 14/09/2013. Copy of duty report dated 14/09/2013 is attached as Annexure "C".
4. That on joining duty the appellant was adjusted as PTS at GPS Talhad vide letter No.2818-21 dated 24/09/2013. Copy of order dated 24/09/2013 is attached as Annexure "D".
5. That appellant again sought Extra Ordinary Leave from 23/10/2013 to 15/08/2020 vides his application dated 23/10/2013. Copy of application dated 23/10/2013 is attached as Annexure "E".
6. That the said EOL (Leave without pay) from 23/10/2013 to 15/08/2020 was granted vide letter No.5238-43/F.No.5-1/EB/Leave case PST(M) dated 16/09/2020 and appellant was allowed to join and take over charge as PST at GPS

Muradabad. Copy of inquiry report & order 16/09/2020 is attached as Annexure "F" & "F-I".

7. That the appellant reported for duty and took over charge as PST at GPS Muradabad Haripur on 21/09/2020. Copy of joining and taking over charge is attached as Annexure "G".

8. That the appellant was reinstatement in service vide order dated 16/09/2020, took over the charge on 21/09/2020 and since than the appellant has been performing his duties regularly and satisfactorily as PST at GPS Muradabad without any complaint from any corner. But appellant is not being paid his monthly salary despite his performing official duties in accordance with order dated 16/09/2020 and repeated verbal as well as written requests to his officers. Due to the reason the appellant and his family is under stern financial stresses and passing hard days at the time when prices of edible commodities are speaking with sky. No one is ready to give him even loan. Leaving no venue the appellant approaches your highness with the request to issue some necessary directions to the concerned educational authorities

at District Haripur to pay the appellant his monthly salary with outstanding amount. Copy of attendance register is attached as Annexure "H".

9. That the appellant has also filed departmental representation / appeal but the same has been shelved by the respondents without any proceedings. Copy of departmental appeal dated 26/04/2022 is annexed as Annexure "I"

10. That feeling aggrieved from the above said illegal acts of the respondents, the appellant has now come to this Honourable Service Tribunal with the instant appeal in hand assailing the same being unwarranted at law and facts inter-alia on the following grounds:-

GROUND:-

- a) That the impugned act of respondents is illegal, unlawful, without lawful authority, malafide based on jurisdiction hence liable to be struck down.

- b) That it is fundamental right of the appellant to receive salary for the services being rendered by him.
- c) That the respondents have no lawful authority to withheld the salary of appellant.
- d) That the appellant is the only bread earner of his family who are totally dependent upon him and without receiving salary appellant and his family is suffering hard and unable to meet their daily requirements especially of food. Hence, the impugned act of respondents amount to snatch the bread from the mouth of appellant as well as his family.
- e) That respondents department has led the appellant to the place which is utterly unknown to the principle of Natural Justice, and jurisprudence.
- f) That the matter relates to the terms and condition of service. Therefore Service Tribunal has jurisdiction to entertain the said

service appeal. Beside, service appeal is well within the period of limitation.

- g) That there is no other prompt, efficacious remedy, available to the appellant except the instant appeal.

It is, therefore, humbly prayed that on acceptance of instant service appeal, the respondents may graciously be directed to release the monthly salary of appellant w.e.f 21/09/2020 to till date and onward with all benefits attached with the salary. Any other relief which this Honourable Court deem appropriate may also be granted to the appellant.

Para wise Comments on behalf of respondent No.1 & 3.

Preliminary Objections:

- 1 That the appellant has got no cause of action to file the instant appeal.
- 2 That the appellant has not come to this Honorable Tribunal with clean hands.
- 3 That the Appellant has got no locus standi to file the instant appeal.
- 4 That the appellant has concealed the material facts from this Honorable Tribunal, hence the appeal in hand is liable to be dismissed.
- 5 That the appellant has filed the instant appeal on malafide motives.
- 6 The appellant has filed the instant appeal just to pressurize the respondents.
- 7 That the appeal of the appellant is barred by law and limitation.
- 8 That the appeal is bad for mis-joinder and non-joinder of necessary parties.

ON FACTS

1. Para 1 pertains to the appointment of the appellant which needs no comment.
2. Para 2 pertains to sanction of EOL for 365 days which also needs no comment.
3. Para 3 pertains to reporting to return back on duty by the appellant after the completion EOL for 365 days which also needs no comment.
4. Para 4 pertains to adjustment of appellant at GPS Talhad which also needs no comment.
5. Para 5 is incorrect. The extra ordinary leave of the appellant w.e.f. 23-10-2013 to 15-08-2020 was not sanctioned at that time.
6. Para 6 is correct to the extent of adjustment of the appellant at GPS Muradabad but further process for the release of pay could not be completed because the service book of the appellant was misplaced and the respondent No. 1 has provided the sanction for the preparation of duplicate service book vide order endst: No. 2590 dated 11-06-2021. **(Copy of the sanction letter is attached as Annexure-A)**
7. Para 7 pertains to taking over the charge as PST at GPS Muradabad which also needs no comment.
8. Para 8 is incorrect. The SDEO (Male) Haripur, the Drawing and Disbursing Officer (DDO) concerned has also prepared the source form-II for activation of salary of appellant for the month of January 2021 but the respondent No. 2 has returned the same for the fixation by the Fixation Party as **reported SDEO concerned. (Copies of source form- II and relevant page of service book are attached as B&C)**


9. Para 9 is incorrect. The departmental appeal has not been filed through proper channel. However the SDEO (M) Haripur, the Drawing and Disbursing Officer (DDO) concerned has also sought the guidance vide letter endst: No. 322 dated 19-02-2022 for the verification of service w.e.f. 01-09-2012 till the date. However the then DEO (Male) Haripur in response of the ibid letter has directed the SDEO (Male) Haripur that pay of the appellant will not be drawn till the finalization of inquiry conducted by Worthy Director E&SE Khyber Pakhtunkhwa Peshawar. **(Copies of guidance letter and direction letter are attached as Annexure-D&E)**
10. Para 10 is incorrect. The respondent No. 1 has finally directed the SDEO (Male) Haripur the Drawing and Disbursing Officer (DDO) concerned to release the salary of the appellant and also conducted the inquiry to dig out the facts of the matter. However appeal of the appellant is liable to be dismissed inter alia on the following grounds. **(Copies of salary release order and inquiry letter are attached as Annexure-F&G)**

REPLY ON THE GROUNDS:

- a. Ground "a" is incorrect. The impugned act of the respondents is in accordance with law, rules and policy on the subject.
- b. Ground "b" is incorrect. That the appellant is not entitle to receive salary without fulfilling of codal formalities.
- c. Ground "c" is incorrect. The respondents are not authorize to release the salary without the fulfilling of all codal formalities.
- d. Ground "d" is incorrect. The appellant was not obtained the sanction of EOL within stipulated time period.
- e. Ground "e" is incorrect. The case of the appellant for release of salary is in process which would be finalized after the fulfilling of all codal formalities.
- f. Ground "f" pertains to the jurisdiction of Honorable Service Tribunal. However the appeal of the appellant is time barred.
- g. Ground "g" is incorrect. The appellant is not entitle for any remedy through instant appeal.
- h. That the other points shall be agitated at the time of arguments with the leave of this Honorable Tribunal.

PRAYER

In view of the above made humble submissions, it is most respectfully prayed that on acceptance of foregoing factual position/ Comments, the instant appeal may very graciously be dismissed being meritless.


