MUHAMMAD AKBAR KHAN, MEMBER(E):- The instant service appeal has been instituted under Section 4 of the Khyber Pakhtunkhwa Service Tribunal, Act 1974 with the prayer copied as under;

"On acceptance of the instant appeal the appellant may kindly be granted all back benefits/salaries in the interest of justice."

02. Brief facts of the case are that appellant was serving as Primary School Teacher at District Tank. That her brother was kidnapped by unknown

CANNED KPST Peshawar^{registered} at Police Station Gomal Tank, therefore, she requested for her

transfer form District Tank to District D.I.Khan. That vide order dated

29.11.2019, the appellant was awarded major penalty of removal from

service. Feeling aggrieved, she filed departmental appeal which was accepted and the appellant was reinstated in service, however, the intervening period was treated as leave without pay vide impugned Notification dated 02.10.2020. Feeling aggrieved, from the impugned Notification dated 02.10.2020, she filed departmental appeal on 09.08.2021 which was not responded within the statutory period, hence preferred the instant service appeal on 11.01.2022.

03. Notices were issued to the respondents to submit their reply/comment, however, the responded did not submit reply/comments within the specified time as a result of which their right for submission of reply/comments was struck off vide order sheet dated 18th Jan, 2023.

04. Learned counsel for the appellant contended that the impugned Notification No.6973-76 dated 02.10.2020 issued by respondent No. 3 is illegal, against services law and rules, without jurisdiction; that the services law and rules were not complied, hence the appellant is entitled to receive all the back benefits from the department being innocent; that the appellant has been deprived form salaries of eleven months which is against the norms of natural justice, service rules and departmental policy, hence the appellant is entitled to receive all the back benefits i.e. salaries.

05. On the other hand, learned District Attorney argued that the impugned Notification dated 02.10.2020 was issued after recommendation of the inquiry report. Moreover, the appellant is not a committed person to her job and remained absent from duty without prior leave/permission of the competent authority. He is, therefore, not entitled for salary for the period in which she has not performed duty.

It is admitted that the appellant stopped attending and performing her 06. duties at the school where she was posted citing security reasons after abduction of her brother. She claims to have submitted application for transfer to D.I.Khan and leave for two months and stopped attending school without getting the leave sanctioned by the DEO (F) Tank, the competent authority. The school was shown closed and the teacher (appellant) absent by the Independent Monitoring Unit (IMU) staff in the monthly visit report. On the second inspection visit the school was reported as non-functional by the IMU inspecting staff. The competent authority initiated disciplinary proceedings against the appellant and imposed major penalty of removal from service on her. However, the appellate authority set aside the order of major penalty on the ground of procedural deficiencies in the disciplinary proceedings. The appellate authority reinstated the appellant into service and treated the intervening period as leave without pay so as to regularize the period in which the appellant remained out of service. We observe that the appellant has already been given departmental relief and there no reason available for further relief. Therefore, we find no legal ground to interfere in the appellate order dated 02.10.2020 and as such the appeal stands dismissed. Costs shall follow the event. Consign.

Respectfully Sheweth;

Appellant humbly submits as under;

- 1. That the appellant was appointed in Education Department District Tank and performed her duties with great zeal, zest and to the entire satisfaction of her superiors. In this respect the service record of the appellant is very much evident.
- 2. That the appellant was performing her duties according to service rules. Meanwhile the mother of the appellant had been died; moreover, the brother of the appellant was kidnapped by the unknown culprits, in this respect the FIR#76 dated 25/04/2019 u/s 365 PPC was registered at Police Station Gomal Tank. The appellant submitted an application for leave and also requested for her transfer from District, Tank to District Dera Ismail Khan as there were life threats to the appellant as well as her family but the then EDO (F) Tank has not considered the application of appellant. In this regard the inquiry report is also annexed for ready reference as <u>Annexure-A</u>.
- 3. That it is pertinent to mention here that the then Deputy Commissioner Tank also endorsed the request of transfer of the appellant.
- That ironically the District Education Officer (F) Tank issued a notification No. 8775-82 dated 29/11/2019 vide which the appellant was awarded major penalty of removal from service. Copy of notification dated 29/11/2019 is annexed as <u>Annexure-B</u>.
- 5. That feeling aggrieved, the appellant preferred a departmental appeal before the appellate authority. The appellate authority. The appellate authority. The appellant conducted inquiry through inquiry officer in subject case vide letter No. 667173 dated 10/03/2020. Thereafter the appellate authority, after examine the appeal, the detail report of DEO (F) Tank and inquiry

report of the view that the recommendation are convincing and justified. In the light of recommendations of the inquiry conducted by the appellate authority, the notification No. 8775-82datede 29/11/2019 was set aside and the service of the appellant was reinstated but the service and the intervening period was treated as leave without pay vide notification No. 6973-76 dated 02/10/2020. Copy of the notification dated 02/10/2020 is annexed herewith for ready reference as **Annexure-C**.

That it is pertinent to mention here that the inquiry officer mentioned in his report that service rules and legal proceedings were not compiled in the case of appellant. In this respect the inquiry report is very much evident.

7. That feeling aggrieved by the impugned notification dated 02/10/2020 the appellant preferred a departmental appeal to the appellate authority i.e. respondent#2 in August 2021 which is not decided as yet. Copy of the departmental appeal is annexed as <u>Annexure-D</u>.

That jurisdiction of this worthy service tribunal is being invoked in attending circumstances against the impugned notification No. 6973-76 dated 02/10/2020 issued by respondent no. 3, inter alia on the following grounds amongst others;

<u>GROUNDS</u>

a. That the impugned notification No. 6973-76 dated 02/10/2020 issued by respondent no. 3 is illegal, against services Law and rules, without jurisdiction, in violation of the precedents of Honourable apex courts of the country and is not justifiable for any reason whatsoever.

b. That as the service laws & rules were not complied in case of the appellant, hence, the appellant is entitled to receive all the back benefits from the department being innocent.

BRIEF HISTORY:-

In this regards, I visited the Office of the District Education Officer (Female) Tank on 06/07/2020 to conduct inquiry on the appeal submitted to the Director E&SE Feshawar by Mst. Sadaf Faiz Ullah Ex.PST GGPS Kot Zangbar.

Mst. Sadaf Faiz Ullah has rendered her Services as Primary School Teacher BS-12 at Govt. Girls Primary School Kot Zangbar since 2014. 




