Memorandum:

Kindly refer to Assistant Inspector General of Police Legal, Peshawar Letter No. 1792/Legal dated 26.04.2024 in response to this office letter No. 774/Inv: dated 08.04.2024 on the subject cited above (copy enclosed).

It is submitted that, in light of the Honorable Service Tribunal Peshawar Order & verbal direction on 20.11.2023, arrear pay in respect of the subject official amounting to Rs: 1537103/- was sent to District Account Office, Hangu for completion of further process, but the same was returned with the remarks *that arrear pay sanction from Finance Department KP Peshawar must be obtained* (copy enclosed).

In this connection several correspondences have been made with CPO, Peshawar also has been sought legal advice from Legal Branch, Peshawar. Who finally through above quoted letter advised that, *"It is not mandate of legal branch, CPO. Concerned DPO is advised to take up the matter with Finance Department if needed, through Finance Section"* while Budget Branch CPO Peshawar, through telephonically conversation directed to address the matter to his office so that can be taken up with Finance Department KP, Peshawar.

It is therefore, requested that Finance Department KP Peshawar may kindly be approached to accord sanction of arrear pay of the said official so that the case could be completed, please.

Note: It is further mentioning here that, the above named official has been transferred to Operation Staff District Kurram vide RPO Kohat Office Order Endst: No.2963-74/EC dated 03.04.2024 (copy enclosed). All relevant matters pertinent to his account are to be rested to District Account Office, Kurram. Therefore, the District Police Officer Kurram may be directed to take up the matter henceforth.

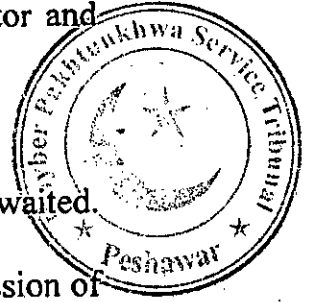
1. That the applicant/Petitioner filed Service Appeal No.862/20170 for Back benefits.
