That respondent #1-3 requests your Honor for remission of said fine on following amongst the other grounds:

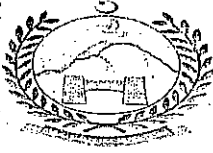
- a. That non submission of parawise comments was inadvertent and not willfully.




