- There are total 50 sanctioned\_posts of Assistants (BRS-16) in the Directorate of Prosecution (Annex-I). Out of 50 posts of Assistant (BPS-16), 38-posts comes to the share of promotion quota @75%, whereas 12-posts comes to the share of initial recruitment @25% as per Prosecution Service Rules, 2010 amended up to 2020. The share of initial recruitment versus promotion quota may be seen at (Annexure-II). Out of 38 posts of promotion quota, 10 Assistants are already working on regular basis, while, 28 Assistants were appointed on acting-charge basis vide separate notification-dated: 08-08-2023, dated:04-03-2021 and dated: 30-01-2023, espectively. Annexure-III, IV & V. Thus, 28 Acting Charge. Assistants (BPS-16) are required to be filled on regular basis.
