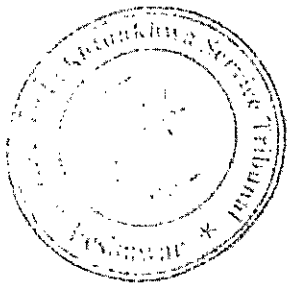



WORKING PAPERS

SUBJECT: PROMOTION/REGULARIZATION CASE OF 28 SENIOR CLERKS (BPS- 14) WORKING ON ACTING CHARGE BASIS TO THE POST OF ASSISTANT (BPS-16) ON REGULAR CHARGE BASIS.

- There are total 50 sanctioned posts of Assistants (BPS-16) in the Directorate of Prosecution (Annex-I). Out of 50 posts of Assistant (BPS-16), 38- posts comes to the share of promotion quota @75%, whereas 12-posts comes to the share of initial recruitment @25% as per Prosecution Service Rules, 2010 amended up to 2020. The share of initial recruitment versus promotion quota may be seen at (Annexure-II). Out of 38 posts of promotion quota, 10 Assistants are already working on regular basis, while, 28 Assistants were appointed on acting-charge basis vide separate notification dated: 08-08-2023, dated:04-03-2021 and dated: 30-01-2023, respectively. Annexure-III, IV & V. Thus, 28 Acting Charge Assistants (BPS-16) are required to be filled on regular basis.
- Under the Khyber Pakhtunkhwa Prosecution Service Rules, 2010 as amended up to 2020, the following method of recruitment has been prescribed for Assistants (BPS-16) (Annex-VI):
