**APPEAL U/S 4 OF THE KHYBER PAKHTUNKHWA SERVICE TRIBUNAL ACT
1974 AGAINST THE ORDER DATED 26/04/2024 WHEREBY
DEPARTMENTAL APPEAL OF THE APPELLANT FILED AGAINST THE
ORDER DATED 28-03-2024 HAS BEEN REGRETTEED.**

PRAYER:-

On acceptance of this appeal the impugned order dated 26-04-2024 of respondent No 1 and Order dated 28 -03-2024 may kindly be set aside and the appellant may kindly be ordered to be posted as sweeper at GHS Wardaga charsadda.

Respectfully Submitted:-

1. That the appellant was initially appointed as sweeper (BPS-1) at GHS Wardaga in the year 2013 and since appointment the appellant performed his duties with honesty and full devotion and to the entire satisfaction of his high ups. (Copy of Appointment Order is enclosed as Annexure A).
2. That astonishingly the appellant was transferred from GHS wardaga to GHSS Dosehra Charsadda against the vacant post of sweeper on administrative ground vide order dated 20-11-2023, which was later on withdrawn by the competent authority vide order dated 23-11-2023.. (Copy of Office Order dated 20-11-2023 & Order dated 23-11-2023 are enclosed as Annexure B & C).
3. That strangely the appellant again transferred on Administrative ground at GHS Shakar Dhand Charsadda against the vacant post of chowkidar vide order dated 28-03-2024. (Copy of Order dated 28.03.2024 is enclosed as Annexure D).

4. That the appellant filed departmental appeal on 03-04-2024 before respondent No 1, which was rejected vide order dated 26-04-2024 copy of which obtained through his own effort on 14-05-2024. **(Copy of departmental Appeal & order dated 26-04-2024 are enclosed as Annexure E & F).**
5. That the impugned Order dated 28-03-2024 and Order dated 26.04.2024 are against the law, facts and principles of justice on grounds inter-alia as follows:-

GROUND:-


- A. That the impugned orders are illegal, unlawful, without lawful authority and void ab initio.
- B. That the appellant has not been treated according to law and rules on the subject which being his fundamental right as per Article 4, 10 and 25 of the Constitution and law of the land.
- C. That the impugned office order is pre-mature as the appellant was transferred to GHSS Dosehra, Charsadda on 20-11-2023 and his transferred order which was withdrawn and again transferred to GHSS Shakar Dhand Charsadda and on this score alone the impugned Office Orders are liable to be set at naught.
- D. That the impugned office order is in violation of transfer posting policy of the provincial Govt. as the same is neither in public interest nor in exigency of service, hence too liable to be set at naught.
- E. That the impugned order is not Speaking order as per section 24 A of the General Clauses Act and as too not tenable in the eyes of law.
- F. That according to posting transfer policy of provincial Govt. there is no concept of transfer on Administrative ground.
- G. That Govt. of Khyber pakhtunkhwa elementary & secondary education department impose complete ban on all kind of posting/transfer vide notification dated 22-03-2024. **(Copy of Notification dated 22-03-2024 is enclosed as annexure G).**
- H. That the appellant was appointed as sweeper and could not be transferred against the wrong post as chowkidar according to notification dated 18-11-1998 **(Copy of Notification is enclosed as Annexure H).**

- I. That appellant being appointed as class (IV) on local basis so can't be transferred to far flung area, being low paid employee.
- J. That the appellant is victimized for no omission or commission on his part.
- K. That the appellant seeks the permission of this honorable Tribunal for further/ additional grounds at the time of arguments.

It is therefore most humbly prayed that appeal of the appellant may kindly be accepted as prayed for.

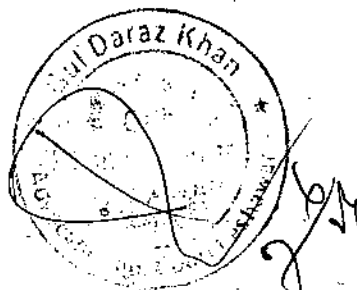
Any other relief not specifically asked for and deemed appropriate in the circumstances of the case may also be granted in favor of the appellant.

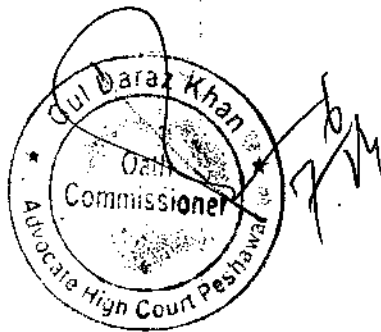

Sir,

I am directed to refer to the subject noted above and to state that the President, NWFP Civil Secretariat, All Class-IV Employees Association and President NWFP Board of Revenue Association have submitted a joint charter of demands for consideration of the Provincial Government. The demands were examined by the Provincial Government in detail and the following decisions have been made as noted against each:-

S.No.	Demand	Decision
1.	Lifting of bar on appointment cases with regard to retired employees quota.	In a meeting of representatives of the employees association, with the Chief Minister NWFP on 6.8.1998, it was decided that the reservation of quota for employees of their sons will be adhered to even after the adjustment/absorption of the surplus Govt: servants. However, individual cases of hardships in respect of deserving Class-IV employees could be considered even earlier on merit. Necessary instructions in this respect have already been issued. All concerned are requested to implement the above-mentioned decision in letter and spirit.
2.	Free allotment of cycles lying in the premises of DC Office, Peshawar.	This demand was also considered in the above-mentioned meeting with Chief Minister NWFP and it was decided that the bicycles lying with the DC Peshawar will be sold out to the Class-IV, Govt: employees on a price. A survey has already been submitted to Chief Minister NWFP for approval. After receipt of approval, the ways and means for further distribution on a price basis will be circulated to all concerned, for further implementation.
	Grant of Liveries to Qasids, Gate Messengers and Bearers during summer season.	The Finance Deptt has just released funds for the summer liveries and the action for the supply of summer liveries is in progress in the S&GAD. While the fund for the Winter liveries is yet to be released by the Finance Department. The case is being pursued vigorously by the S&GAD with Finance Deptt.
	Also, Class-IV employees should be converted to Qasids on the basis of Qasids.	This demand has been accepted and it has been decided that in future all the vacant posts of Naib Qasids will be filled in by transfer from among all Class-IV employees of the respective Deptts (except Sweepers, who have to perform specific duties), subject to seniority-cum-fitness. All concerned are requested to strictly implement this decision.

Quota may be reserved for Class-IV for allotment of quarters.

All abolished posts in the Civil Sectt: as well as Revenue Sectt: may be restored and employees may be promoted against these posts.

In the P&D Deptt: two Projects have been transferred to Non-Development Head. The Employees working there may also be appointed on permanent basis.

Vasids may not be granted the duties of Dgt. Banner.

The excess committed with Class-IV employees with regard to increments may be redressed.

Gratual charges may be paid to all employees who have submitted their applications to Benevolent Fund Cell have not yet released their cheques.

The names of DR's employees may be included in the list of Sectt: employees.

Decision taken during meeting with Chief Secretary with regard to Board of Revenue may be implemented.

It is being explained in the Estate Office S&GAD.

The Finance Department is requested to take further action in the matter under intimation to this Department.

The P&D Department is requested to take further necessary action in the matter under intimation to this Department.

Normally the Vasids are posted with the Provincial Ministers and senior Officers, but in very few cases, the Vasids have been asked to work in the sections, wherein saltatorious duties are to be performed. But this is an administrative matter and no body can be exempted from official duties, what so ever.

The Finance Deptt: is requested to take necessary action, in the matter.

Supt: Benevolent Fund S&GAD is directed to expedite all the cases.

Regretted. The Board of Revenue is an attached Department of Local Department.

The decision of the meeting held on 22.5.4 with the Chief Minister, NPP has already been communicated to the Board of Revenue, NPP for further necessary action.

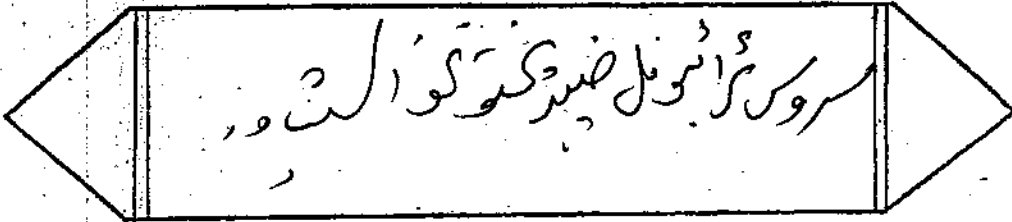
