

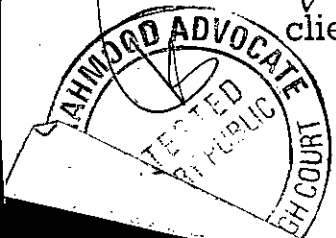

Prayer in appeal:

On acceptance of the instant Service Appeal, the respondents may kindly be directed to include the appellant in the Joint Sonority List of Technicians, Senior Technicians and Chief Technician with reference to the date of acquiring degree/ qualifications for promotion to the post of Clinical Technologist (Pharmacy) BPS-17 and appellant may also be promoted to the post of Clinical Technologist BPS-17 with reference to the date of acquiring of the relevant qualification with all back benefits including seniority. Any other remedy with this Hon'ble Tribunal deems fit that may also be awarded in favour of appellant.

Respectfully Sheweth:

That appellant humbly submits as under:

1. That the appellant is peaceful and law abiding citizen of Pakistan and is entitled for all the rights

guaranteed by the Constitution of Islamic Republic of Pakistan, 1973. (Copy of CNIC is attached as annexure "A").

2. That appellant was appointed on 29/04/2019 as Junior Clinical Technician Pharmacy BPS-12 in the Health Department of Khyber Pakhtunkhwa, since his appointment the appellant perform his duty with great zeal and zest and no complaint whatsoever has been make against the appellant to his high-up's.
3. That the appellant is serving as Junior Clinical Technician Pharmacy since his initial recruitment and is eligible and entitled for promotion to the post of Clinical Technologist Pharmacy BPS-17, as being senior in their group of Pharmacy Technician BPS-12.
4. That according to the Certificate of University of Peshawar the Technology Pharm-D as equivalent to 16 years education and according to the letter dated 18/07/2013 of the Higher Education Commission Pharm-D as equivalent to the corresponding Master

Degree in General Stream involving 16 years of schooling. (Copies of Certificate and letter are attached as annexure "B").

5. That respondent No. 2 was pleased to issued Joint Seniority List of different position including the post of Junior Clinical Technician Pharmacy, for promotion to the posts of Clinical Technologist Pharmacy BPS-17, but astonishingly the name of the appellant was not included in the joint seniority list prepared for promotion to the post of Clinical Technologist Pharmacy BPS-17. (Copy of joint seniority list is attached as annexure "C").
6. That appellant aggrieved from the impugned joint seniority list dated 18/07/2023 preferred a departmental appeal before respondents vide D.D. No. 25063 dated 27/07/2023, on the departmental appeal of the respondents issued correspondence letter for clarification of the appellant diploma in Health Technology the appellant Diploma was duly attested and verified which is clearly mentioned in the correspondence letters made between the respondents No. 2 and 3 despite that no order was passed on the departmental appeal of the appellant.

7. That appellant further feeling aggrieved from the act and action of the respondents, having no other remedy filing the instant Service Appeal on the following grounds:

GROUND:

- A. That inaction of the respondents by not including the name of the appellant in the Joint Seniority List of Technicians, Senior Technicians and Clinical Technologist Pharmacy BPS-17 with reference to the date of acquiring qualification and not to promoting the appellant to the subject post are against the law, facts, norms of justice and material available on record.
- B. That the impugned joint seniority list dated 18/07/2023 of the respondent is illegal, unlawful and against the actual position of the case, hence need modification to the extent including name of the appellant.
- C. That the fundamental rights of the appellant has blatantly violated by the respondents and the

appellant has been discriminated and has been denied his due rights which is protected under the Constitution of Islamic Republic of Pakistan, 1973.

- D. That the appellant is not treated in accordance with law, rules and regulations.
- E. That the act of the respondents of not followed the same criteria whereby the other colleagues of the appellant having Pharm-D Degree enlisted and the joint seniority list prepared by the respondents, while in the instant case the respondents have not yet been considered the name of appellant for promotion, which is illegal, unlawful, discriminatory one.
- F. That the appeal of the appellant in well within time and this Hon'ble Tribunal has the jurisdiction to entertain the instant Service Appeal.
- G. That the respondents acted in arbitrary and malafide manners by not including the name of appellant in the joint seniority list or not to promoting to the post of Clinical Technologist Pharmacy BPS-17 with all back benefits including seniority and thus violating Section 8 and 9 of the

Khyber Pakhtunkhwa Service Act, 1973 Read With Rule 7 and 17 of the Khyber Pakhtunkhwa Appointment Promotion and Transfer Rules 1989 as violating the terms and conditions mentioned above.

H. That it is pertinent to mention here that the respondents circulated joint seniority list of Technologist BPS-17 (Paramedics) wherein the post of Clinical Technologist Pharmacy BPS-17 as reflecting of the initial appointees having qualification of Pharm-D.

I. That by not allowing antedated promotion to the appellant from the date when he was supposed to be promoted is also violative of Section 9 of the Khyber Pakhtunkhwa Service Act, 1973 Read With Rule 7 of the Khyber Pakhtunkhwa Appointment Promotion and Transfer Rules 1989.

J. That any other ground can also, be taken with permission of this Hon'ble Tribunal during the arguments.


