### **RESPECTFULLY SHEWETH:**

### **PRELIMINARY OBJECTIONS:**

1. That the instant Service Appeal is not maintainable in the eyes of law.

2. That the Appellant has got no Cause of Action.

- 3. That the Appellant has concealed material facts from this Honourable Tribunal.
- 4. That the Appellant has challenged the Seniority list with no realistic/cogent grounds.
- 5. That the Appellant is estopped by his own conduct to bring the present Appeal before this honourable Tribunal.

#### **REPLY ON FACTS:**

- 1. Pertains to record. However it is clarified that Appellant qualified Secondary School Certificate examination in year 2022.
- 2. Incorrect hence denied. Name of Appellant was inadvertently mentioned at Serial No. 02 of tentative Seniority list (not final Seniority list) of class-IV, which was circulated to all the district formations of province, for objections/corrections, if any.
- Needs clarification. After circulation of the tentative seniority list, some objections were received to the Directorate of Prosecution from field formations, against the seniority position awarded to Appellant, on the ground that Appellant acquired the minimum qualification of Secondary School Certificate later than them i.e. in the year 2022. It is pertinent to mention here that as per Service Rules of Directorate of Prosecution, as amended in the year 2018 (Annex-A), a common seniority list of Naib Qasid, Chowkidar etc. is maintained with reference to the date of acquiring Secondary School Certificate. A Departmental Committee was constituted to discuss the objections/representations on tentative seniority list of Class-IV (Naib Qasid), which held that objections of officials against the Appellant are genuine and hence they were placed at their due positions in Final Seniority list as per rules. (Minutes of the Departmental Committee is Annex-B). The Appellant was correctly placed at serial No.86.
- 4. Incorrect hence denied. The Appellant has no case to plead and has been dealt as per rules.
- 5. Incorrect hence denied. Detailed reply already provided at para 3 above.
