accumulative effect rather than segregate in clubbed cases, and the
amount of cost/line shall not be acceded from the amount of Rs 25000/-
while the impugned order dated 22/2/2024, exceed the limits and thus
may kindly be /omit rather then huge cost/line.


f. That respondents due to financial hardship, and low budget are not in
financial position to pay the huge fine/cost, respondents may humbly
requested to remit the huge fine/cost, so that reply/comments of
respondents may kindly be submitted.

c. That there are sufficient cause available regarding non-submission of
reply/comments of respondents part, there are valuable rights rest in the

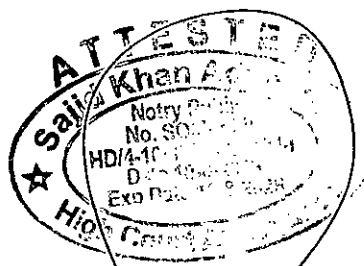




