**JOINT PARA-WISE COMMENTS ON BEHALF OF RESPONDANTS NO. 1, 2, 4 & 5.**

**PRELIMINARY OBJECTIONS:**

1. That the appellant has no cause of action / locus standi.
2. That the appellant has not come to this Honorable Tribunal with clean hands.
3. That the present appeal in hand is not maintainable in its present form and also in the present circumstances of the issue.
4. That the present appeal is liable to be dismissed with cost for miss joinder / non joinder of necessary parties.
5. That the appellant has filed the instant appeal on malafide motives.
6. That the instant appeal is against the prevailing laws and rules.
7. That the appellant is estopped by his own conduct to file the present appeal.
8. That the instant appeal is badly time-barred.

**RESPECTFULLY SHEWETH,**

1. Pertains to record. Hence no comment.

3. Incorrect and misconceived. Hence Denied.


4. It is clarified that Public Health Engineering Department arranged Departmental Promotion Committee meeting on 26.05.2021 after fulfilling all codal formalities and those who were in promotion zone were promoted on regular basis including the appellant on probation for a period of one year in term of Rule-15 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion & Transfer) Rules, 1989, and the competent authority issued promotion orders accordingly **(Copy is attached at Annex-A).**
5. Incorrect and misconceived. It is clarified that Khyber Pakhtunkhwa Public Service Commission recommended candidates who were not included in the seniority at that time due to non availability of inter se-merit from KPPSC. After receiving the same from KPPSC, the respondent department incorporated all newly recommendees comprising Assistant Engineers/SDOs (BS-17) in the seniority list, wherein, the appellant was ~~senior~~ junior to all the private respondents in light of Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules, 1989 **(Copy is attached at Annex-B).**  
It is also worth to mention here that the Khyber Pakhtunkhwa Public Service Commission recommendation ~~is~~ received earlier then the promotion /DPC of the appellant **(Copy of KPPSC recommendation is attached at Annex-C).**
6. Incorrect and misconceived. It is clarified that the appellant was initially appointed in the respondent department as Sub Engineer (BPS-11/12). As already discussed that seniority list of promoted Sub Engineers was combined with those of KPPSC recommendees in BPS-17. As per policy seniority has been determined in light of Khyber Pakhtunkhwa (Appointment, Promotion & Transfer) Rules, 1989, wherein, appellant stands junior to all the private respondents and placed at S.No. 13 **vide Notification No SO(Estt)/PHE/13-77/2021 dated 24.07.2023 and the same is also annexed by the appellant as Annex-G.** Keeping in view recommendation of KPPSC is earlier then the promotion/DPC of the appellant. It is also added that all the recommendees assumed their charged in compliance with the offer of the appointment of the competent authority. Now the burden lies upon the appellant to prove before this Honorable Tribunal that where the respondent department violated the rules and policy.
7. Incorrect and misconceived. The appellant is not an aggrieved person. He has been treated as per rules and policy. Hence his claim is denied.

#### **GROUNDS:**


- A. Incorrect and misconceived. The appellant misleads this Honorable Tribunal. He was appointed as Sub Engineer (BPS-11/12) in the respondent department and seniority in the higher pay scale will be determined with effect from the date of his regular promotion in (BPS-17). It is also added that the recommendees of KPPSC are senior to the appellant, keeping in view their early recommendation as well as charge assumptions.

The stance of the appellant is not justified on the ground that the posts are of different cadres, as the appellant was initially appointed as Sub Engineer (BPS-11/12) and he jumped to the seniority of all the private respondents who were appointed directly in BPS-17. The present appeal is devoid of merit and not maintainable in the eyes of law.
- G. The respondent department seeks permission from this honorable Tribunal to raise additional grounds at the time of arguments, please.

**PRAYERS:**


