




Service Record, Character Roll and ACRs for the last Five years in respect of the above mentioned ASI were requisitioned alongwith the views/comments of the Director FSL, KP Peshawar regarding overall performance of the individual concerned which were perused during the meeting.

Last Five Years ACRs in respect of ASI Taza Gul were found complete in all respect. Service synopsis of the above named officers reflects the applicant/officer to be competent and hardworking in his relevant field of job. The Director FSL KP Peshawar also expressed satisfaction upon the performance of ASI Taza Gul. It was observed by the Committee that confirmation of ASI Taza Gul in his existing rank was due with effect from 13.01.2013 but it was differed due to adverse remarks conveyed to the applicant/officer in his ACR for the year 2012 by the then Director FSL. Hence the applicant/officer filed appeals at different forums finally before the Honourable Service Tribunal KP Peshawar to expunge the said adverse remarks. The Apex Tribunal in its decision dated 27.10.2017 ordered to expunge the adverse remarks. Hence the applicant/officer requested for confirmation in his existing rank from the due date i.e. 13.01.2013.




