PRELIMINARY OBJECTIONS:

- 1. That the Appellant has got no cause of actions/locus standi.
- 2. That the instant appeal is filed by suppressing the material facts from this honorable Tribunal, hence not maintainable.
- 3. That the appellant was recommended for promotion and consequent upon the recommendation of departmental promotion committee was promoted to the post of SST Math/Physics (BPS-16) vide notification dated 08-12-2023 as per eligibility criteria and availability of vacant post of SST Math/Physics in 40% promotion quota.
- 4. That the instant appeal is against the prevailing law & rules.
- 5. That the instant appeal has been filed just to pressurize the respondents.
- 6. That this honorable tribunal lacks jurisdiction in the instant matter in issue.



- 7. That the instant appeal is hopelessly time barred.
- 8. That the appeal is bad for mis-joinder and non-joinder of the necessary and proper parties.
- 9. That the appellant is estopped to sue through his own conduct.

REPLY ON FACTS

- 1. That Para No-1 of service appeal is pertaining to service career of the appellant hence no comments.
- 2. That Para No-02 as composed is incorrect, the appellant has annexed the notification/rules dated 24-08-2014 issued by the department wherein it has clearly been mentioned that in case of non-availability of suitable candidate for promotion then the post will be filled by initial recruitment. (copy of notification/rules dated 24-07-2014 is appended as annexure-A).
- 3. In reply to Para No.3 it is submitted that in the year 2020 no suitable candidate having 05 years length of service was available for promotion in district Torghar, Hence the said quota was granted to initial recruitment. Similarly, in the year 2021 two appointments of SST M/P were made on the basis of advertisement dated 30-11-2020 and at that time no suitable candidate including appellant was eligible for promotion. The appellant was appointed as certified teacher on 09-04-2016 and having less than 05 years' service. The required length of service in respect of appellant was completed on 16-04-2021. Furthermore, part second relating to the appointment of Mr. Inayat Khan is irrelevant and unnecessary to the case. (Copy of advertisement is appended as annexure-B)
- 4. In reply to para No.4 it is stated that the Departmental Promotion Committee for promotion to the post SST Math/Physics was scheduled to be held on 12-08-2021 at Directorate of E&SE Peshawar wherein instructions were





issued to eligible candidates, including appellant for submission of files. The eligible candidate for SST Math/Physics submitted their files before respondent No.02 on 12-08-2021 and 02 candidates were found eligible, but there was only 01 post available for promotion to the post of SST Math/Physics at GHSS Manjakot. The eligible candidates were as below:

- i) Abdul Jalil CT GMS Seri Kohani (against 40% promotion quota for CT).
- ii) Muhammad Aqeel SPST GPS Boray Hassan Zai (against 20% promotion quota for PST).

As there was only one post of SST Math/Physics available, therefore no promotion could be made under the following criteria:

- a) For CT @ 40% the share of CT = 1 post x 40 /100 = 0.4
- b) For PST @ 20% the share of PST = 1 Post x 20 / 100 = 0.2 (copies of working papers are annexure C & D)
- 5. In reply to para No-05 it is submitted that the appellant submitted appeals to the Department the replies whereof were communicated on 22-07-2022 and 02-02-2023 respectively. It was clarified that only 01 post of SST was available which could not be divided amongst 02 candidates. The availability of 01 post of SST Math/Physics is also admitted by the appellant. (copies of reply of departmental appeals are annexure E & F).
- 6. In reply to para No. 06, it is submitted that at the time of DPC in the year 2021 only 01 post of SST Math/Physics was available which could not be divided amongst 02 candidates under 40% and 20% promotion quota. Furthermore, availability of 01 post is also admitted by the appellant.

- 7. That the matter in issue has already been decided by Honorable Peshawar High Court Abbottabad Bench on 21-09-2023 with the direction to respondent to consider the case of the appellant in the coming Departmental Promotion Committee (DPC) Which was held on 10-10-2023 for the post of SST BPS-16 and he was promoted to the post of SST Math/Physics. (Copy of judgment dated 21-09-2023 is attached as annexure-G)
- 8. Incorrect, Complete and comprehensive reply has already been given in preceding paras along with entire relevant record.
- 9. That in the year 2021 only 01 post of SST Math/Physics was available which could not be divided amongst 02 candidates under 40% and 20% promotion quota.
- 10. The appellant has no cause of action/locus standi.

REPLY ON GROUNDS: -

- A) That para No-01 of the ground as composed is Incorrect, there was only 01 post of SST Math/Physics available at GHSS Manjakot at the time of DPC in the year 2021 which could not be divided amongst 02 candidates under rules and policy of the department.
- B) That para No. B is Incorrect, as only one post of SST Math Physics was available throughout the district on 22-04-2021 which could not be divided amongst 02 candidates. Therefore, the case of appellant has been considered in the very next DPC after 2021 after the availability of second post of SST Math/Physics.
- C) In reply to para No. C it is submitted that only 01 available post could not be divided as per 40% share of certified teacher and 20% share of PST in the year 2021. Hence, the instant appeal is not maintainable.

- D) In reply to para No. D it is submitted that only 01 available post of SST Math/Physics in the year 2021 could not be given to CT having 40% share in promotion and no second post was available in district Torghar in the year 2021.
- E) Incorrect, against the record, without any proof, hence. denied.
- F) Incorrect hence denied. Detail reply already given in supra para No. 04.
- G) In reply to para No. G it is submitted that second post of SST Math/Physics was not available in district Torghar in the year 2021.
- H) That the other points shall be argued at the time of arguments with the permission of honorable court.

In the light of above stated facts & circumstances, it is most humbly prayed that the instant appeal may kindly be dismissed with cost.


