BUNER WHEREBY THE APPELLANT HAD BEEN TRANSFERRED  
FROM GGPS AJILIA TO GGPS GUMBAT, BUT THE SAID  
TRASNFER ORDER WAS CANCELLED AFTER 15 DAYS IN UTTER  
VIOLATION OF LAW AND POLICY OF TRANSFER AND POSTING  
GOVERNING THE SUBJECT.**

**RESPECTFULLY SHEWETH,**

- A.** That the Appellant is a naturally born bona-fide citizen of Islamic Republic of Pakistan and hails from a respectable family of District Buner.
- B.** That after going through mandatorily required criteria and have been envisaged with ordeal and inquisition of selection process, the Appellant got inducted onto the rolls of this prestigious department on 19-08-2020.
- C.** That since induction into service, the appellant always remained dutiful and pragmatic fellow, who never left any stone unturned in performance of his duties and have won felicitation and appreciation of high ups at certain juncture.
- D.** That before going into the root of the instant case is pertinent to mention here that the Appellant had with the much hardship and havoc on her health had completed the serving tenure of 03 years and 07 months at GGPS Ajilia.
- E.** That the Appellant kept forwarding a gazillions of application to the Respondent DEO so the Appellant be transferred as she had completed her serving tenure with a toll on her daily livings as the commute to the Appellant's GGPS had almost of 40kilometers from where she was residing but the Appellant kept the burning hope and steered her ways so she can serve the Respondent Department with her utmost dedication.
- F.** That after all the struggles on the part of Appellant and the hardships she had to face while serving, finally a Transfer Notification of the Appellant was issued vide the Office Order No. 4887-92/ Dated: 06-03-2024 against the vacant position available in the said GGPS, which came as the beacon light to the lengthy struggle of almost four years in service.

**G.** That the even the dust of the Appellant's transfer was not settled in the said GGPS Gumbat, that the Appellant was hit by a shock and when out of the blue the Appellant received another Impugned Notification No. 5072-75/ Dated: 20-03-2024 right after 15 days of the issuance of the Appellant's Transfer Order vide Order No. 4887-92/ Dated: 06-03-2024 against the vacant position available in the said GGPS& in the light of the latter one, the previous Transfer Order was cancelled.

**H.** That through the cancellation of the Transfer Order in the light of the Impugned Notification Dated: 20-03-2024, the Appellant's substitute PST is the one who is benefiting the most, as it was the political influence and peer pressure on the Respondent DEO which resulted into issuance of the Impugned Order against the Appellant and the Appellant long-pending transfer has been cancelled.

**I.** That feeling aggrieved the Appellant moved a Departmental Appeal to the Office of Secretary Elementary & Secondary Education Khyber Pakhtunkhwa, Peshawar, but the same has been left undecided despite the lapse of the statutory time period.

**J.** That from the above episode, the grievances that come into existence, having no other adequate remedy available, and forum to be addressed at, the Appellant approached this Hon'ble Tribunal for setting aside the Impugned Notification Dated: 20-03-2024 , on the following grounds inter-alia:-

**GROUNDS:**

1. That the Impugned Notification is wrong, illegal, unlawful and liable to be struck down and set aside.
2. That it is a cherished principle of law that where a law require a thing to be done in particular manner then it has to be done in that manner and not otherwise.
3. That the Impugned Notification is thoroughly in derogation to the principle as laid down and enumerated in transfer & posting policy.
4. That even it is a dictum laid down by the Apex Courts of the Land that wedlock policy can always be given weight and considered in the public which in the case of the Appellant was violated and turned down due to the political influence of one black mole in the Respondent Department.
5. That even the husband of the petitioner is working as PST at Gps Ramzay Gulbandi, buner, so as per the spouse policy, the impugned cancellation transfer and posting order is totally illegal and unlawful and is not justified in any canon of law.
6. That even the spouse policy fully covers the case of appellant as the husband of appellant is serving as PST at same union council school, even on this score alone, the impugned order are illegal and unlawful, hence liable to be set aside.
7. That beside the above the appellant has been shown to be transferred from GGPS Ajlai to GGPS Gumbat whereas the appellant is serving as PST in Gumbat, Buner, where against the appellant has recently has been transferred and issue impugned cancellation order, so this show not only the hollowness of impugned order but as well as the ulterior motive of mala-fide nursed under the impugned order which render the same impugned order is nullity in the eyes of law.
8. That it goes without saying that in the case of the Appellant, the Appellant has been thrown under the bus because of the considerable influence and clout of

the private Respondent who enjoy the patronage of the local politicians which is why the cancellation order of the Appellant's transfer cannot justified in the name of the best interest of the public.

9. That from every angle, the Impugned Notification is the result of colorful exercise o discretionary powers vested in the Respondent, which is totally illogical and unlawful, hence the impugned order is liable to be dismissed.

10. That any other ground not raised here may graciously be allowed to be advanced at the time of arguments.

**PRAYER:**

It is, therefore, most humbly prayed that on acceptance of the instant Service Appeal, the Impugned Notification No. 5072-75/ Dated: 20-03-2024, of the Office of the Respondent DEO may kindly be declared as void and illegal and be set aside& by doing so, the Appellant be allowed to serve her remaining tenure in the light of the Transfer Order No. 4887-92/ Dated: 06-03-2024, strictly as per law & relevant policy.

Any other relief not specifically asked for may also graciously be extended in favor of the appellant in the circumstances of the case.
